Minutes of Previous Meeting

Upon a motion by Commissioner Kuriyama, seconded by Commissioner Faulkner, it was voted on and unanimously carried to accept the minutes of the February 6, 2013, Education Review Committee meeting.

2013-2014 Continuing Education Providers and Courses Ratification List

Upon a motion by Commissioner Kuriyama, seconded by Commissioner Sherley, it was voted on and unanimously carried to ratify the attached list.

Course – "Real Estate Closing Issues for an Aging Population – Escrow and Title Issues Associated with the Challenges of Aging"; Author/owner: Patsy K. Saiki; Provider: Hawaii Association of REALTORS®; Course Categories: Real Estate Law, Risk Management; Clock Hours: 3

Upon a motion by Commissioner Sherley, seconded by Commissioner Faulkner, it was voted on and unanimously carried to approve "Real Estate Closing Issues for an Aging Population – Escrow and Title Issues Associated with the Challenges of Aging" subject to including a "glossary" of basic terms in the course materials, as a three credit hour continuing education elective course, under the course categories: Real Estate Law, Risk Management.

Course – "Land Use and Permit Requirements – Residential Mini-Subdivisions"; Author/owner: Philip Hale Wilia; Provider: Dower School of Real Estate; Course Category: Real Estate Development; Clock Hours: 3 (Deferred from 8/7/12 and 2/6/13 ERC meetings)

Commissioner Senter stated that the course is much clearer, but suggested on page 1 to include the following language in the "Note" at the bottom: "If a development does not meet subdivision requirements, then a Condominium Property Regime ("CPR") may be considered. A CPR needs to comply with all applicable City and County requirements and Land Use Ordinances."

Upon a motion by Commissioner Senter, seconded by Commissioner Kuriyama, it was voted on and unanimously carried to approve "Land Use and Permit Requirements – Residential Mini-Subdivisions" as a three hour continuing education elective course, under the course category: Real Estate Development. The approval is subject to inserting language at the bottom of page 1, clarifying that when a CPR is considered, the CPR must comply with all applicable City and County requirements and Land Use Ordinances.

Course – "Unlucky 13 – the Common 1031 Pitfalls"; Author/owner: Investment Property Exchange Services, Inc.; Provider: Investment Property Exchange Services, Inc. and Hawaii Institute of Real Estate; Course Categories: Investment and Real Estate Law; Clock Hours: 3

Upon a motion by Commissioner Sherley, seconded by Commissioner Gendrano, it was voted on and unanimously carried to approve "Unlucky 13 - the Common 1031 Pitfalls" subject to including an introduction section on basic 1031 exchanges which will provide a segue to the "Unlucky 13,,," examples, as a three hour elective course, under the course categories: Investment, and Real Estate Law.

Continuing Education Core Course

The Committee discussed increasing the continuing education mandatory core course to eight (8) hours, instead of the current 5 hours. After discussion, upon a motion by Commissioner Faulkner, seconded by Commissioner Cobb, it was voted on and unanimously carried to increase the continuing education core course hours to eight (8), to be effective beginning with the 2015-2016 biennium.

Program of Work: <u>Annual Report, Quarterly Bulletin and School Files</u>

Senior Real Estate Specialist Fujimura reported that the February 2013 issue of the Real Estate Bulletin was distributed and a copy made available on the Commission's website: www.hawaii.gov/hirec.

Real Estate Seminars & Instructor's Development Workshop

Senior Real Estate Specialist Fujimura stated that the Commission procures for a provider to assist the Commission in sponsoring one Instructor's Development Workshop ("IDW") and one Real Estate Seminar each biennium.

Senior Real Estate Specialist Fujimura asked the Commission if they want to continue to sponsor both a Real Estate Seminar and an IDW each biennium or only sponsor one of the events. There appears to be few IDWs generally available for Hawaii instructors, so continuing to sponsor an IDW each biennium is a good idea. For the Real Estate Seminar, it was suggested to consider sponsoring a seminar open to potential real estate buyers, providing tips, red flags, and other important information to be aware of as a real estate buyer. Another suggestion made was to consider a real estate seminar on distressed properties, short sales, etc.

After discussion, upon a motion by Commissioner Faulkner, seconded by Commissioner Gendrano, it was voted on and unanimously carried to procure both a real estate seminar and an IDW for the current biennium.

Ad Hoc Committee on Education ("ACE")

Senior Real Estate Specialist Fujimura stated that the next ACE meeting will be on March 14, 2013 in the King Kalakaua Building, third floor, Examination Room. The ACE is hosting a "focus group" of young licensees, to open discussion on how these newer, younger licensees view the real estate industry, how they do business, and how this may impact future prelicense education and continuing education.
