SEO Kimura stated that this list has been developed before and it was started back when Patricia Choi was the Education Review Committee Chair. He stated

that individuals have already been asked to participate and are willing to participate but are not on the recommended list.

Chair Yamanaka stated that those individuals are former Commissioner and Chair of the Education Review Committee, Helen Lindemann and Jackie Parkinson of the Kona Board of REALTORS[®]. As for Jackie Parkinson and Robert Cheesbrough we are concerned about the cost of travel. SEO Kimura replied that one could be an alternate attendee or there could be an understanding that the second participant will pay their own expenses to and from meetings.

Vice Chair Nishihara explained why the task force member list is so extensive. She stated that one of the purposes of the task force is to look at all education courses and potential courses and it would be beneficial to have different people from different islands, Boards, the real estate community, and instructors. There is diverse talent in the community and they will be able to come up with constructive programs.

Prelicense Education: Applications

<u>Substitute Instructor – Henry Jay Hannigan, Salesperson and Broker</u> <u>Curriculums, Dower School of Real Estate</u>

Upon a motion by Commissioner Abrams, seconded by Commissioner Rice, it was voted on and unanimously carried to recommend approval of Henry Jay Hannigan as a substitute prelicense instructor for the salesperson and broker curriculums.

<u>Prelicense School – Seiler School of Real Estate, Ricardo D. Seiler, Principal,</u> <u>Broker Curriculum – Independent Study Course</u>

Upon a motion by Commissioner Abrams, seconded by Commissioner Kagawa, it was voted on and unanimously carried to recommend approval of Seiler School of Real Estate to offer the broker curriculum – independent study course.

Paige Vitousek Recommendation

A copy of Ms. Paige Vitousek's letter received on August 4, 2003, was distributed to the Commissioners. Ms. Vitousek was available for comment.

Ms. Vitousek stated that there is an incredible wealth of knowledgeable instructors on the mainland. She stated that she has an instructor that is planning to move to Hawaii that she would like to hire—he has been a broker for 27 years, a prelicense instructor for 14 years—however, he does not meet the three year Hawaii licensee requirement. She noted that a licensee can now become a broker without being a Hawaii salesperson, but instructors must still meet the three year requirement.

SEO Kimura stated that Ms. Vitousek is referring to Section 16-99-58(d)(1), Hawaii Administrative Rules, which states that each instructor shall initially take and pass an examination as prescribed by the commission and shall hold a current Hawaii real estate broker's license, have at least three years full-time experience in real estate in Hawaii, and fulfill the present experience requirement for a Hawaii broker's license. SEO Kimura inquired if Ms. Vitousek is requesting that the three years full-time real estate experience in Hawaii be deleted.

Ms. Vitousek responded that there is the broker to broker rule whereby a broker from another State is allowed to become a Hawaii broker if he/she meets the requirements.

SEO Kimura inquired if she would agree to allow an instructor to become certified in Hawaii if he/she was certified by a national organization. Ms. Vitousek replied that she does not think all instructors are part of those organizations.

SEO Kimura stated that this type of rule amendment would need to be taken up by the Laws and Rules Review Committee and noted that rule amendments usually take up to two years. He added that a laundry list of items has been started for changes and her request will certainly be added to the list.

	SEO Kimura noted that the Commission does not have the discretion to waive
	the rule; however, there are other avenues for Ms. Vitousek to pursue, for example, she may want to have the interested individual apply as a substitute instructor; whereby they are not allowed to teach more than 50% of classroom time.
	Chair Yamanaka stated that the Committee will have the Education Evaluation Task Force review Ms. Vitousek's issue and the task force can come up with recommendations—this will ensure that her request is considered.
	SEO Kimura stated that rulemaking is an administrative process involving a multitude of approving entities the process takes a long time.
	SEO Kimura stated that another avenue Ms. Vitousek may want to pursue is having the individual teach as a guest lecturer. A guest lecturer would come in to teach a specific topic but is also limited to teach less than 50% of the scheduled classes.
	Vice Chair Nishihara stated that Ms. Vitousek's comments and concerns are very valued and timely and thanked her for attending the meeting.
	Upon a motion by Commissioner Nishihara, seconded by Commissioner Rice, it was voted on and unanimously carried to recommend referral of Ms. Vitousek's recommendation to the Education Evaluation Task Force for further review and recommendations.

Interactive Participation with Organizations - NAR Meeting 11/5 - 10/2003

A copy of the program for the upcoming National Association of REALTORS[®] 2003 Conference and Expo was distributed to the Commissioners for their information.

SEO Kimura reported that in the past we have been unsuccessful in getting approval to get Commissioners to attend these conferences; however, this year's conference has a lot more programs that is directly related to the Commission's responsibilities and its program of work.

Upon a motion by Commissioner Ohama, seconded by Commissioner Imanaka, it was voted on and unanimously carried to recommend approval for one participant to attend the National Association of REALTORS[®] 2003 Conference and Expo to be held on November 5 – 10, 2003 in San Francisco, California, subject to REEF budget and DCCA approval. The Chair of the Real Estate Commission and the Supervising Executive Officer to determine the attendee.

Real Estate Seminars

Senior Specialist Fujimura reported that she has begun discussion with Ms. Marsha Shimizu, Hawaii Association of REALTORS[®], about co-sponsoring a real estate seminar this fiscal year as we did not have a seminar in fiscal year 2003.

Senior Specialist Fujimura stated that they have discussed the topic of responsibilities of principal brokers and brokers in charge. She reported that staff has been trying to inform PBs and BICs of their responsibilities under Section 467-1.6, Hawaii Revised Statutes, and the need for them to come up with a policies and procedures manual and their need to oversee their agents' continuing education as well as informing them of law and rules updates.

Senior Specialist Fujimura reported that they have a potential mainland consultant and are targeting early 2004 for the seminar.

Senior Specialist Fujimura stated that they are seeking recommendations for seminar topics—the PB/BIC topic will narrow the audience down. SEO Kimura stated that the seminar could cover a combination of topics.

Vice Chair Nishihara stated that this would be a good topic for the Education Evaluation Task Force to review and also determine other pertinent topics. Ms. Shimizu stated that the PB/BIC topic is a very important issue. SEO Kimura stated that budget is also an issue in trying to put on this seminar as we are looking for ways to contain costs and get more for the buck. Travel is the most scrutinized cost item. Commissioner Rice stated that we should make the request for the budget increase and if it is denied we will have this information on record and we can go to the next Legislature with this information. Upon a motion by Commissioner Nishihara, seconded by Commissioner Rice, it was voted on and unanimously carried to recommend that the Education Evaluation Task Force (EETF) decide on a topic for a real estate seminar to be held early 2004, that EETF discuss possible seminar topic of Principal Brokers/Brokers in Charge Responsibilities, and that the seminar be a priority for decision making by the EETF at its initial meeting in September 2003. REEA – 24th Annual Conference report **ARELLO. REEA &** Other Organizations A copy of the report by SEO Kimura and Senior Specialist Fujimura on the Real Estate Educators Association 24th Annual Conference held on June 22 – 25. 2003 in Philadelphia was distributed to the Commissioners for their information. SEO Kimura went over key issues of the report and added that they had a meeting with Promissor staff at the Promissor Headquarters. They saw the latest on examination development. They also saw how the PC based exam works and how they implement graphics, video and multi-media into the exam. SEO Kimura stated that he was very impressed and see a lot possibilities ARELLO – California CE Exam and Exam Fees A copy of articles regarding California now requiring a final exam for continuing education courses and a comparison of exam fees from various ARELLO jurisdictions was distributed to the Commissioners for their information. Tennessee REC – Post Licensing Course A copy of an article from the Spring 2003 Tennessee Real Estate News -Journal regarding a new Tennessee law requiring new affiliates complete a law course within the first six months of licensure was distributed to the Commissioners for their information.
