A report of the Education Evaluation Task Force meeting held on November 30, 2006, was distributed to the Commissioners for their information.

Chair Ball reported that the EETF committee approved a four hour core course to be offered over 2 years of the biennium with 2 hours being presented each year of the biennium. The odd-numbered year's core course, Part A, will include a legislative update and current issues. The even-numbered year's core course, Part B, will include a legislative update and current issues. Each part of the core course shall be available in both an on-line and live classroom format.

Commissioner Nishihara questioned whether two hours is ample time to cover the legislative updates and meet the objective of the course.
