Minutes of Previous Meetings

Upon a motion by Commissioner Kuriyama, seconded by Commissioner Faulkner, it was voted on and unanimously carried to accept the minutes of the February 6, 2013, Laws and Rules Review Committee meeting.

Program of Work: Licensing Renewal

Staff met with various Boards for their feedback regarding last year's renewal. It was a real productive meeting and it was consensus that the biggest problem for the licensees was that they couldn't get through to the licensing branch number (808) 586-3000. SEO Fujitani informed the Commissioners that the licensing branch just recently installed a new telephone system and they cannot handle the volume of calls that are coming in. The Licensing Branch is aware of the problem and is working toward resolving the issue.

Staff learned from information presented at the meeting that during the renewal process, many licensees were confused between renewing their license and renewing their membership with the local industry board. On their membership renewal form, there was a breakdown of payment information which included a payment of "state dues." Many thought that the state dues were their renewal so they didn't renew their license. A suggestion was brought up to change the language from National dues to National Association of Realtors, State dues to Hawaii Association of Realtors, and Local dues to the respective board the licensee belongs to, e.g., Honolulu Board of Realtors. In an effort to distinguish the various documents, another suggestion made was to color code the notices that go out to all licensees.

Legislative and Government Participation Report

SEO Fujitani reported on Senate Bill No. 41, S.D. 1, relating to real estate. In its current form, this bill amends the definition of "local contact" found in Act 326 of the Session Laws of 2012. Generally, the local contact is one who serves as the on-site contact for the operator, residing on the same island where the transient accommodation is located, whose name is required to be prominently posted in the transient accommodation, and included in any transient accommodation contract or written rental agreement. It is still early on how this measure may or may not morph but the companion bill House Bill No. 23 has died.

Legislative Report No. 2 was distributed to the Commissioners for their information.
