COURSE MONITORING AND EVALUATIONS

The Hawaii Real Estate Research and Education Center ("HREREC") is working on an evaluation system for the schools, providers, instructors and continuing education courses. The Commission has moved this program up in priority for the 1998 fiscal year. Also, please note that RICO will investigate any violation of the laws and rules, including the following: §16-99-108, 16-99-109 and 16-99-110, Hawaii Administrative Rules, the Commission may revoke or suspend the certification and registration of a continuing education course, instructor or provider if the course contains outdated or incorrect information, the provider allows its instructors to use outdated course information and material in the teaching of any continuing education course, the instructor no longer demonstrates command knowledge and understanding of the subject matter of the course offering, or the instructor uses outdated information and course materials in the teaching of any continuing education course.

REMINDERS: MATERIAL CHANGES

Any anticipated material change to a Commission certified continuing education course offering, its curriculum, or objectives shall be submitted in writing by the provider or by the instructor to the Commission for approval thirty days prior to making the changes - §16-99-117, Hawaii Administrative Rules. Changes reported in an untimely manner will not be accepted and may not be recognized by the Commission if offered.

PRELICENSE INSTRUCTOR'S REQUIRED TO TAKE EXAM

Every instructor, every three (3) years, as a condition of recertification shall take and pass an instructor's exam, demonstrating the instructor's current command of the prelicense course.

CONTINUING EDUCATION
INSTRUCTORS WHO ARE
LICENSEES

In satisfying the continuing education hours of a license period, an instructor who is a real estate licensee, may use once in any biennium, the clock hours for each course topic taught. The one time use applies even when the instructor has taught the course more than once. Please submit your request in writing directly to the Commission's office at 250 S. King Street, Room 702, Honolulu, Hawaii 96813, Attention: Lorene. All written requests must state the correct and complete name of the continuing education course and when the course was taught by that instructor. Incomplete written requests will delay processing.

INCREASE IN EXAM FEES

ASI exam fees will increase from \$50 to \$65 effective January 1998.

Please read the attached memorandum on "ex parte" communications and remind your students that if they attempt to discuss their pending application with a Commissioner, that Commissioner may be disqualified from discussing, voting or decision making on the matter and the applicant may be doing more harm than good.
