Each of the applicants shall file a pre-hearing statement on the issue of standing. The statement shall be filed with the Commission on Water Resource Management (CWRM) and served on the other applicants and parties not later than the close of business on November 5, 2014. Any applicant or party may file and serve a reply statement which is due no later than the close of business on November 10, 2014.

All documents filed with the Hearings Officer shall include the **original plus five (5) copies** and shall be filed at the CWRM office at 1151 Punchbowl Street, Room 227, Honolulu, Hawaii 96813 or P.O. Box 621, Honolulu, Hawaii 96809. The deadline for filing and serving the required documents may be met by email attachments or facsimile, provided that the sender receives confirmation of receipt by the recipient, and electronic delivered is followed by mail delivery. The mail, email, and facsimile addresses for all parties and applicants (or as much information as is known) are indicated in Attachment 1.

Upon finding that the applicants have standing, the applicants will be given a choice as to whether they would like to participate in the contested case as a party or whether they would instead like to have information that the applicant has relating to a particular stream(s) preserved in the record through the applicant's testimony or evidence the applicant presents as a witness.


