We kindly ask that all oral/video testimony be limited to not more than two (2) minutes. We also ask that you identify yourself and any affiliation before speaking, but you can choose not to do so.

The Committee will meet for the sole purpose of selecting at least three nominees for each anticipated vacant position on the Commission on Water Resource Management, as required by HRS § 174C-7. There are two positions to be filled, for which, to be qualified, the individual selected for consideration must have substantial experience in the area of water resource management.

B. PUBLIC TESTIMONY

Public testimony may be given at the start of the meeting prior to the beginning of the interviews or may be given for any named candidate after the interview has been conducted.

C. INTERVIEW OF APPLICANTS – (Executive or Open Meeting)

For any candidate whose name has not been disclosed and wishes to be interviewed in a closed session, the Committee anticipates going into an executive meeting, pursuant to HRS §§ 92-4 and 92-5(a)(2)¹, for consideration of matters affecting privacy, to consider and evaluate the applications of individuals seeking a nomination to the Commission on Water Resource Management. Those candidates who have disclosed their names will be asked whether they choose to hold their interview in an executive meeting or an open meeting.

These interviews are a continuation of the prior interview process in the Committee meeting that was initiated on June 9, 2025, in which six candidates were interviewed.

Candidates will be interviewed singly either in-person, or by admission into the Zoom meeting room during a convened executive session at intervals of approximately 35 minutes. Recesses may be called by the Committee Chairperson as necessary, so the interview order and estimated times is approximate.

If any previously undisclosed candidates wish to be interviewed by the Committee in open session, the Committee will reconvene an open meeting session if it was previously in an executive meeting.

The Committee may also go into executive session pursuant to HRS § 92-5(a)(4), to consult with its attorney "on questions and issues pertaining to [its] powers, duties, privileges, immunities, and liabilities" as they may relate to the Committee's business.

The interviews are anticipated to recess after the last (fourteenth) candidate on June 27, 2025 and then resume in the same meeting room (CWRM Conference Room) on the continuation date of June 30, 2025.

D. SELECTION OF NOMINEES

1. Executive Session

After the completion of interviews, the Committee will resume in executive meeting to evaluate applicants pursuant to HRS § 92-5(a)(2) and select two lists of at least three nominees to be sent to the Governor for consideration.

In the event that the Committee's business is not completed on the scheduled date, the Committee may announce a continuation date to meet with any remaining candidate whose interview was not finished or discuss the applications of the individual candidates seeking a nomination as a member of the Commission on Water Resource Management, until the selections have been made.

2. Open Meeting

After discussions to evaluate applicants, the Committee will exit executive session to announce in open meeting that it has finalized the two lists of at least three nominees for consideration by the Governor.
