Community centers ensure health care

ore than three years ago, an elderly Micronesian couple first visited Honolulu's Kalihi-Palama Health Center (KPHC). Experiencing homelessness, they were seeking help to manage their challenges with diabetes and high blood pressure.

Teko Gabriel, a KPHC community health worker, became the couple's frontline advocate, providing them with assistance in their native Chuukese language. When the husband was hospitalized this June, Gabriel handled paperwork to ensure the couple had shelter after they were released. Gabriel's work helped the couple at a time when Hawaii, with its high cost of living and nation's highest per capita homeless rate, is struggling to provide care and shelter for many individuals.

Staff like Gabriel within Hawaii's 15 community health centers, and more than 1,400 such centers across the country, fill critical roles in their patients' lives. For decades, both Republican and Democratic lawmakers have supported

medically underserved populations healthy, including low-income, minority and limited-English proficient communities.

Health center providers remain many patients' preferred choice, even when some have access to other providers through other health plans. Often, these patients' health coverage does not grant them much access to care. This gap between coverage and care disproportionately affects Asian-American, Native Hawaiian and Pacific Islander

assistance, and depend on such as transportation and programs like Medicaid and those addressing social dethe Children's Health Insurterminants of health, such ance Program to access the as housing.

Community health centers narrow the coverage to care gap, addressing patients' complex needs with culturally competent care, language assistance and expertise with key health concerns affecting the communities they serve. They also provide enabling services, such as case management, health education in-language and transportation. These centers are a safety net for those who would otherwise be lost amid language barriers or other challenges in navigating the health system.

Their holistic approach results in improved health outcomes. Explaining her efforts to help the couple transition to a shelter, Gabriel said, "Home is good health. Housing is good education, housing is wellness."

Community health centers save billions of dollars in health care costs each year but themselves struggle for funding and resources. This includes payment or reimbursement for in-language assistance - required of but often in-

Community health centers need support to sustain the progress they have achieved. Elected officials and all policymakers must continue to invest in health centers, and health plans

must partner with community health centers to effectively serve the most vulnerable patients.

With the next open enrollment period underway through January, work to help more people get health coverage under the Patient Protection and Affordable Care Act continues, and community members should continue to enroll. In the AA and NHPI community, 70 members of Action for Health Justice, including KPHC, have reached nearly 1 million people in efforts to maximize enrollment.

Achieving health equity means getting more people covered and ensuring access to effective care. A stronger and healthier America begins with closing the coverage to care gap, ensuring continued coverage for our society's most vulnerable, and investing in community health provid-

This is Megan Loomis Powers testifying of Agenda Item C-1.

Thank you for the opportunity to submit testimony on this very important and personal issue. I grew up living on our family property that borders Ho'olawa stream below Twin Falls. My family still uses our property and spends time bathing and recreating at the stream.

It is vitally important to the East Maui Watershed that CWRM do their job and protect the 12 streams in Huelo by establishing "Interim In-stream Flow Standards" (IIFS).

Only by requiring a base stream flow can we protect native stream life who require Mauka to Makai connectivity, the fisheries and cultural practices that rely on natural flow.

We also need to provide for domestic and Ag water for residents that live along these streams. We have Ag land there where we subsistence farm.

Access to water for agriculture would enable us to scale up our production and create a bountiful line of value added food products.

Furthermore, recreation by residents and visitors alike greatly impacts their lives in a positive way. These uses must be protected according the law.

It appears as if CWRM has been dragging their heals...

Perhaps is it because Ho'olawa stream is one of Big Ag's largest and closest sources of water along the East Maui watershed.

As A&B & Mahi Pono are trying to get their foot in the door and acquire long-term leases on State and Private land in the Watershed, it is suspicious that CWRM is delaying their establishment if IIFS...

as if they are coordinating in the back rooms with the Big Players instead of doing their job, which is "protecting the natural resources for present and future generations."

Even though water is flowing now (in some of the 12 streams... not all) by not establishing in-stream flow standards; it leaves them vulnerable to BIG Ag taking ALL the water, if they win battle for the long-term leases.

It's not that we don't support farming in the Central Valley. But not at the expense and destruction of the "balance of life" that creates a healthy watershed (which has been the status quo for the last 100+ years).

Those of us that have spent much of our lives living and working and playing in the watershed have witnessed the harm done by bad resource management.

It can no longer be tolerated.

The central valley farmers need to focus on building soil tilth & health so that their soil retains water that it receives from rain and irrigation.

Currently the soil is so devoid of proper structure and micro organisms that it does not retain water, hence leading to the overuse and abuse of the water resources as well as

the need for synthetic fertilizers and pesticides, which in the end contaminate the aquifer and the food. Healthy soils grow healthy and more disease resistant plants.

Sadly, the Big Ag in the central valley is stuck in a positive feedback loop.

Add to that, the leaking water transport system that loses up to 22,000,000 gallons a day.

Giving Big Ag more water to waste on poor soils, meanwhile killing the Watershed is not a solution.

#1 Protect the water shed. Establish IIFS.

#2 Require that the transport infrastructure be repaired and maintained so that 22,000,000 MGD can stay in the watershed.

#3 Keep the control of our water resources out of the hands of a foreign corporation. Do Not approve the long term leases.

#4 Establish a storm water utility and build water storage reservoirs (both lined and unlined for recharging the aquifer.)

#5 Swale / contour the agricultural slopes of Haleakala so that they retain water and slow it's passage across the landscape.

The problems with the watershed, and the problems with the Central Valley soil health are the result of 100+ years of poor resource management.

Another example of extraction from nature and the native culture without giving back.

This trend continues as CWRM delays establishment of IIFS for the 12 Huelo streams being discussed.

Perhaps they are trying to establish an exact number before they make a final decision. The operative word here is "interim". The demands within the watershed will change within a range based on: changing as weather patterns, effects of the re-establishment of native species, and local residents farming practices.

For example, my family currently subsistence farms, but as we get our infrastructure established and our farming systems more streamlined and

our value added products developed ... and if next generations become passionate about carrying on the legacy, then we may have a higher demand for

ag water as we provide more products to the community.

The required flow volumes will need to be able to fluctuate over the years. But an established base flow for the support of native species and native crops is absolutely essential sooner than later.

Doing so, moreover, may ultimately serve to repair the ditches, preventing waste of precious water through unmaintained diversions.

My wife and I have attended water meetings off and on for the past 40 years. Not much seems to change, hopefully we are in a new generation now where the 'good old boy' aspects of plantation days are waining. I hope this commission will do diligence in a timely manner even if the 180 day extension is given.

Beside a concern for the ecology especially the marin ecology of the north coast of Maui, we have another reason to be concerned about a particular stream flow, Waipio stream.

We purchased our 3.8 acres at the beginning of 2003, our deed specifically designates that we have the right to a 1 inch pipe from Waipio stream for domestic use. Our property was part of a four part subdivision, of two different tax map keys. The three other properties in our subdivision were forced to give up their water rights and compensated with \$50,000. The owner that we purchased from declined accepting any monetary compensation and wanted to keep the water rights because his property/our property had its own tax map key while the other three were sharing what had once been a single tax map key.

Now for almost 18 years we haven't pressed the matter, we've been satisfied with our rainwater catchment system and see no need, to put any more stress on the pathetically flowing Waipio stream. However as climate change starts to hit we want to ensure that we have our rights to the stream as our back up. For us to truck and water is over \$850 for 4000 gallons, that might only last us three weeks. We want to be able to count on Waipio stream as our back up! 50,000 was waived for this right, which is now ours. We have justifiable legal interest.
