Dear Chair Case and Commissioners:

Moloka'i Nō Ka Heke urges this Commission to fully implement and enforce its April 19, 2022 decision partially addressing the waste of surface water diverted from the streams of Moloka'i's Mountain Water System ("MWS"). We further urge the Commission to amend Staff's recommendations to maximize the potential for restoration of Kawela ahupua'a and provide for reasonable-beneficial offstream uses by requiring full and permanent restoration for Kawela Stream and the use of other available sources to meet offstream MWS needs.

In April, this Commission instructed diverter Moloka'i Properties, Ltd. ("MPL") to, among other actions: (1) restore Kawela Stream; (2) begin the formal abandonment process for the unused West Kawela and East Kawela Tributary intakes; and (3) assess the feasibility of utilizing existing alternative non-potable water sources to allow for full restoration for Kawela. The Commission set a bottom-line interim instream flow standard ("IIFS") of 340,000 gallons per day (gpd) for Kawela, effective immediately, and approved Staff's oral recommendation to return all flows to Kawela for at least 180 days. To date, MPL has: (1) failed to restore Kawela Stream or comply with the terms of the IIFS;¹ (2) failed to submit stream diversion works permit

applications to abandon any intakes; and (3) subverted this Commission's intent to pursue full restoration of Kawela by reportedly proposing to offer two of the available alternative water sources to the Department of Hawaiian Home Lands ("DHHL"), instead of utilizing those and other sources as alternatives to diverting Kawela.

Enough is enough. MPL's twists and turns over the last six months do not change the Commission's April decision, or its mandate under the Water Code and Constitution. Full restoration of Kawela Stream remains practicable because MPL's offstream uses can be met by responsibly managing water inputs from other existing sources and more efficiently utilizing existing infrastructure, particularly the extensive storage capacity of MWS reservoirs. The Commission's April decision sought to effectuate enhancement and restoration of long-overexploited public trust resources to the extent practicable, while supporting and honoring the Kawela community's kuleana to ensure that their 'āina will thrive in generations to come. Given the last six months of MPL's continued waste, the Commission should take firm action to update, enforce, and effectuate its April decision, rectify ongoing injustices, and finally allow Kawela Stream and ahupua'a to recover from over a century of abuse.²

I. Legal Duty to Protect and Restore Instream Flows to the Extent Practicable

While Staff's October 18, 2022 submittal for agenda item B.2 ("October Submittal") summarizes several of the legal underpinnings for the Commission's authority to manage surface water resources, we further emphasize the legal principles and standards governing the Commission's decision in this case. In addition to the Water Code provisions and appellate court holdings noted in the October Submittal, the public trust doctrine—as enshrined in our Constitution and Code—expressly mandates that this Commission:

- (1) Protect and restore instream uses and values "to the extent practicable," *In re Waiāhole Ditch Combined Contested Case Hr'g*, 94 Hawai'i 97, 156 (2000) ("*Waiāhole*");
- (2) "[P]rotect, enhance, and reestablish, where practicable, beneficial instream uses of water," *id.* at 149;
- (3) "[R]eassess previous diversions and allocations," *id.* at 149; and
- (4) Consider "physical solutions, including . . . modification of [water] project operations, changes in time and rate of diversion, *uses of water from alternative sources,*

II. The Mountain Water System

The MWS consists of dams, intakes, reservoirs, and a network of pipelines and other infrastructure transmitting diverted mountain stream water across the island and pumping it back uphill at the base of Maunaloa.

Streams and Intakes. The estimated diversion capacities for each MWS intake,³ and the estimated quantities diverted in 1992,⁴ are as follows:

MWS Intake	Divertible Capacity (gpd)	1992 Diversions (gpd)	Status
East Kawela	500,000	562,000	active
East Kawela Tributary	unknown	67,000	unusable
West Kawela	100,000	67,000	inactive
Kamoku (Kaunakakai)	150,000	71,000	inactive
Lualohe (Manawainui)	100,000	270,000	inactive
Kalihi (Manawainui)	70,000	71,000	inactive
Hanalilolilo (Waikolu)	150,000	120,000	active

In recent years, only two MWS intakes have been utilized: East Kawela and Hanalilolilo (Waikolu).⁵ The remaining five intakes are dormant, and at least the East Kawela Tributary intake is damaged beyond repair. Miles of pipelines formerly connecting the dormant intakes lie unused throughout the east side forest reserve.

Reservoirs. The MWS storage infrastructure consists of four large reservoirs on the eastern mountain, two large reservoirs on the west side, and various smaller livestock reservoirs.⁶ The names and capacities of each MWS reservoir (or group) are:

1. Kawela (east): 5,000,000 gallons
2. Dole (east): 4,000,000 gallons
3. “Mountain Reservoir 1” (east): 15,000,000 gallons

4. “Mountain Reservoir 2” (east): 15,000,000 gallons
5. Pu’unānā (west) (+ ag tank): 7,250,000 gallons
6. Mauna Loa (west): 3,200,000 gallons
7. Livestock reservoirs (west): not stated, but comprising the largest acreage⁷
8. Total storage: **49,450,000 gallons**

Based on the combined acreage of all MWS reservoirs, Staff estimates that the reservoirs can lose around 33,000 gallons every day to evaporation.⁸ While those evaporative losses should certainly be mitigated, the large capacity of available storage for the MWS, if managed efficiently, can supply offstream needs for months at a time with zero inputs from any stream.⁹

Transmission Infrastructure. Stream water diverted at the MWS intakes is gravity-fed through pipes to a weir house combining inputs from all active diversions. From this structure, the water can be gravity-fed to the two smaller (and older) east side reservoirs and, from there, to the much larger and slightly newer “Mountain Reservoirs.”¹⁰ From the large reservoirs in the east, the water is gravity-fed down and across Moloka’i to the Mahana pump house, where diesel pumps push the water back uphill to the Pu’unānā reservoir, to be again gravity-fed to the reservoir at Mauna Loa and the network of smaller agricultural reservoirs.¹¹ MPL currently has no infrastructure to gravity-feed non-potable water to Kaluako’i.

III. MWS Diversion Capacities Grossly Exceed Offstream Uses.

The network of MWS diversions can take far more water than is needed for reasonable-beneficial offstream use. Even now, with only two of the seven available intakes open, the MWS diverts *nine times* the water needed to meet offstream uses—an outrageous level of waste that by all indications has been continuing unchecked for years.¹²

Maximum Diversion Capacities. Based on information presented in the April Submittals, the maximum diversion capacity of the East Kawela intake is 500,000 gpd.¹³ The Hanalilolilo intake on Waikolu Stream can divert up to 150,000 gpd, the same amount of water the Commission reserved to the Department of Hawaiian Home Lands (“DHHL”) out of the

mauka reach of the Waikolu hydrologic unit.¹⁴ The remaining five MWS intakes have been inactive for years, but the combined diversion capacity for Kamoku, Lualohe, Kalihi, and West Kawela is listed at 420,000 gpd,¹⁵ and in 1992 the amount diverted from all five unused intakes totaled 546,000 gpd.¹⁶

Diversion Rates. Diversion flow statistics for the MWS were presented in Table 4 of April Submittal C.3.¹⁷ In the early 2000s, mean daily diversions totaled 690,000 gpd, including water taken at Lualohe and Kalihi intakes, but not Kamoku.¹⁸ When the Lualohe and Kalihi intakes on Manawainui Stream were most recently in use, their daily mean inputs to the MWS were 139,000 gpd and 53,000 gpd, respectively.¹⁹ Subtracting the inputs from Kawela, mean daily diversions in 1992 totaled 466,000 gpd.²⁰ From 2019 to the present, the mean daily diversion rate was 372,000 gpd, diverting water only from East Kawela and Hanalilililo (Waikolu).²¹

Offstream Uses. In April, Staff reported that offstream uses of MWS water total approximately 42,000 gpd. Future MPL offstream uses were at that time predicted to total around 138,000 gpd, based on the additional need for 96,000 gpd of non-potable water to replace the potable well water currently used for landscape irrigation in Kaluako'i.²² MPL has presented no plan or suggested any intention to install a new non-potable pipeline to Kaluako'i. Until such a plan is proposed and becomes a tangible reality, the Commission should consider planned MPL offstream uses at current rates, *i.e.*, 42,000 gpd. In April, the Commission reserved 150,000 gpd to DHHL from the MWS portion of the Waikolu hydrologic unit (*i.e.*, from the Hanalilililo intake) for future use on DHHL's Kalama'ula tract.

IV. All Offstream Uses Can Be Met Without Diverting Any Water From Kawela.

Moloka'i Nō Ka Heke respectfully reiterates its disagreement with Staff's prior assessment that with full restoration of Kawela, only MPL's needs can be met.²³ Based on the information presented, reconnection of just two currently unused intakes—Lualohe and Kamoku—would allow for all offstream needs to be met while fully restoring Kawela Stream.

The Commission's Reservation of Waikolu Surface Water to DHHL Provides For DHHL's Planned Offstream MWS Uses. In April, the Commission reserved 6.0914 million gallons per day ("mgd") to DHHL from the Waikolu surface water hydrologic unit.²⁴ The reservation includes 150,000 gpd of Waikolu water from the MWS.²⁵ Hanalilolilo is the only MWS intake that diverts water from the Waikolu hydrologic unit²⁶ and provides 150,000 gpd to the MWS when fully utilized.²⁷ Thus, for this present purpose of demonstrating that MPL's offstream uses of MWS water can be met without diverting water from Kawela Stream, the following discussion does not include the 150,000 gpd available from Hanalilolilo and the 150,000 gpd DHHL reservation of Hanalilolilo water. In reality, however, the amount of water proposed to be set aside for the DHHL reservation would continue to be available for MPL's use until DHHL is actually able to use the water.

Full Restoration of Kawela Stream Will Not Constrain Offstream MWS Uses. Exhibits 18 and 19 to April Submittal C.2 presented estimated low flow statistics and water availability for each of Staff's proposed alternatives. Median flows at Kamoku, Lualohe, and Kalihi intakes were estimated at 33,000 gpd, 72,000 gpd, and 6,000 gpd, respectively, for a total of 111,000 gpd.²⁸ Staff recommended IIFSs for Lualohe and Kamoku that would allow diversion of **70,000 gpd** to the MWS on a mean daily basis, more than enough to meet MPL's 42,000 gpd of offstream needs. Because Staff did not propose to establish an IIFS for Kalihi intake, the availability of water from Kalihi was not stated in Exhibit 18 or 19 of April Submission C.2. In the early 2000s, however, when Lualohe and Kalihi intakes were active (and excluding Kamoku), they provided reported mean daily diversions of 139,000 gpd and 53,000 gpd, respectively (192,000 gpd total) to the MWS.²⁹

Most importantly, Staff's April Exhibits 18 and 19 "d[id] not consider the storage of excess water diverted during flows greater than [the IIFS] and made available during lower flow periods."³⁰ Moloka'i Nō Ka Heke respectfully urges that this additional supply must be considered given the extensive storage capacity of the MWS. The amount that can be diverted in excess of any IIFS extends to the maximum divertible capacity of each intake, as listed in Part II, *supra*. When last connected, the maximum divertible capacities of Kamoku and Lualohe intakes were 150,000 gpd and 100,000 gpd, respectively, totaling 250,000 gpd.³¹ The MWS's total storage capacity is nearly 50 million gallons, enough to meet all offstream needs for

months at a time without any diversion of stream water whatsoever.³² Thus, by capturing high-flows from Lualohe and Kamoku at maximum intake capacity to fill the reservoirs, the MWS can meet all offstream needs with no further inputs during lower-flow periods.³³ Given the MWS's significant available storage capacity, there is no need or justification to set the IIFSs to accommodate continual diversions by ensuring that the "mean divertible flow" is equal to the stated planned offstream uses at all times. In other words, just because MPL uses 42,000 gpd does not mean that it must divert that amount every day, or that the IIFS must be set at a level to ensure that level of diversions daily. Again, with efficient use of the reservoirs, MPL could meet its needs for months at a time without any diversions.

V. The Commission Should Fully and Permanently Restore Kawela Stream, Enforce its April Decisions, and Amend Staff's Recommendations Accordingly.

This Commission in April made clear its "goal of full restoration" for East Kawela.³⁴ In implementing its "phased approach" to accomplishing that goal, the Commission approved Staff's oral recommendation to return "all the water back into the stream" for at least 180 days.³⁵ Even if Staff was wrong about the efficacy of opening a particular valve,³⁶ MPL undeniably knows how to effect full restoration, as observed on May 11.³⁷ In the ensuing months, however, MPL has ignored the Commission's instruction to restore Kawela. Moreover, it has initiated discussions seeking to dispose of its most promising long-term alternative sources, Lualohe and Kamoku intakes. We urge the Commission to affirm and restate its intention to restore Kawela, require MPL's compliance with the Commission's April decisions, and amend Staff's recommendations to require that Kawela Stream is fully restored, and that all practicable alternatives to diverting Kawela are fully and honestly assessed.

The Commission Should Require MPL to Submit Plans to Fully and Permanently Restore Kawela Stream. In amending Staff's April recommendations, this Commission stated affirmatively that "[i]n 180 days, the Commission will consider the timeframe to achieve full restoration."³⁸ MPL's submitted plans to modify the East Kawela intake to meet the IIFS will not achieve full restoration. In considering the timeframe for full restoration, the Commission should also consider implementation. Moloka'i Nō Ka Heke therefore requests a 30-day deadline for MPL to prepare plans to remove the East Kawela dam and intake permanently. We support Staff's recommended 90-day deadline to submit a Stream Diversion Works Permit

(SDWP) application for proposed Kawela modifications, but the deadline should instead be for permanent removal.³⁹

The Commission Should Hold MPL Accountable for Proven Violations. As Moloka'i Nō Ka Heke noted in its September 22 letter to the Commission, on all but one occasion when community members visited the intake, nearly all of Kawela's water was being diverted.⁴⁰ The sole exception was on May 11, when Moloka'i Nō Ka Heke members, Commission staff, and MPL representatives visited the intake together to implement what was supposed to be a full restoration of flow in compliance with the Commission's April decision.⁴¹ Staff's October Submittal states that the East Kawela IIFS was verifiably met on only one other day.⁴² Staff notes that when measurements of stream flow "made above and below [East Kawela intake] demonstrate that the [IIFS] is not being met and water continues to be diverted, then a violation of the [IIFS] has occurred."⁴³ Although Moloka'i Nō Ka Heke observed flows being almost fully diverted throughout the last six months, based on a strict reading of Staff's definition above, verifiable violations occurred on at least two days.⁴⁴ Accordingly, Moloka'i Nō Ka Heke requests the Commission levy administrative fines of \$10,000 for two days of violations pursuant to Haw. Rev. Stat. § 174C-15 and Haw. Admin. R. § 13-168-3.

The Commission Should Shorten the Deadline for MPL to Submit SDWP Applications for Abandonment of East Kawela Tributary and West Kawela Intakes. The Commission instructed MPL to initiate formal abandonment of the two unused Kawela intakes by submitting SDWP applications by July 18, but to date MPL has not done so.⁴⁵ Staff recommends a new deadline of 30 days to submit the missing permit applications.⁴⁶ Because of the already long delay, we request deadline be shortened to 15 days deadline and implementation required within 90 days of SDWP approval. Formal abandonment should include clean-up and remediation to return the streams to their natural states. We also raise for the Commission's attention that on October 14, Moloka'i Nō Ka Heke members observed that instead of being

decommissioned, the West Kawela intake is again diverting water, which is currently flowing into the concrete weir near the East Kawela access tunnel.

The Commission Should Ensure That MPL Thoroughly Assesses and Promptly Implements Waste Mitigation Measures and Alternative Water Sources. In April, the Commission further amended Staff's recommendations to require a "water system audit or other investigation to determine more accurately evaporative or system loss and reduce that to provide for additional source[s]." ⁴⁷ The Commission moreover directed MPL to "analyze whether wastewater reuse is a potential additional water source to meet its non-potable needs." ⁴⁸ Assuming MPL presents its findings on these topics at the Commission's October 18 meeting, we urge the Commission to require firm deadlines for MPL to: (1) remediate its increasingly dilapidated reservoirs and provide for mitigation of evaporative and system losses, and (2) propose plans to utilize reclaimed wastewater for non-potable uses in Kaluako'i.

Moloka'i Nō Ka Heke *Strongly Objects* to Staff's Proposal That MPL and DHHL Enter Into Discussions Regarding Reactivation of the Lualohe and Kamoku Intakes. When Moloka'i Nō Ka Heke filed its petition and complaint in 2019, we asked the Commission to establish flow standards for the active East Kawela and Hanalilolilo (Waikolu) intakes, and to order MPL to formally abandon all five of the inactive MWS intakes. When new data came to light between the Commission's February and March 2022 meetings showing that MPL was diverting nine times as much water as it uses, and that MPL's offstream uses can readily be met with water from Lualohe and Kamoku, Moloka'i Nō Ka Heke supported the possibility of reactivating Lualohe and Kamoku intakes *for the express purpose of effecting full restoration of Kawela*. Staff's recommendation, however, suggests that MPL is considering offering the Lualohe and Kamoku intakes for DHHL's use. ⁴⁹

While we appreciate and have consistently supported DHHL's initiatives to supply water to homesteaders, including advocating in support of DHHL's nearly 6.1 million gpd reservation out of Waikolu, we strongly urge the Commission to reject MPL's bald attempt to avoid fully restoring Kawela by undermining the legal obligation to consider and use available alternative water sources through speculative negotiations with DHHL. The very suggestion of such an arrangement all but proves that reactivation of the Lualohe and Kamoku intakes is both feasible and practicable. Again, Lualohe and Kamoku intakes are entirely capable of meeting MPL's offstream uses of 42,000 gpd. ⁵⁰ DHHL has not yet begun to implement even its 150,000 gpd reservation from Hanalilolilo, and MPL has not yet begun to legitimately restore Kawela Stream as the Commission ordered. Nevertheless, both developers appear poised to subvert the Commission's April decision and twist it to impose the burdens of (at best) theoretical offstream

uses on Kawela's stream and community, without any need or justification. We therefore strongly urge the Commission to re-emphasize its intent to fully restore Kawela and reactivate Lualohe and Kamoku to meet *MPL's* offstream needs.

Finally, Moloka'i Nō Ka Heke appreciates and generally supports Staff's recommendation to hold regular quarterly meetings including Moloka'i Nō Ka Heke along with MPL and DHHL. But as other examples such as the Waimea River case has shown, without strong and proactive Commission direction, such meetings are far less effective and can simply contribute to delays, feet dragging, and community frustration. In short, such meetings are not a substitute for the concrete action that Moloka'i No Ka Heke is requesting.

VI. Conclusion

For the foregoing reasons, Moloka'i Nō Ka Heke urges this Commission to end the ongoing diversion and waste of Kawela water, fully effectuate the Commission's April decisions, and ensure that Moloka'i's water resources are conserved, protected, and restored to the maximum amount practicable. In summary, we request the Commission to amend Staff's recommendations as follows:

- Establish a 30-day deadline for MPL to submit a plan for removal of the East Kawela dam, intake, and pipeline; a 30-day deadline to submit an SDWP application for removal; and a 180-day deadline for completion upon SDWP approval;
- Find MPL in violation of the East Kawela IIFS for two days and levy administrative fines of \$10,000;
- Order MPL to immediately cease any diversion from the West Kawela intake;
- Establish a 15-day deadline for MPL to submit SDWP applications to remove the East Kawela Tributary and West Kawela infrastructure and a 90-day deadline for completion upon SDWP approval; and
- Establish a 30-day deadline for MPL to propose measures to minimize system losses and a 90-day deadline for implementation.

Mahalo for taking action to protect and manage Moloka'i's surface water resources and for ensuring that this Commission's management decisions have real-world results. Restoring Kawela's mauka flow will significantly benefit both the 'āina and people of Kawela, particularly with the passage of time and consistent daily flow of water toward Kawela's makai area. We look forward to participating in the Commission's continued efforts to address water resource issues on Moloka'i, including the remainder of Moloka'i Nō Ka Heke's 2019 Petition.

Aloha,

My name is Teave Heen, I'm a lifelong resident of Kawela with no plans of leaving Molokai. I am testifying on item B2.

I'm in full support of the decisions that were made in April's meeting regarding IIFS, abandonments, cleanup, waste management, utilizing existing water storage facilities and alternative water sources.

However, the bigger issue here is still on the table; and that is full restoration for Kawela. We need to immediately do what is required to achieve full restoration as soon as possible, while MPL continues to follow through with all the commission's recommendations.

To my understanding the IIFS for Kawela was supposed to be in effect during this 180 day waiting period while a plan to fully restore Kawela was established by MPL. Despite MPL's two attempts to stop diverting all the water, till this day, all the water is still being diverted. We went up in June and found that despite their first attempt, all water was again being diverted, NO water was running down stream. Last week we went up again to find that their second attempt also failed and again NO water was running downstream, ALL the water was draining into their diversion pipe. We also saw West Kawela water being diverted. This was a diversion that was supposed to be abandoned. This stream hardly runs so to see this water being taken and dumped into a ditch lead me to strongly believe that MPL is not taking any of the recommendations seriously and I don't trust them with any more temporary solutions to restore the water. The next alternative is to remove the dam. The dam is outdated and constructed at a time where the engineers had no consideration for the future. Well, the future is now, and we see the effects of this outdated design from what is happening downstream and to the entire Ahupua'a. Taking down the dam would be essential to the health and wellness that we were looking for and create an efficient way to regulate stream flow. Little to no monitoring is needed and it's the most inexpensive solution.

I think major moves have been made in the right direction since this petition was filed in 2019. I hope we can quickly find solutions to this ongoing problem with Molokai Ranch. I wanna thank the commission staff for listening to our community and holding true to our state water code.
