## Aloha Commissioners,

My name is Shelley Muneoka and I wanted to submit testimony in support of the CWRM staff recommendation to fine Olowalu Water Company (OWC) the prescribed \$440,000 penalty for violating the IIFS since January 2019. OWC is a known bad actor, previously fined in 2018 for building a 30-foot long, 12-foot wide concrete dam in the stream (!!!) and diverting 2 million gallons a day without authorization. They are also completely delinquent on required reports by CWRM on the water volume being diverted by Diversion 961 for the last year. Their reporting was spotty in the two years prior (missing 16 of 24 reports). It is clear that they are not taking seriously the impacts of their previous or ongoing bad acts.

I also support the \$30,000 to cover administrative and installation costs for the new gaging station installed by CWRM at OWC's request.

Echoing Commissioner Hannahs' mana'o at the Oct 18th CWRM meeting -- after this many years of ongoing violations on the part of OWC, one must conclude that they are willfully negligent and must be held to account.
