**RE: Commission on Water Resource Management--Ground Water Use Permit for Existing Users in the Honokowai Aquifer System, West Maui, Water Management Area**

Dear Chairperson Chang, Deputy Manuel and Members of the Commission  
on Water Resource Management:

The purpose of this letter is to provide the Commission with an application for ground water use for existing users in the Honokowai Aquifer System, West Maui. Hawaii Water Service Company, Inc. (Hawaii Water) provides potable water service to the Kaanapali resort area via nine wells in the Honokowai aquifer system. Hawaii Water owns three of the nine wells. The remaining wells are leased from Maui Land and Pineapple (MLP) and Kaanapali Land Management Corporation (KLMC). As a result, Hawaii Water is submitting three separate page 1 of form GWUPA. Each first page presents wells owned by the three entities. The required supporting documentation applies to the entire service area. The application refers to several appendices, each meant to meet the requirements of the Ground Water Use Permit Application (GWUPA). The following summarizes the appendices to the application.
