**II. PROMPTNESS OF APPEARANCE:**

Failing or refusing to access the hearing by or at the Appointed Time may, in the hearing officer's discretion, result in the hearing going forward without your participation at the Appointed Time. In the hearing officer's discretion, your hearing rights may be deemed to be waived. No party shall be permitted to appear for the hearing in-person, unless expressly ordered by the hearing officer.

**III. RECORD OF HEARING:**

All audio sounds during the video conference hearing shall be recorded electronically by the hearing officer using the “Zoom” application. This audio recording shall constitute the formal record of the hearing and will be posted online for the parties to access as soon as practicable after each of the Appointed Times. Information needed to access these postings and other hearing records will be provided in a forthcoming minute order.

The record shall not include any video recording of the hearing. Parties are prohibited from recording the hearing in any way using their own electronic devices.

**IV. ORDER AND MANNER OF SPEAKING:**

Generally, the hearing officer shall recognize or identify by name, the person who is about to be heard next. However, when someone wishes to be heard without the hearing officer first recognizing or identifying them, the speaker shall state their first and last name before uttering the substance of their statement, argument, or question. If multiple people attempt to speak at the same time, all speakers shall immediately stop speaking and the hearing officer shall designate which person may speak first. This ensures a clear record.
