**ORDER DENYING SIERRA CLUB'S
MOTION TO ALLOW REAL PUBLIC ACCESS TO THE CONTESTED CASE
HEARING, DATED DECEMBER 7, 2021**

The Sierra Club's "Motion to Allow Real Public Access to the Contested Case Hearing," dated December 2, 2021 ("Motion"), is hereby DENIED.

The Motion repeats the Sierra Club's December 2, 2021 request to either have the contested case hearing livestreamed or to lift the prohibition on recording the proceedings so that the Sierra Club can livestream the hearing itself. These requests have already been considered and denied in Minute Order No. 15 dated December 3, 2021. For the reasons previously stated in Minute Order No. 15, the Hearing Officer finds that the public access provided is sufficient and declines to grant the Sierra Club's request for additional measures.
