¹ In particular, after reviewing the Audio Recording of the Contested Case Hearing dated December 9, 2021, at timestamps 45:50-to-50:30, it is clear that both the witness (Dr. Ayron Strauch) and the questioner (counsel for the Sierra Club) are talking about photos of the waterfalls found on page 11 of Exhibit D-1, which the photos say are at approximately 600-ft. elevation. The Strauch testimony from the *trial* held in 2020 is inapposite.
