**Annual Renewal of Revocable Permits on the Islands of Hawaii, Maui,  
Molokai, Kauai and Oahu**

**STATUTE:** Section 171-55, Hawaii Revised Statutes, reads as follows:

"Permits. Notwithstanding any other law to the contrary, the board of land and natural resources may issue permits for the temporary occupancy of State lands or interest therein on a month-to-month basis by direct renegotiation without public auction, under conditions and rent which will serve the best interests of the State subject, however, to those restrictions as may from time to time be expressly imposed by the board. A permit on a month-to-month basis may continue for a period not to exceed one year from the date of its issuance; provided that the board may allow the permit to continue on a month-to-month basis for additional one year periods."

**BACKGROUND:**

As part of its annual review of revocable permits, the Board may either approve or disapprove the continuation of existing revocable permits covering State lands on a month-to-month basis for another year with or without any changes in their existing rental rates. Such actions are taken in recognition of prevailing economic conditions.

On January 26, 2001, under agenda item D-17, the Board approved the method of revocable permit rent review for future years as follows:

- A. Starting in May 2001, the Appraisal Section would review and appraise at least 10% of the existing revocable permits on each island. This sample will include all property types.
- B. Based on the results of this sampling, a decision will be made to review and appraise all of the existing revocable permits, just a portion (based on character of use, island or both) or none of the remaining existing revocable permits. This decision will hinge on whether the sampling produces rent increases of 5% or more.

- C. In December of each calendar year, the Appraisal Section will present the findings of its sampling and revocable permit rent recommendations for the coming year.

At its February 22, 2002 meeting, under agenda item D-14, the Board approved, as amended, the continuation of the listed revocable permits for an additional one-year period up to December 31, 2002, except for permits that were in arrears, at the current rents. Because of the negative economic impacts of September 11th, staff felt the sampling method would not achieve fruitful results. Instead, staff used last year's method of reviewing indices of real estate activity to determine whether a permit-by-permit review would be justified. Based on these indices and the state of the economy at that time, staff felt rent increases were not warranted. Further, permittees could have sought rent relief pursuant to Act 15, Third Special Session Laws of Hawaii 2001.

At the February 22, 2002 meeting, the Board also questioned staff on the following permits. We provide a status response for each as follows:

- RP6271      Kahala, Duke – Board wanted to insure that this and any other RPs on the list in Kahana Valley were reviewed for consistency with their recent actions. They did not want any conflicts with renewing something that they had recently terminated or should not renew.  
*Erwin Kahala is living on the permit area and paying rent. Therefore, we have to cancel this RP and give a new one to Erwin. This process cannot be completed before the end of the year. So, this RP has to be extended.*
- RP5985      Carlsmith, Curtis – The Board was aware that the person is deceased and requested that the status of the permit and the permittee be reviewed by staff.  
*Maui District Branch is continuing efforts with Judge Marilyn Carlsmith to determine what instrument is appropriate to replace the existing RP 5985. An abstract request has been initiated to determine the kuleana status of the beneficiary parcel. Staff requests that the existing RP be renewed pending a final decision from Judge Carlsmith.*
- RP7263, RP7264, RP7265 & RP7266  
These are the RPs involved with the EMI Irrigation system that were holdover by prior action involving a contested case. These should be removed from the list. However, in connection with these RPs, the Board requests that the rental rate on these RPs be reviewed and briefing be held on this rate issue upon appraisal or research into rates.  
*As these permits continue on a "holdover" basis due to the ongoing contested case hearing, they do not appear in Exhibit A.*
- RP5346      Smart, Richard – Mr. Smart is deceased, Board asked that staff review the status of the permittee under this RP.

*The Board approved the cancellation of this permit and re-issuance to Parker Ranch on September 13, 2002. Document execution is in process.*

RP6040 Hashimoto, John K. & Junedale – The Board indicated that they were aware that John Hashimoto was deceased and were not aware of adding his daughter Junedale on as an additional permittee. The Board asked that staff review the status of the permittee. Additionally, the Board had some concerns that the rental rate on this property and asked that this rental rate be reviewed.

*Both John and Junedale are permittees under RP 6040. Since only John has passed away, staff recommends maintaining this permit as is. Regarding the review of the rental rate, due to vacancies in the Appraisal Section, staff did not have an opportunity to complete this review. Refer to staff's comments below.*

Various The Board requested that all non-governmental RPs with \$0 rent rates be reviewed.

*Due to the vacancies in the Appraisal Section, staff did not have an opportunity to complete this review. Refer to staff's comments below.*

Various The Board requested that all RPs that were involved in the Kaneohe Bay Piers program be reviewed to insure that the impact of these renewals is consistent with their prior actions on these piers. They did not want to trigger billing those RPs that are supposed to be on hold until implementation of the leases.

*The majority of Kaneohe Bay permittees have participated in the Amnesty Program, and we have stopped billing them. Quite a number of them will be getting their leases soon. In the meantime, staff recommends approving the permits for an additional one-year period (until such time the leases are executed) at the zero rents to indicate no billing.*

Due to loss of appraisal staff, we have not initiated the review of permit rents for this year. In December 2001, one staff appraiser went out sick and then left the Division. In June 2002, the only other staff appraiser resigned. A new appraiser was hired in August. Because of the vacancies, a sizable backlog of appraisal assignments accumulated. The appraisal manager has had to complete assignments in the order of priority, including regular reopenings, lease extension reopenings, new dispositions, calculation of assignment premiums and sublease sandwich profits and special projects (e.g., EMI water appraisal, Honokohau Ditch appraisal, Naniloa appraisal, etc.). The review of revocable permits was considered a lower priority.

Staff feels that once the priority assignments have been addressed, a review of the revocable permit rents may be possible sometime during 2003. Therefore, staff is recommending that, while the Board approve the existing rents, the Board also authorize the Chairperson to review and revise permit rents during 2003. This action will allow the staff appraiser to evaluate the rents and obtain Chairperson approval for any adjustments. The staff appraiser will look at the non-governmental permits with gratis

rent and the Hashimoto RP 6040 as the first priority. The standard permit conditions do allow for rent changes with 30-day notification.

Notwithstanding a possible review of rents during 2003, the staff appraiser will apply the approved method of revocable permit rent review for next year's permit renewals.

**RECOMMENDATION:** That the Board:

1. Approve the continuation of the revocable permits listed in Exhibit A on a month-to-month basis for another one-year period up to December 31, 2003, except for permits that are in arrears of rental payment for more than 60 days. Permits in arrears of rental for 60 days or more shall not be renewed.
2. Approve the continuation of current rents as listed in Exhibit A, provided that the Board delegates to the Chairperson the authority to review and revise such rents during the year.
