ISSUANCE OF QUITCLAIM DEED OR LAND PATENT IN EXCHANGE FOR DEED TO PRIVATE LANDS BY WAY OF EQUITABLE SETTLEMENT, CIVIL NO. 5467, 3RD CIRCUIT, KOHALA CORPORATION V. CALLISH, KOHALA, HAWAII

## ITEM F-9

Mr. Shimabukuro asked to amend his submittal: (a) under properties to be conveyed from Kohala Corporation to State of Hawaii, item B., delete the third item, 5-7-03:Por. 1 (easement); (b) under recommendation, add the finding that the abandoned road parcel designated by tax map key no. 5-7-03:Por. 10 is economically, physically, unsuitable and undesirable for development as a separate unit and declare that it is a remnant.

Mr. Shimabukuro stated that the State was successful in its claim to Mahukona I and that in 1985, Kohala Corporation filed for quiet title action on Mahukona I. On appeal, however, the Hawaii Supreme Court held for Kohala Corporation and remanded the case to the Third Circuit to determine what area constituted the "flat land" reserved by the King during the mahele.

Mr. Shimabukuro stated that Kohala Corporation has offered to settle the "flat land" issue by quitclaiming 6-10 acres in exchange for its fee land of approximately 16 acres. A portion of that is under lease to the county; a portion is adjacent to the Coast Guard property. They would also like to include the abandoned road in exchange for another easement serving State land under lease to Richard Smart. The shoreline trail (floating easement) may be relocated at a later date.

Mr. Shimabukuro indicated he recommended the exchange for 16 +/- acres as settlement, with the details to be worked out by the Attorney General's office; he also requested authorization to publish the disposition.

Mr. Shimabukuro stated that Mr. William Tam, deputy attorney general, and the attorney for the Kohala Corporation were both present.

Mr. Kealoha questioned Mr. Shimabukuro on the size of the remnant piece. Mr. Shimabukuro indicated that it was approximately one acre; that it was 30 feet wide, and the road is about 50 feet; that the acreage to be exchanged was about the same, combining the flat areas, 6-9 acres. Mr. Kealoha also asked whether it was fast land, and Mr. Shimabukuro answered in the affirmative.

Deputy Attorney General William Tam was called forward. He stated that the area reserved was the flat lands and harbor area land. The exact measurements have not been determined by any court or land document. The State contends, however, that the parcel is between 6 to 8 acres. However, he stated that Kohala Corporation differed with the State on the measurement. Mr. Tam explained that the disputed acreage could be measured by the survey office. He said they are before the Board to obtain approval in concept and subsequently to obtain the approval from the Third Circuit Court. He said the settlement did not include the floating easement; however, Mr. Wong suggested that it might be beneficial to have the easement measured so that when it is relocated the measurements will be the same.

Mr. Shimabukuro summarized stating that the total acreage of State of Hawaii land to be conveyed to Kohala Corporation is 7 to 11 acres, and from Kohala Corporation to the State, 16 +/- acres. Under the lands from Kohala Corporation to the State, the easement is deleted and that the roadway is included in parcel 5-7-03:13. Mr. Shimabukuro agreed to amend his submittal subject to verification of the acreage involved.
