ACCEPTANCE OF LAND BY GIFT, ADDITION TO WAIAKEA-WAENA ELEMENTARY SCHOOL, TMK 2-2-42:07, WAIAKEA, SO. HILO, HAWAII. ITEM F-3

ACTION Unanimously approved as submitted. (Arata/Arisumi)

DIRECT ISSUANCE OF LEASE TO KAHIKOLU CONGREGATIONAL CHURCH AT ITEM F-6 KALAMAWAIAWAAWA, KAHAULOA-1ST, SO. KONA, HAWAII, TMK 8-2-07:7 & 9.

When asked by Mr. Paty if he had any problems with the conditions, Mr. Wilcox said no except for the bond requirement.

Mr. Arisumi voiced concern as to what would happen to the cemetery plot after the 55 year lease expired. Mr. Kealoha suggested to Mr. Wilcox that he look to having some kind of legislation introduced whereby the church could purchase the land.

ACTION Unanimously approved as submitted. (Arata/Arisumi)

CDUA FOR A SINGLE FAMILY RESIDENCE AT KAHAULOA, SO. KONA; APPLICANT: ITEM H-2 MR. & MRS. ALLEN C. WILCOX, JR.

> Mr. Evans presented this application with a recommendation for approval. However, he stated that there was concern with respect to Condition No. 4 which requires the applicant to install a septic tank, etc. Mr. Wilcox thought this to be a major problem and felt that the Department of Land and Natural Resources and the Department of Health should find out the facts with respect to cesspools and drainage, not only for the Kealakekua Bay area but for other areas as well.

> Mr. Arisumi asked if putting in a septic tank was a requirement. Mr. Evans explained that this requirement became effective sometime in 1988 when the Department of Health came out with new administrative rules. Under these new rules, the applicant is required to come up with a new wastewater treatment works which did not apply to some of the others in the area because they were grandfathered in.

ACTION Mr. Arata moved to approve with an amendment to Condition No. 4 requiring that the applicant shall comply with all applicable Department of Health rules and regulations. Mr. Arisumi seconded; motion carried unanimously.

> RESUBMITTAL - REQUEST OF HOUSING FINANCE AND DEVELOPMENT CORPORATION FOR RIGHT OF ENTRY FOR PLANNING, TOPOGRAPHY SURVEY, ENVIRONMENTAL AND ENGINEERING STUDIES FOR AFFORDABLE HOUSING PROJECT, TMK 4-5-21:03, WAHIKULI, LAHAINA, MAUI.

Mr. Arisumi wondered if it was possible to develop affordable homes at Wahikuli inasmuch as homes in that area are now selling for about \$250,000. He asked who would be able to afford to buy these homes. His concern was that the people working for the hotels and/or Pioneer Sugar would not be able to afford to buy these homes. Not only was he concerned about the homes being affordable, he was also concerned that prime sugar land was being taken away from Pioneer Sugar.

Mr. Dickie Hirata of HFDC explained their pricing criteria for affordable housing. Right now HFDC's plans are really at the embryo stage. He said that a typical three bedroom house today would cost about \$115,000 to develop and then went on to explain how they would lower this cost so it

was affordable. Taking OSP's formula of 60-40, about 40% of the homes would be sold at market and, if they are lucky enough to pick up about \$15,00 on each unit, that will down the price for the affordable units by that \$15,000. They are not only looking at a social-economic mix by doing this but will also be deriving revenue to meet the needs of the low income people. They will also be looking at ways to address the rental problem. Right now, however, they are only looking for a right of entry to do their studies.

As far as sugar is concerned, Mr. Hirata said that they will be working very closely with the sugar company in bringing down fields so that there won't be any crop damage. What will dictate the pace will probably be twofold -- 1) the absorption rate; and 2) sugar. It would be difficult right now for HFDC to say whether this would take 10, 15 or 20 years. Right now they are looking at 4000± units.

Mr. Bert Hatton of AMFAC, speaking for Pioneer Sugar, talked about the impact HFDC's project would have on Pioneer Mill. While they have no objections to the right of entry for purposes of the study, they would, for security purposes, like to see a condition added where HFDC would notify the manager of Pioneer Mill anytime someone would enter the property. He also urged that HFDC look at a phased development. Pioneer Mill would not like to see all 1128 acres withdrawn from their lease. Mr. Hatton said that Wahikuli is not only important to Pioneer because of the cane lands but because of the infrastructure they have e.g. cane haul roads, which delivers from their own lands as well as state lands from the Honokowai area. This comes through the Wahikuli property so they would ask that any planning take into consideration continuance of that infrastructure e.g. cane haul road, irrigation systems, etc.

Mr. Kealoha asked, if during the conduct of the right of entry, Mr. Hirata finds for any reason a need to reopen a discussion for land exchange, that this discussion also be included in the report to the board. Mr. Hirata said that if all the numbers come out favorably to take the state land, then they would rather just go with the state land.

Mr. Arisumi moved to approve with the added condition that a report of the findings by HFDC be forwarded to the Board for review. Mr. Arata seconded; motion carried unanimously.

APPROVAL OF AMENDMENT TO PLAN OF OPERATIONS FOR 25 MW GEOTHERMAL PROJECT, STATEMINING LEASE NO. R-2, KAPOHO, PUNA, HAWAII.

Mr. Tagomori said that the amendments to the original Plan of Operations (December 1986) will reduce potential environmental impacts through the use of back-pressure steam turbines, air-cooled binary cycle steam turbines, and the injection of spent geothermal fluids and gases back into the geothermal reservoir at depth.

Maurice Richard of ORMAT explained the process in terms of what environmental impacts exist, the energy conversion, etc.

In answer to Mr. Arata's question as to whether these changes required public input, Mr. Richard answered in the negative. He felt that these changes were a big improvement from the original plan. He said that they have had public meetings in Pahoa relating to these changes; they have shown video and films and felt that they have had very positive response.

Mr. Paty said that he did have the opportunity to see their plants in operation in Imperial Valley and it certainly was an improvement to what he has seen so far.

Mr. Arisumi said that there was no way the wall could be taken down without having to bring in a barge, and maybe not even that, to take all of the rubbish away. Staff's recommendation is to take the seawall out.

Mr. Kealoha asked whether in staff's research there had ever been established the owner's boundaries before the 1980 certified shoreline. Mr. Evans said, yes. Mr. Kealoha was interested in the owners property seaward of the shoreline. Mr. Evans said that the shoreline was seaward of the deeded boundary.

Mr. Kealoha asked Craig Nakamura, who represented the applicant, if he knew how much in terms of inches from the private property to the ocean the water extended out to the state lands. Mr. Nakamura presented drawings for the board's review and explained.
