REQUEST TO AUTHORIZE DESIGN PROPOSALS REGARDING CDUA FOR THE ATLANTIS SUBMARINE TOUR OPERATION OFFSHORE OF WAIKIKI, OAHU; APPLICANT:

ATLANTIS SUBMARINES INC.; AGENT: ERIC GUINTHER ITEM H-3

Mr. Yuen asked how applicant was proposing to remove the day use mooring and how would it be stored. Mr. Evans said their understanding is that the day use mooring would be brought out when the first boat goes out and brought in with the last boat at nite.

Mr. Eric Guinther, Agent for Atlantis and Mr. Rick Schaefer, General Manager were present. To answer the questions of the Board, Mr. Guinther explained that the buoy that exists now, is attached to the items that are down in the bottom, specifically the sunken ship. Most likely that will be the method for the buoy that is being requested. The Army Corps of Engineers have requested that the buoys not be on the surface at night there were concerns by the sailing community that even a lighted night, there were concerns by the sailing community that even a lighted buoy would be hard to see at night.

The buoy is taken out in the morning and attached to the ship by divers and removed in the last dive of the day. Basically the mooring buoy is used by Atlantis or the divers have a surface boat and they are the primary users of the existing mooring now. There are occasions when private persons come out and they use the buoy. By having a 2nd buoy, it would be used by people that are not associated with Atlantis but it would make available a mooring mainly for public access and safety reasons.

Mr. Schaefer said that at least a boat a day comes out and few more on the weekends. They try to get them to tie up to the bouy and most are cooperative.

Mr. Arisumi asked if there is a rope to the buoy and is it safe, and is there a chance of it catching on to a propeller as it is dangerous.

Mr. Guinther answered that the Corps requires that nothing be in the water column down to a depth of 40 feet and Mr. Shaefer said that the top of the ship is at 40 feet.

Mr. Arata said his concern is whether the sunken vessel had any oil or gas leaks. Mr. Guinther said the Coast Guard and the Department of Health need certification that the craft is properly cleaned and inspected.

Responding to Mr. Kealoha, Mr. Evans said applicant was required to file an Environmental Assessment upon which staff made a negative declaration.

REQUEST FOR BOARD ADOPTION OF PROPOSED POLICY STATEMENT FOR PRESERVATION OF THE PREHISTORIC-EARLY HISTORIC ALA LOA COASTAL TRAILS ITEM C-3

Mr. Michael Buck presented the proposed policy.

Mr. Arata said he had a problem with the language and was concerned with the definition of the word "preserve". He would need more time to review the proposed policy statement with staff and possibly the Attorney General's Office also.

ACTION

Mr. Arata moved to defer this item to the next Kona Board meeting. Motion was seconded by Mr. Arisumi.

DISCUSSION

Mr. Apaka said he also had concerns regarding the language of the polices. He asked if the trails mentioned were for all the islands.

Ms. Deborah Chang Abreu, Project Coordinator of the Na Ala Hele Program said traditionally an ancient culture there were foot trails encircling every island. Currently there are not too many trails left on Oahu. Na Ala Hele has demonstration trials on all islands and the intent of the proposed policy is for all islands.

Mr. Buck said that the Na Ala Hele Program extends beyond just along the coast and is also working toward makai and mauka accesses as well.

Mr. Buck said that this is only one component of the program. Ms. Abreu then handed out maps to the Board to illustrate and focus in on this particular type of trail.

Vice Chair Kealoha said there was a motion and second on the floor to defer this item. Chairman is now declaring that this item be deferred until the next Kona meeting.

ISSUANCE OF RIGHT-OF-ENTRY FOR TEST BORINGS, HARBORS DIVISION, PIER 5

TO PIER 14, HONOLULU, OAHU (ALOHA TOWER ASSOCIATES (ATA))

After Mr. Garcia's presentation to the Board, Mr. Yuen asked if the results of the borings will be made available to the Department of Transportation. Mr. Garcia said, "Yes, they would be made available to DOT."

Mr. Earl Matsukawa, with the firm of Wilson Okamoto and Associates said they were on contract for the preparation of the Environmental Impact Statement for the project. Mr. Arne La Prade said he was working with Charles Pankow Builders doing construction of the project. They were both present to any questions that the Board might have.

To answer Mr. Arata's question, Mr. Matsukawa said EKS is Eric K. Smith Development.

Mr. Yuen moved for approval as submitted, second by Mr. Arata.

Mr. Garcia wished to amend the term to nine months.

ACTION Mr. Yuen amended his motion for approval with an amendment to term of 9 months instead of 6 months with extensions. Seconded by Mr. Arata.

DISCUSSION Mr. Kealoha asked Mr. Garcia if the request for right-of-entry was for submerged lands only and the ownership. Mr. Garcia answered that it was for submerged and fast lands. The fast lands were owned by the Department of Transportation (DOT) and every boring to be done is all within the executive order no. 1793 which is issued to the DOT Harbors Division.

Mr. Kealoha also asked if this Board issues right-of-entry to Harbor owned lands. Mr. Garcia responded that this was a form of a disposition.

Another concern regarding the borings on submerged lands, was whether it required a Conservation District Use Application (CDUA). Mr. Garcia felt it didn't require a CDUA because this particular executive order existed prior to 1964 and this is a government sponsored project. Mr. Kealoha's concern was that he did not see any comments from the Office of Conservation and Environmental Affairs and Office of Hawaiian Affairs. He would rather the Department of Transportation address these concerns Mr. Garcia felt He would rather the Department of Transportation address these concerns before going on or proceeding.

Mr. Arata said he had heard that construction had already started. Mr. Evans said no work has been done to the structure itself. There was some work done on grading but a prior CDUA allowed for the grading.

Ms. Marsha Freeman, Educational Director at the Kulani Correctional Facility spoke before the Board and informed them of all the proposed uses for the building.

CONSERVATION DISTRICT USE APPLICATION FOR SUBDIVISION INTO TWO LAND ITEM H-13 COURT PARCELS: APPLICANT: AUSTIN ESTATE TRUST

Mr. Evans wanted to make a modification on page 7 of the submittal, Condition no. 5 to make it clear by adding, "or any area in the Conservation District."

Discussion continued on the division of the parcel into the two portions and clarification on what and where applicant could build a house.

Mr. David Bills, Engineer with the firm of Gray, Hong & Bills Associates, also the agent for the applicant explained that in 1949, two tax map parcels were created, however it was never carried through and actually filed to get the lots separated through the Land Court. The Board was contacted to see if the subdivision could proceed without a CDUA. They were advised that a CDUA was required. A CDUA has been submitted to allow finalization of the subdivision which was previously requested in allow previously filed with the land Court. Subdivision boundary follows 1949, previously filed with the Land Court. Subdivision boundary follows the forest reserve boundary.

For clarification, both lots are in the Conservation District except for a small portion of the lower lot which is in the Urban District. The intent of the owners was that the upper lot not have any homes on it as it's in the forest reserve boundary as proposed. The owners have reviewed the conditions and they have no problems with the conditions. Regarding the modification to condition no. 5, they would agree with the concept of no home to be built in the upper lot. Although there is urban and in the lower lot, much of it is unbuildable as it lies in an area sceptible to floods.

Discussion followed to clarify the modification suggested by Mr. Evans to condition no. 5.

ACTION

Mr. Yuen moved for approval of item H-13 as submitted. Seconded by Mr. Arisumi, motion carried.

Mr. Apaka asked if applicant was asking for right-of-entry to the top of bridge or all the way to the forestry line. Mr. Evans understood they wanted to go all the way up but not all of that is in Conservation.

Mr. Ronald Matsumura, Land Surveyor with the County of Hawaii said in regards to the maintenance of the road, the County will assume maintenance for the one mile of the road.

Mr. Evans explained that the applicant was originally granted a CDUA permit to conduct the motorcycle ride on September 9, 1983 and subsequently on December 19, 1986. Each time the Division of Forestry and Wildlife Recreation reported there were no problems during and following the event.

Vice Chair Kealoha asked if any lands involved are ceded lands and if they had checked with the Office of Hawaiian Affairs. Mr. Evans said he did not know if any ceded lands were involved and would inform OHA as requested.

Mr. Dennis Vierra was present with his legal counsel Glen Dryer, who is also the Vice President of Rock Island Riders. Mr. Vierra made his presentation asking for the Board's review and approval for their 15th Annual Event. The last six years have been under the guidance of the Board through their CDUA.

In response to questions of the Board, he said that last year there were 105 applicants and so far this year they've received 88 applications. They provide lodging at the Mauna Kea State Park pavilion if they wish, others may go to nearby hotels. There have been a few injuries, couple broken ankles and broken legs but all applicants do use legal equipment and carry insurance. The club also carries under the American Motorcycle Association insurance, a \$1,000,000.00 Policy. In the 14 years there has been no suit. The average age of the participants is 45 years old. He explained how the race is conducted and the routes. This is not a speed race and the contestants must follow different speed rules or they are disqualified.

ACTION

Mr. Buck also wanted to modify his submittal by adding a pending request to the Division of Land Management for a water easement across Tract 2 and the Division of Forestry has no problem with that request.

Mr. James M. Greenwell, President of Palani Ranch Company and Mr. James S. Greenwell, Vice President said they were present to answer any questions of the Board. They have reviewed and agree with the submittal as presented. The senior Mr. Greenwell thanked the Board for deferring this matter to this meeting so that they were able to work out an agreement with staff that has some compromises on both sides. He also commended Mr. Buck and Mr. Charles Wakida of the Division of Forestry and Wildlife for the very excellent manner in which they worked out this problem. They have worked out their differences and both have made commitments and they intend to live up to theirs.

AMENDMENT TO REVOCABLE PERMIT NO. S-5566 TO HAWAIIAN ELECTRIC CO., INC., PUU MANAWAHUA, EWA, OAHU, TMK 9-2-05:14

Mr. Young reminded the Board that in January 26, 1990, a Conservation District Use Application (CDUA) was approved which would allow Hawaiian Electric to expand its facilities at Puu Manawahua, Ewa. As a result of the CDUA, the Division of Land Management has to come before the Board to amend the permit because of the increase of the area from 288 square feet to 1,420 square feet. Staff is recommending that the monthly rent be reopened, secondly that there is a third condition, that the transmission of video, voice and data communication by or for other Hawaiian Electric Industries subsidiaries shall be governed in accordance with all applicable PUC, FCC, Federal and State laws and rules and regulations.

The condition C. was the same condition which the Board had approved with respect to the tri-party agreement between the State of Hawaii-DLNR, hawaiian Electric and the Telecommunication Division in the Department of Budget and Finance with respect to Lanai, Haleakala, and Kaupulehu on the Big Island as part of the HITS program system.

Staff is recommending that the Board approve amending Revocable Permit No. S-5566 subject to the amendments provided to the Board this morning in the handout. (Copy of amendments to be placed in Departmental Board folder.)

Mr. Yuen moved to approve item F-7 as amended by staff's handout. Seconded by Mr. Arata, motion carried unanimously.

# ITEM H-12 APPROVAL OF DEVELOPMENT AGREEMENT FOR SAND ISLAND INDUSTRIAL PARK

Mr. Young said he was asked by Administration to present Item H-12 to the Board this morning.

Each member of the Board voiced criticism and objection to receiving a copy of the development agreement on the date of the meeting, and also to the 'draft form' which was presented to them. Specific comments were are follows:

Requested that the Board be briefed by Deputy Fukumoto and Deputy Attorney General Wong prior to next Board meeting.

Objected to having the department collect and reimburse SIBA of all delinquent assessment on infrastructure development listed on Page 8, #6 and Page 7, #8.

Insurance requirement has to be beefed-up to include hazard, performance bond, liability and flood clauses.

Objected to SIBA having a voice in commercial center, Page 5, #5 and in providing SIBA the right to develop commercial center, Page 4, #14.

Inquired whether Bank of Hawaii reviewed development agreement and whether they were going to come in with additional comments.

Mr. Kealoha said that at the last Board meeting, the board had agreed to a Memorandum of Understanding for the development of Sand Island and the Board has moved in their favor. Subsequently they were of the understanding that they would have a chance to review: 1. The Developer's, Development Agreement as they're proposing to the Board; also the appraiser would be mutual to the hiring to have the place appraised; and 2. There would be some sort of review period before this item would return to the Board, if not, this meeting then a subsequent meeting would be scheduled for the 27th of April. If there is a time constraint to act then the Board would act favoring their own agreement rather than a review of two agreements. So far the staff, whoever was negotiator for the State in dealing with Sand Island has not done a good job.

Mr. Arisumi asked what was the time constraint and urgency.

Mr. Edgar Hamasu, Executive Director of the Sand Island Business Association, answered that the urgency is the fact that the SIBA is already effective March 1, 1990 and has been assessing the 116 tenants. Fortunately, they've been very supportive. Out of the 116 they have 6 that have held out but all others have contributed what they've been assessed and are hoping that the Development Agreement could be approved today.

Mr. Arisumi said he had a problem. The staff at the Department of the Attorney General's office had reviewed the Development Agreement and with the staff handling the negotiations to conclude negotiations. There are a lot of questions as they are not attorneys and he would like to question Mr. Wong on some of these understandings. Also having only gotten a copy this morning he would like to defer this matter to the April 27th meeting.

DEFERMENT Mr. Arisumi moved that this matter be deferred to the April 27, 1990 meeting. Seconded by Mr. Apaka, motion carried..

Mr. Hamasu wanted to thank the Board as its been a trying experience for all involved, also the Attorney General. He will accept the fact that it has to be deferred.
