### ITEM H-3 LENDRA AND DR. ROBERT D. SCOREN

ITEM K-3

Mr. Evans testified that the County of Hawaii informed staff that the applicant needed a Special Management Area (SMA) permit. Applicant was informed if the SMA permit was not obtained within 30 days prior to the 180-day expiration date, then negative action would be taken by the Board. To date an SMA permit has not been obtained and staff is recommending that the Board defer this item.

Ms. Leslie Lendra, applicant stated that the County of Hawaii has said that they are in the process of issuing the SMA permit. The County informed them because they have the small subsistence farm, they will probably require a minor permit and that's why it's taking a little longer. She has received indication from the County that this will probably be done before the next Board meeting of July 8, 1994. She understood why this would need to be deferred.

Ms. Lendra informed that Board that due to a prior scheduled business trip she would be on the mainland on July 8 and if there are any questions by the Board she would try to answer them today.

Mr. Evans also pointed out that the subsistence farming would be strictly for the family's use. If there were to be commercial resale, then the CDUA would be required to go to a public hearing.

**DEFERRED** Ms. Himeno moved to defer, seconded by Mr. Kennison motion carried unanimously.

CONSENT TO AFFILIATION AGREEMENT AFFECTING HARBOR LEASE HO. H-87-30, PIER 7, HONOLULU, HARBOR, OAHU (ATL, INC. AND HAWAII MARITIME CENTER)

Mr. Garcia made the presentation of Item K-3. He asked that a condition

9 be added to read, "This consent is for the berthing of the Abner T. Longley within submerged areas covered by Harbor Lease No. H-87-30 to Hawaii Maritime Center at Pier 7. The loading and unloading of passengers at Pier 7 shall require the prior written approval of the Director of Transportation and the oral approval of the Board of Land and Natural Resources."

Chairperson Ahue asked for an explanation of the request for an oral approval.

Mr. Garcia explained that they would accept the oral motion and action at today's meeting as the "oral approval."

Mr. Rick Rainalter, one of the Hawaiian partners of the Aloha Tower Associates said that he was present to inform the Board about fireboats. He used enlarged photos of the area and of the two fireboats. He said that the boats will be used in educating the children, visitors and the community about the history of the harbor.

Mr. Rainalter said that an agreement has been put together with the Hawaii Maritime Center who is represented by Admiral Kozlovsky, their executive director, to use the vessel for this purpose.

Admiral Kozlovsky did not have anything else to add.

REQUEST APPROVAL TO ENTER INTO A MEMORANDUM OF UNDERSTANDING FOR THE CREATION OF AN ADOPT-A-TRAIL PROGRAM WITH THE HAWAII EQUESTRIAN TRAIL ASSOCIATION IN THE MAINTENANCE OF THE MAUNAWILI DITCH TRAIL

Before his presentation, Mr. Buck on behalf of the Division of Forestry and Wildlife thanked Ms. Sharon Himeno for all her support during her tenure as a board member and wished her well.

Mr. Buck informed the Board that this program was a pleasure when a community group can participate and go into partnership with government to help manage public resources. He said that this was a two year agreement with the Hawaii Equestrian Trail Association (HETA) where the equestrian association will help maintain the trail three times a year, help restore portions of the trail and police and inform the community about appropriate uses of the trail. The department will provide assistance. The agreement does not provide for exclusive use of the trail as it's a multi use trail. There is a wide range of community interest in using the trail and because equestrian use is really advancing in Waimanalo, staff feels it appropriate to bring it forward for Board

approval.

Mr. Tony Ornellas, President of HETA said that they are looking forward to working on this trail. They appreciate the opportunity and feel that their community should be part of its own restoration and caretaking.

Mr. Evans began his presentation by saying that two weeks ago on Kauai, the Board came to a decision and because of the time frame this item is back on the agenda. There were several persons who had an important interest in the judgement and what the recommendations would be. The interested parties were contacted by staff yesterday and this morning prior to the board meeting, notwithstanding the nature of this matter to be distributed, he felt in fairness, at least to the Hawaii's Thousand Friends and Office of Hawaiian Affairs (OHA) be given a copy of the submittal so that they could prepare their testimony. A copy was also given to Haseko.

Mr. Evans then presented a background of what had transpired at the Board meeting held on Kauai on June 9, 1994.

Staff is before the Board this morning on behalf of two requests for intervention status. At the Kauai Board meeting the Deputy Attorney General at that time said the standard that would be applied would be the same standard that was applied relative to the State's Administrative Procedures Act. As a result and in keeping with that standard, once the department received those requests, there were three elements. Basically one of the elements was, those written materials submitted by the two parties individually, one Hawaii's Thousand Friends and OHA. The second element was a staff review and third element was a review by the Department of the Attorney General. Considering these elements, staff's recommendation is that the Board deny both Hawaii's Thousand Friends, intervenor status, as a party and OHA as a party. Relative to OHA, there is one caveat that he wanted to make clear and that is notwithstanding their recommendation, any action that the Board takes today relative to the question of OHA, not be considered precedent. In terms of the staff recommendation or the board's action for future actions or requests by OHA. He clearly wanted to make it known that the recommendation today is based on strictly a conservative approach

to the process, this particular issue, their particular written material relative to this particular issue and nothing one way or the other in any form relative to any future issues.

Ms. Yvonne Izu, legal counsel to Haseko testified that yesterday they filed a brief statement in opposition to OHA's petition to intervene. They did not file a subsequent statement in opposition to Hawaii's Thousand Friends because the Friends submitted the same petition that they did the first time around and they filed a statement of opposition to that and asked that the Board consider their prior statement because they didn't add anything new. One thing that she would like to comment on and it was brought up at the last meeting on June 9th, that Hawaii's Thousand Friends had indicated a TMK of one of their members which would give them standing. They checked the TMK and realized that it was Haseko's TMK. She assured the Board that Haseko is not a member of Hawaii's Thousand Friends.

Ms. Donna Wong of Hawaii's Thousand Friends declined to testify.

Ms. Sheryl Nicholson testified on behalf of OHA. She stated that Mr. Evans was correct that OHA had previously petitioned this Board for status as a party for the contested case hearing on Haseko's CDUA. It was denied by this Board because 1) the Board concluded that OHA had not timely requested a contested case hearing and 2) because OHA lacked standing. There were no reasons that were given for the Board's conclusion that OHA lacked standing under the Hawaii Administrative Rules to be a party to the contested case hearing. OHA is now bringing in a petition to intervene in the contested case hearing that the Board has decided to hold on the CDUA and as Mr. Evans in his staff recommendation has acknowledged that OHA's petition is different in several significant respects from its previous petition to become a party in the contested case. She stated that she just wanted to focus on one aspect of the petition and that is that OHA, under Section 13-1-31, A3 under the Hawaii Administrative Rules must be made a party to this contested case proceedings because it is a party that has an interest that will be directly and immediately affected by the proposed change. That OHA's interest is distinguishable from the general public at large.

Ms. Nicholson testified that OHA's interest in enforcing Section 5F of the Hawaii's Admission Act, which limits the uses to which ceded lands, which are part of the public land trust, may be used. Section 5F says that these lands may only be used for certain enumerated purposes, among which the betterment of conditions of native Hawaiians. Sec. 5F also says that any other use, not enumerated in the section will constitute a breach of trust for which action may be brought. OHA's position based on what is ceded in the CDUA is that this application proposes a use of ceded lands which is subject to Sec. 5F and is a breach of that

trust. OHA is statutorily charged as being the advocate on behalf of Hawaiians and native Hawaiians. Specifically and in instances such as this, where proposed governmental action will affect, impact the rights of Hawaiians and native Hawaiians, as an entity under the Pele Defense Fund case, it has the right to advance the interest of the Hawaiians and native Hawaiians in insuring that breach of the land trust and Sec. 5F does not occur. It is for this reason that OHA has standing and has specific interest and distinguishable from the public at large which will be impacted by the proposal of the CDUA. It's on this basis that OHA suggests and argues that is a mandatory party under the Hawaii Administrative Rules, Subsection 18.

She said that she did have a chance to take a look at the staff recommendation that OHA's petition for intervention be denied. She noticed that it refers that OHA lacks standing but there are no reasons given.

Mr. Evans responded relative to three things Ms. Nicholson brought up. Firstly she brought up Section 13-1-31, secondly Section 5F, thirdly the Pele Defense Fund. Mr. Evans stated that he could represent to the Board that these three elements among others were reviewed prior to the formulation of staff's recommendation which is before the Board this morning. On the question of intervention as opposed to party, OHA's petition was timely.

### Executive Session

Upon motion by Ms. Himeno and a second by Mr. Kennison, the Board went into an executive session to consult with legal counsel.

Chairperson Ahue called the regular meeting back to order.

#### MOTION

Mr. Nekoba made a motion to amend staff's recommendation to allow OHA to participate as an intervenor in the contested case hearing based on the new information provided since the Kauai meeting and because OHA would be able to contribute information and resources that would assist the Board in making a decision on this contested case. However, this decision is not based on OHA's claim on Section 5F and he recommended that the Board deny the Hawaii's Thousand Friends petition because of no new information provided since the Kauai meeting. Motion was seconded by Mr. Kennison.

#### DISCUSSION

Mr. Evans offered clarification as he understood that the action by the Board today will not or is not intended to alter the time frame that staff has set up relative to hearing the scheduled contested case hearing. This would mean that staff will meet with representatives from OHA to explain the schedule for the contested case hearing and staff's expectation is that they will fall into line along with the previous parties that the Board has admitted.

Deputy Attorney General Wong recommended that OHA through its representative be required to make a statement that they agree to comply with the proposed schedule so that they won't request extension and delays.

Ms. Nicholson stated that she was not familiar with the time deadline but her understanding is that they would not have a problem complying with that. She would welcome the opportunity to work with the department's staff to make sure that they will have enough time. To be candid, she stated that she's not familiar with the time constraints.

Mr. Evans explained that they would meet with the OHA representative (in terms of staff, they are in ex parte situation) for the public record they would be meeting with the OHA representative to explain the process, where they are in the process and to answer any procedural questions only on this issue.

Ms. Himeno stated that she thought that this was a major consideration of the Board as far as being able to keep the existing schedule and not create a delay allowing OHA their intervention. She believed that OHA had something to contribute but it has to be weighed against the fairest to the existing parties.

Ms. Nicholson asked for clarification, "I understand the basis of permitting to intervene under this motion is not 5F. Now does that preclude OHA at the contested case hearing from offering testimony or raising any issues that are based on Section 5F?"

Deputy Attorney General Wong stated that it was a separate legal issue.

Chairperson Ahue stated that he supposed they could raise questions that could relate to the application but he felt the Board's point is that we are not agreeing to standing based on Section 5F.

Mr. Evans stated that he could go over those kinds of questions, procedural issues with the OHA representative.

**ACTION** Chairperson Ahue called for the question and motion carried unanimously.

REQUEST TO USE THE IOLANI PALACE GROUNDS FOR A 100TH THE ANNIVERSARY OBSERVANCE OF THE INAUGURATION OF REPUBLIC OF HAWAII

Mr. Nagata presented the request by the Friends of Iolani Place to use the palace grounds on July 4, 1994 to conduct a program to mark the 100th anniversary of the inauguration of the Republic of Hawaii. The Friends tentatively include the erection of a stage in front of the Iolani Palace Steps. Speeches, historical readings, re-enactments and other commemorative activities are envisioned on the stage or elsewhere on the palace grounds. The Hawaiian flag will be flown at half mast in recognition of the prior actions having a devastating effect on the Hawaiian people. Other Hawaiian organizations, while not requesting a permit, have expressed an interest in utilizing the palace grounds or the Iolani Palace steps to conduct related activities.

Mr. Nagata stated that the Friends are willing to erect the platform to avoid the use of the security monitored steps and have further indicated they are willing to work with the groups who have indicated interest to present a meaningful program. Staff is recommending that the Board approve the Friends of Iolani Palace request subject to various conditions listed in the submittal. He informed the Board that Ms. Betty Lou Stroup and Mr. Elia Long from the executive committee of the Friends were in the audience today.

Mr. Long testified that they would like two changes to their application. 1) They would like to have the permit limited from 6 a.m. to 10 a.m. that morning. That would be approximately the length of their presentation. The permit not to cover the entire day at the palace. 2) They decided not to erect a platform but would give their presentation at the base of the steps of Iolani Palace.

Staff's difficulty and concern is speculation in the conservation district.

Ms. Himeno stated that her only concern is whether condition no. 1 should be included. The Board could approve the extension for one year and if they don't do that, then automatically the permit is null and void.
