**Item 1.** Briefing on Papahanaumokuakea Marine National Monument Management Plan, EA, and Associated Documents to the Board of Land and Natural Resources. *To be distributed.* 

This is an informational briefing of the Board of Land and Natural Resources, non-action item, public meeting. Materials were submitted.

Chair Thielen has to leave and Member Johns will leave early. They have met on this.

Ms. Athline Clark representing Division of Aquatic Resources asked everyone to introduce themselves and presented the following.

#### Materials

Hard copies and CDs of four volumes of the Draft Monument Management Plan were distributed to the Board. Volume one will be discussed today.

### **Slide Presentation**

### <u>Introduction – Background History</u>

A key component of Bush's Proclamation is to develop a Monument Management Plan based on a draft plan that was originally developed for the Northwest Hawaiian Islands National Sanctuary process. The 3 agencies involved are the State, NOAA and Fish & Wildlife Service. The Monument Management Structure was created by a Memorandum of Agreement. There are 3 components. First is the Senior Executive Board. This MOA was signed by the Governor, the Secretary of Commerce and the Secretary of Interior. The Monument Management Board has representatives of the co-trustees and the Office of Hawaiian Affairs (OHA) where there are two members from NOAA, Fish & Wildlife and the State. There is an inter-agency coordinating committee which is made up of other state and federal agencies.

History regarding Midway Atoll, U.S. Coral Reef Task Force, Coral Reef Ecosystem Reserve, scooping, and additional comments from the public in regards to the sanctuary plan. The sanctuary plan had a 5 year time horizon while this management plan has a 15 year horizon with revisions every 5 years. It merged aspects of Fish & Wildlife requirements including comprehensive conservation planning, compatibility determinations for wildlife first for all of the Fish & Wildlife refuge areas, all of the sanctuary planning processes, all the NIMPS requirements, State of Hawaii liens and referenced all other plans. Susan White explained that some things are at a programmatic level and others are more specific which is the best median they could come up with.

Volume 1 is the Draft Monument Management Plan, Volume 2 is the Environmental Assessment and associated Cultural Impacts Assessment, Volume 3 is the Draft Midway Services Plan and Volume 4 is the Conceptual Site Plan for Midway because Midway is the window to the Monument. More background was given on each volume.

### B. Preliminary Summary with the Board – Athline Clark

- 4. Staff will come back to the Board for the Board's recommendations for approval on the Management Plan.
- 5. September or October to the Governor for final decision.

The Board asked the number of comments received so far which were 6.

Also how does staff feel about it? Ms. White opinioned it isn't a perfect plan given the amount of time, but it is comprehensive. Ms. Clark added this is why the need for public comment.

The Board queried whether there will be an advisory counsel or an alliance where there could be a lot of input. What is the science based research, what is the permitting process and those might have differences of opinion between the co-trustees. Ms. Wilhelm referred to Appendix 3 for comment. Ms. Clark: This is not complete for the 15 year period and gave Midway as an example. They can't predict global warming situation and will reassess every 5 years. Ms. Wilhelm: There is a step-down plan with an overview of the process and then the public process.

The Board approves of this process and summarized. Ms. Clark suggested referring to the history. Member Johns recommended Member Gon focus on issues of the science plan, permitting issues and how the public will participate in management and/or evaluation/monitoring of the monument as this goes forward. Also because the co-trustees agree as proposed doesn't mean the Board gives up their obligation to decide whether the State resources, protected constitutionally or otherwise, are adequately protected in the plan. The Board's perspective is different from that of the public. Ms. Wilhelm referred to Chapter 2 which is the management framework. She understands the having a co-trustee group is unusual and the Board is part of it. Member Johns: Federal doesn't have the same obligation to protect native Hawaiian interests. Member Gon: There is specific focus in today's presentation. Ms. Clark: A native Hawaiian group assisted in development. Ms. Heidi Guth: OHA was very much involved.

There being no further business Member Tim Johns adjourned the briefing at 4:21 p.m. The recording and all written testimony submitted for the briefing was filed in the Chairperson's Office and are available for review.
