## **REQUEST**:

Issuance of a direct lease to the State of Hawaii, Department of Defense, Hawaii Army National Guard (HIARNG), to develop a central aircraft wash-fuel in support of HIARNG's plans to relocate units and construction projects to the Kalaeloa Hawaii Army National Guard Facility, located at Kalaeloa Airport, Oahu, State of Hawaii.

# **CURRENT USE STATUS:**

At its meeting of September 9, 2011, the Board of Land and Natural Resources, under Agenda Item M-4, approved setting aside this parcel of land and recommended issuing a Governor's Executive Order (GEO) to the State of Hawaii, Department of Transportation, Airports Division (DOTA) for Airport purposes. By memo (AIR-PM 12.0258) dated April 17, 2012, the issuance of the GEO is pending.

## **CHARACTER OF USE:**

Planned site of HIARNG's central aircraft wash-fuel facility.

## **TERM OF LEASE:**

Thirty (30) years.

## LEASE COMMENCEMENT DATE:

Upon execution of the lease document

#### LEASE RENTAL:

Nominal rent in accordance with Airports Division Procedures No. 4.5 (Schedule of Rates and Charges).

#### CHAPTER 343, HRS - ENVIRONMENTAL ASSESSMENT:

The subject area is covered by the Final Environmental Assessment (EA) dated August 2010 for the Relocation of Units and Construction Projects at the Kalaeloa Hawaii Army National Guard Facility. The Finding of No Significant Impact dated August 11, 2011, analyzed the EA and found that the proposed action by HIARNG would result in no

> significant adverse impacts from noise, hazardous wastes and materials, or airspace operations.

## **REMARKS:**

The Department of Transportation proposes to issue a direct lease to HIARNG, for the purpose of developing a central aircraft wash-fuel in support of HIARNG plans to relocate units and construction projects to its Kalaeloa Hawaii Army National Guard Facility, located at Kalaeloa Airport. The DOTA, in the public interest, has no objections to the issuance of this lease.

## **RECOMMENDATION:**

That the Board authorize the Department of Transportation to issue a direct lease to the HIARNG, subject to: (1) terms and conditions herein outlined, which are by reference incorporated herein; (2) such other terms and conditions as may be prescribed by the Director of Transportation to best serve the interests of the State; and (3) review and approval of the Department of the Attorney General as to the lease form and content.
