Land presently encumbered by multiple Governor's Executive Orders setting aside in total 1,245.034 acres designated as Hilo International Airport under the control and management of the Department of Transportation, Airports Division, State of Hawaii, for Airport purposes.

CHARACTER OF USE:

Operation of rental car concession.

TERM OF LEASE:

Lease No. DOT-A-09-0060, commenced on July 1, 2009 and expires on May 31, 2014.

Lease No. DOT-A-09-0061, commenced on July 1, 2009 and expires on May 31, 2019.

CONSIDERATION:

Zero. Assignment of Lease is required by the United States Federal Trade Commission to maintain competition among rental car concessions at various airports.


REMARKS:

Hertz Global Holdings, Inc. (Hertz) recently acquired Dollar Thrifty Automotive Group, Inc. The United States Federal Trade Commission conditioned its approval of the acquisition on Hertz's agreement to (i) divest its Simply Wheelz LLC subsidiary which operates the Advantage brand to an entity capable of successfully expanding the operation of that brand, and (ii) ensure that the buyer of Advantage will have the right to operate that brand on-airport at certain additional locations indentified by the FTC, including Hilo International Airport.

RECOMMENDATION:



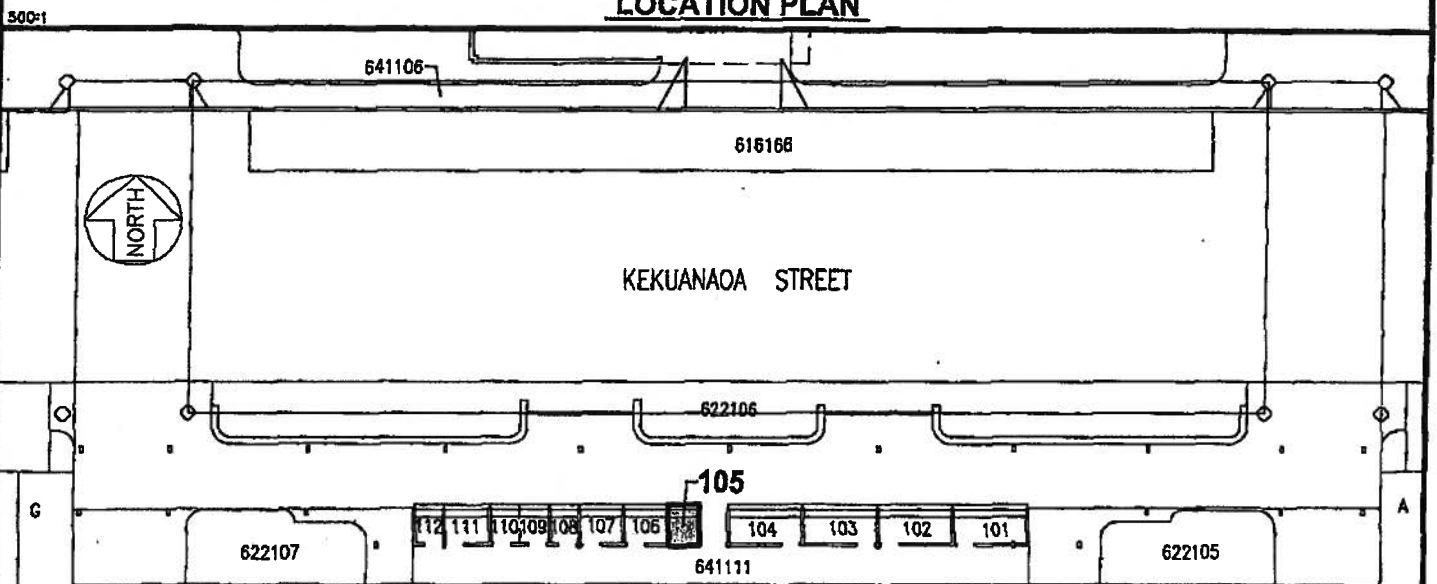

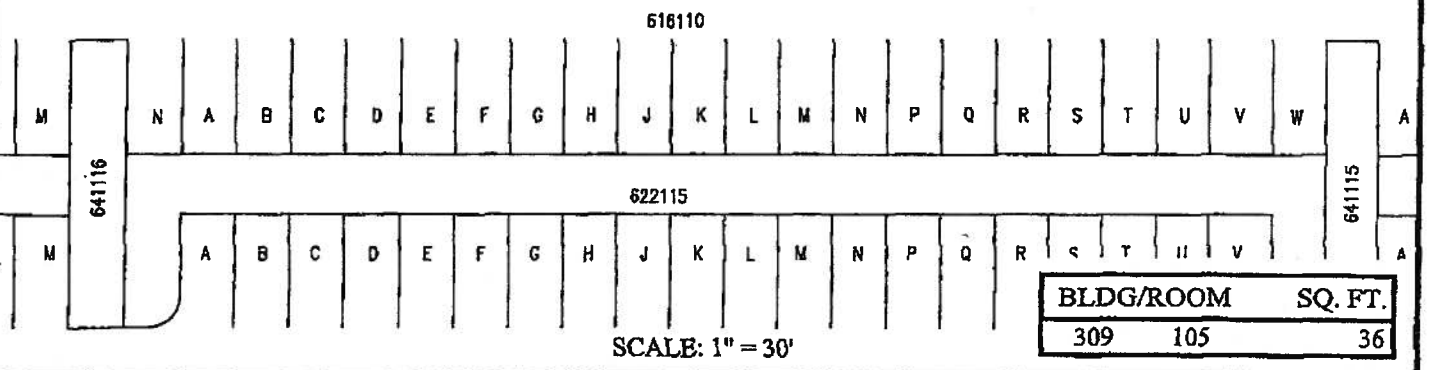
