

This exemption is appropriate because the permittee, Kauai Bodyboarding Association has requested the use of a small area for judges tents. The location has been used periodically for such uses in recent years without significant impact on the environment.

The grant of a right-of-entry permit for the limited purpose will result in no material change or significant cumulative impact. If further actions are taken that result in a material change, Kauai Bodyboarding Association will be required to be in compliance with Chapter 343.

Recommendation:

It is recommended that the Board find that the issuance of a rightof-entry permit to Kauai Bodyboarding Association will probably have minimal or no significant effect on the environment and is presumed to be exempt from the preparation of an environmental assessment.
