In accordance with the "Exemption List for the State of Hawaii, Department of Land and Natural Resources, as Reviewed and Concurred Upon by the Environmental Council (Docket 91-EX-2, December 4, 1991), the subject request is exempt from the preparation of an environmental assessment pursuant to Exemption Class No.1, "Operations, repairs or maintenance of existing structures, facilities, equipment or topographical features, involving negligible or no expansion or change of use beyond that previously existing [HAR § 11-200-8(a)(1)]."

REMARKS:

In April of 2013, The department was approached by both the County of Maui, Department of Environmental Management, Wastewater Division and its contractor, Hawaiian Dredging Construction Company, to request a right-of-entry to government lands situate adjacent to the Kahului Wastewater treatment facility for storage purposes. The intent is to allow for storage of materials related to an ongoing sewer line replacement project. The project is anticipated to continue for about six (6) months but maybe extended, as needed, to complete the replacement project.

The existing site is encumbered by Governor's Executive Order No. 3694 to the Department of Land and Natural Resources for Forestry and Wildlife related purposes.

Staff is recommending consideration to the State in the form of land maintenance services to be conducted by Hawaiian Dredging Construction Company in support of Forestry and Wildlife program initiatives. Hawaiian Dredging has agreed to clear cut introduced and invasive plant and tree material encumbering over five (5) acres at no cost to the State. The proposed maintenance is valued at \$3,000 per acre. Pursuant to the land clearing, DOFAW will be re-introducing native species to the area as needed to encourage development of a landscape indicative of a coastal dune and wetland habitat similar to what is observed in the nearby Kanaha pond area.

RECOMMENDATION: That the Board

1. Declare that, after considering the potential effects of the proposed disposition as provided by Chapter 343, HRS, and Chapter 11-200, HAR, this project will probably have minimal or no significant effect on the environment and is therefore exempt from the preparation of an environmental assessment.
2. Authorize the issuance of a right-of-entry permit to Hawaiian Dredging Construction Company covering the subject area under the terms and conditions cited above, which are by this reference incorporated herein and further subject to the following:
  - A. The standard terms and conditions of the most current right-of-entry permit form, as may be amended from time to time;
  - B. Such other terms and conditions as may be prescribed by the Chairperson to best serve the interests of the State.
  - C. Authorize the Chairperson to issue future right-of-entries to the applicant in relation to its use of the subject government lands for storage purposes.



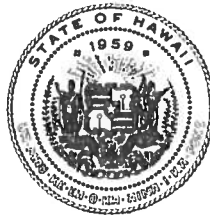

**Project Title:** Issuance of Right-of-Entry Permit to Hawaiian Dredging Construction Company onto Government Lands Encumbered by EO No. 3694 for Temporary Storage Purposes.


**Project Location:** Kahului, Maui; TMK (2) 3-8-001: 019 por.


**Project Description:** Applicant shall use government lands for temporary storage purpose related to the implementation of a County of Maui, Department Environmental Management, Waste Water Division sewer line replacement project. As consideration to the State of Hawaii for the use of Government Lands, the applicant has agreed to perform land maintenance activities in support of Forestry and Wildlife land restoration activities on site at no cost to the State. The value of the proposed land maintenance is estimated to be \$15,000.

**Consulted Parties:** DLNR – Division of Forestry & Wildlife; and the County of Maui, Mayor's Office and Department Environmental Management, Waste Water Division

**Exemption Class No.:** In accordance with the "Exemption List for the State of Hawaii, Department of Land and Natural Resources, as Reviewed and Concurred Upon by the Environmental Council (Docket 91-EX-2, December 4, 1991), the subject request is exempt from the preparation of an environmental assessment pursuant to Exemption Class No.1, "Operations, repairs or maintenance of existing structures, facilities, equipment or topographical features, involving negligible or no expansion or change of use beyond that previously existing [HAR § 11-200-8(a)(1)]."

**Recommendation:** It is recommended that the Board find that the issuance of a Right-of-Entry to Hawaiian Dredging Construction Company will have minimal or no significant effect on the environment and is presumed to be exempt from the preparation of an environmental assessment.
