APPLICANT REQUIREMENTS:

- 1. Provide survey maps and descriptions for the subject easement, according to State DAGS Survey Division standards, at Applicant's own expense.
- 2. Obtain designation of easement approval from the Department of Planning and Permitting of the City and County of Honolulu.

REMARKS:

The subject request is part of a project to upgrade the schools' network system with fiber cable connectivity. Oceanic Time Warner Cable LLC was selected by the Department of Education ("DOE") to complete the proposed cable work.

The subject project involves connecting a fiber optic cable line from a pole on Lanakila

Avenue to a classroom building located at the Lanakila Elementary School. The new cable line will cross above and overhead of the Lanakila Park which has been set aside to the City and County of Honolulu, by Governor's Executive Order 2939 for public park purposes.

According to the DOE, the communication cable line will be for their exclusive use only.

Pursuant to 171-95(b)(1), HRS, which provides, "[t]he sale price or lease rental shall be no less than the value determined in accordance with section 171-17(b); provided that such sale price or lease rental may be on a nominal basis, if the board finds that such easement is required in connection with a government project", applicant requests the easement be issued at gratis consideration as this is a government project. Staff has no objection to the request for gratis consideration.

The Department of Parks and Recreation has no objections concerning the subject request. See their response attached as **Exhibit 3**.

The Department of Facility Maintenance has no objections to the subject request but notes the existence of a storm drain line and grating improvements that form a connection from Lanakila Avenue to North Kuakini Street, along the proposed alignment of the subject cable easement. Staff do not forsee any potential problem(s) that will be caused by the alignment of the proposed subject cable easement since the cable line will pass above and overhead of the Lanakila Park.

The Department of Health has no comments regarding the subject request.

The Board of Water Supply had no objections nor comments regarding the subject request.

The State Historic Preservation Division, Department of Planning and Permitting and the Office of Hawaiian Affairs had not responded as of the requested date.

The Applicant has not had a lease, permit, easement or other disposition of State lands terminated within the last five years due to non-compliance with such terms and conditions.

Staff is unaware of any further pertinent issues or concerns regarding the subject request and have no objections to it.

Staff now brings this request to the Board for its approval.

RECOMMENDATION: That the Board:

1. Declare that, after considering the potential effects of the proposed disposition as provided by Chapter 343, HRS, and Chapter 11-200, HAR, this project will probably have minimal or no significant effect on the environment and is

therefore exempt from the preparation of an environmental assessment.


- 2. Authorize the issuance of a perpetual non-exclusive easement to Oceanic Time Warner Cable LLC covering the subject area for cable communication purposes under the terms and conditions cited above, which are by this reference incorporated herein and further subject to the following:
 - A. The standard terms and conditions of the most current perpetual easement document form, as may be amended from time to time;
 - B. Review and approval by the Department of the Attorney General; and
 - C. Such other terms and conditions as may be prescribed by the Chairperson to best serve the interests of the State.
- 3. Issuance of a construction and management right of entry permit to Oceanic Time Warner Cable LLC covering the subject area for cable communication purposes under the terms and conditions cited above, which are by this reference incorporated herein and further subject to the following:
 - A. The standard terms and conditions of the most current right of entry document form, as may be amended from time to time and
 - B. Such other terms and conditions as may be prescribed by the Chairperson to best serve the interests of the State.
