
REMARKS:

RECOMMENDATION:

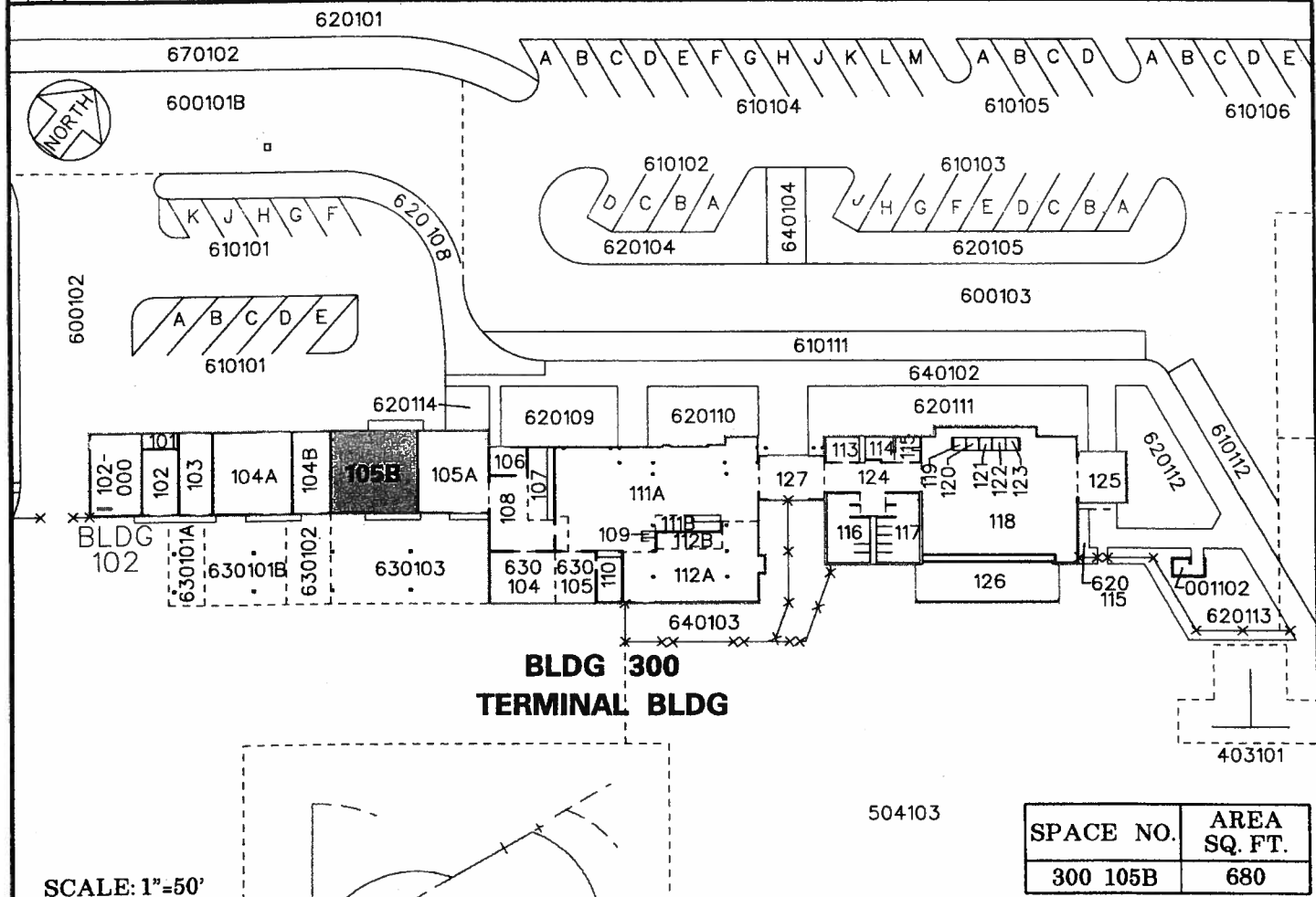
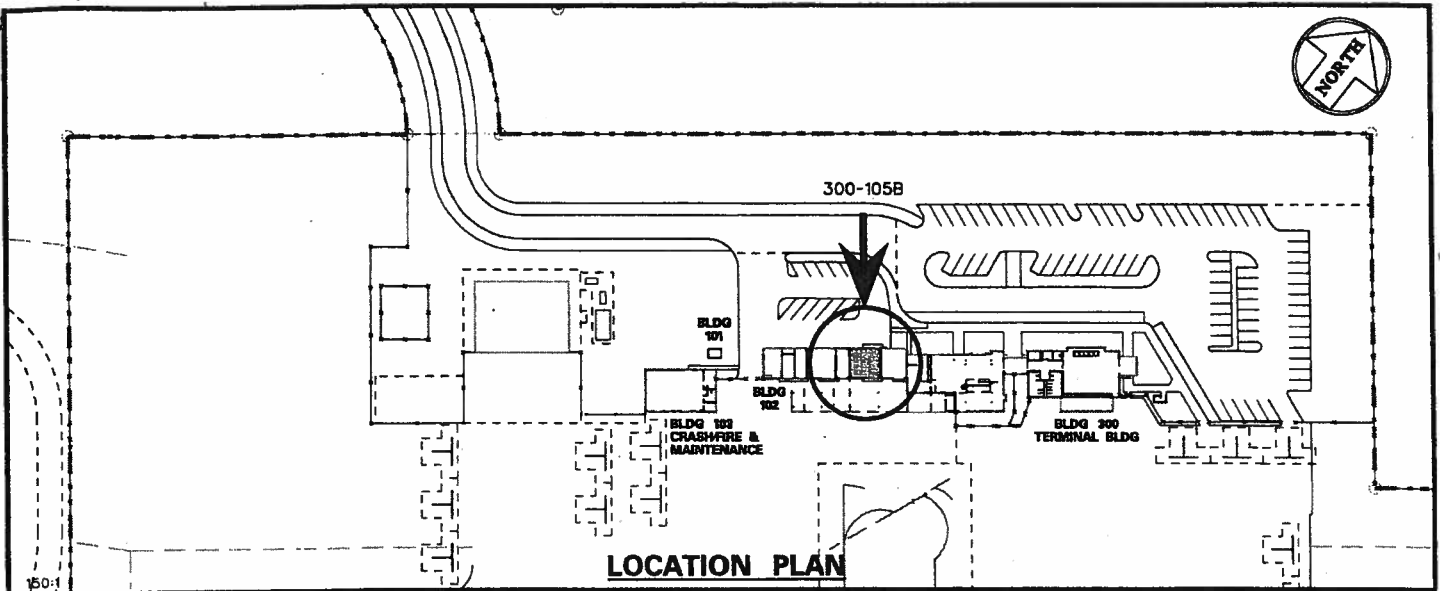
