RECOMMENDATION:



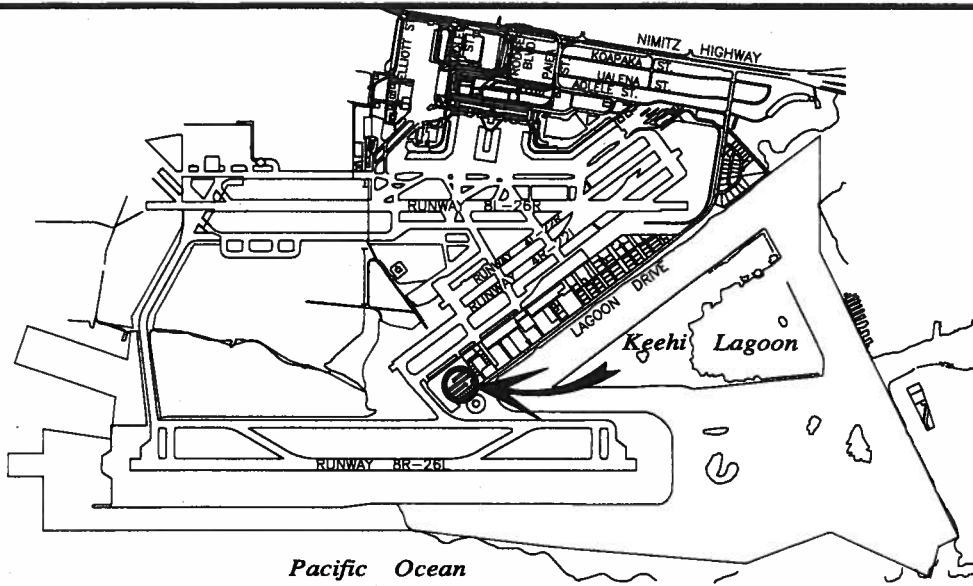
