RECOMMENDATION:



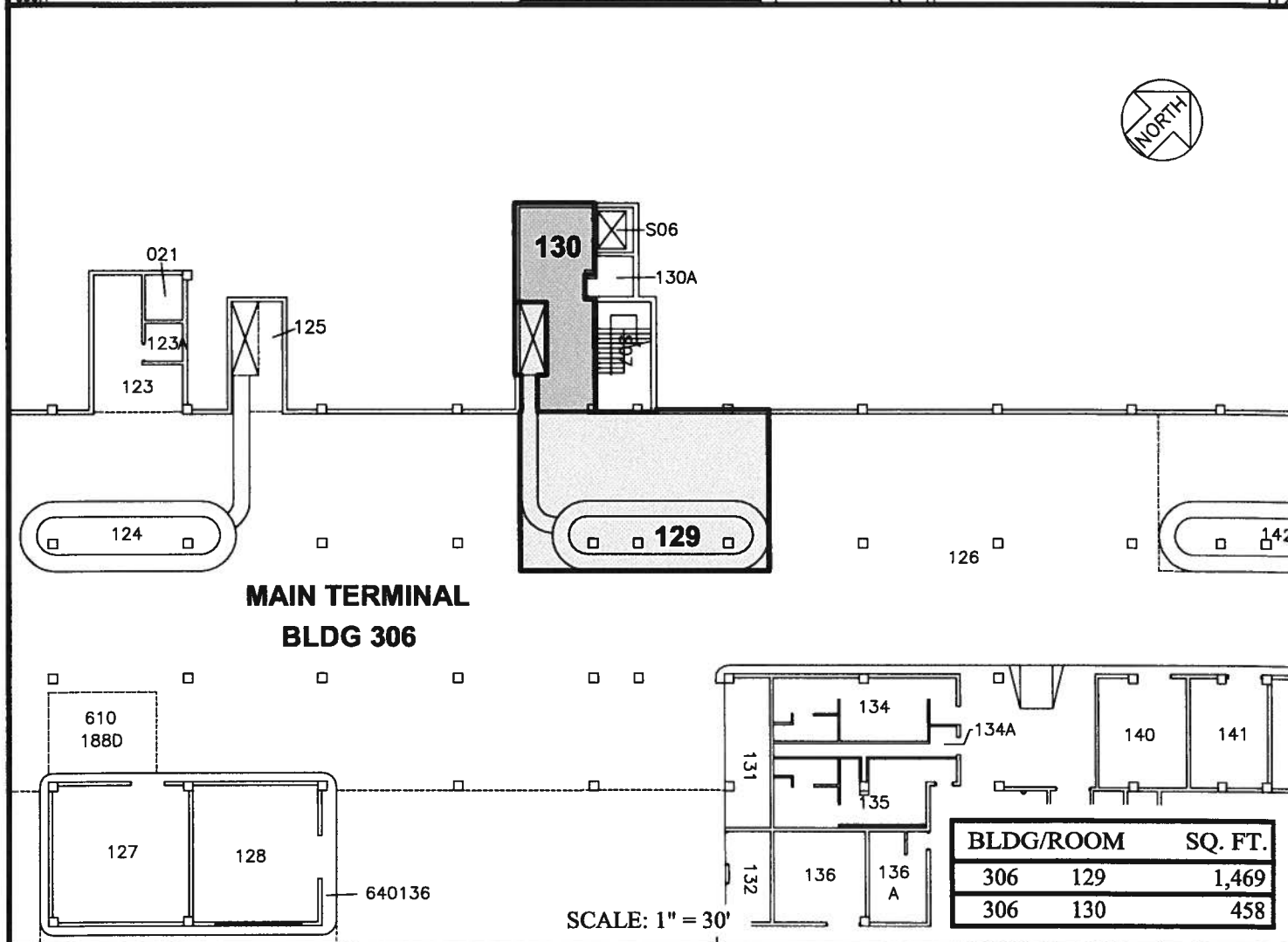
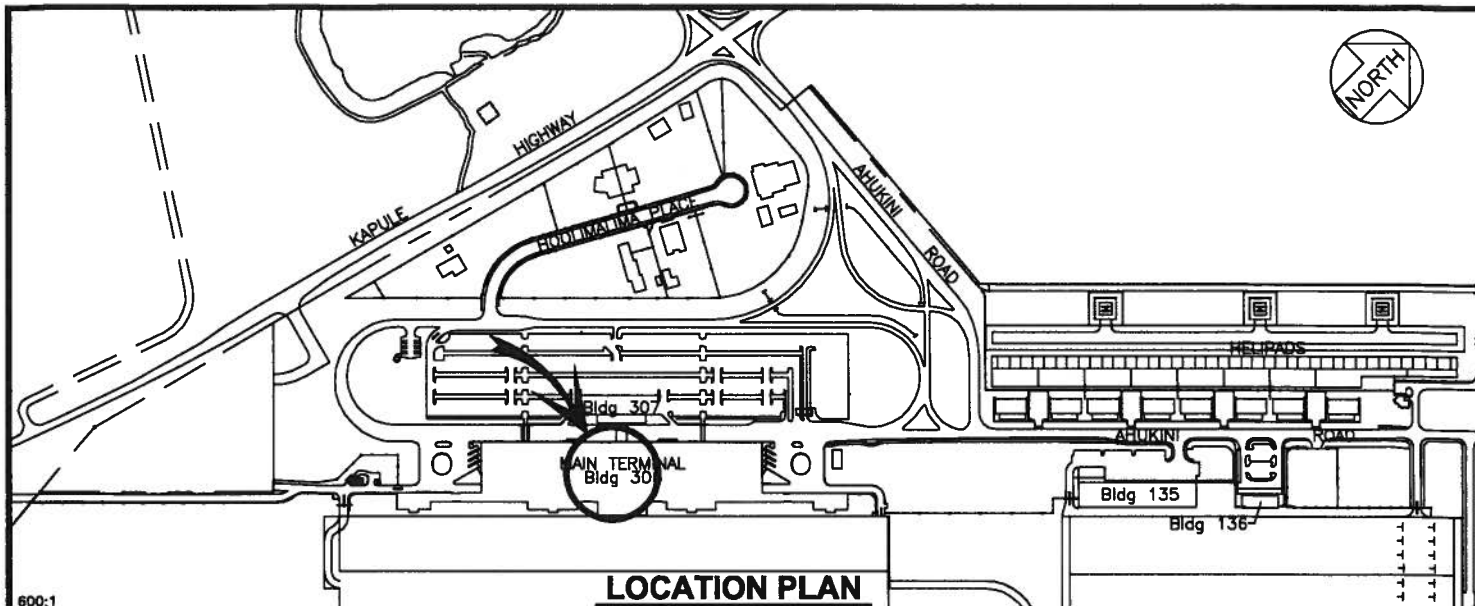
