CHAPTER 343, HRS - ENVIRONMENTAL ASSESSMENT:

As stated within State Project No. AO1021-24, Runway 4L Edge Lighting Project at Honolulu International Airport, Item 1.4 Provisions for Field Office/Storage Space: “Pending the availability of space on airport property, the State will issue a permit to the Contractor for the use of the space, at no charge, to be used specifically for a field office and/or storage of materials and equipment...”


RECOMMENDATION:

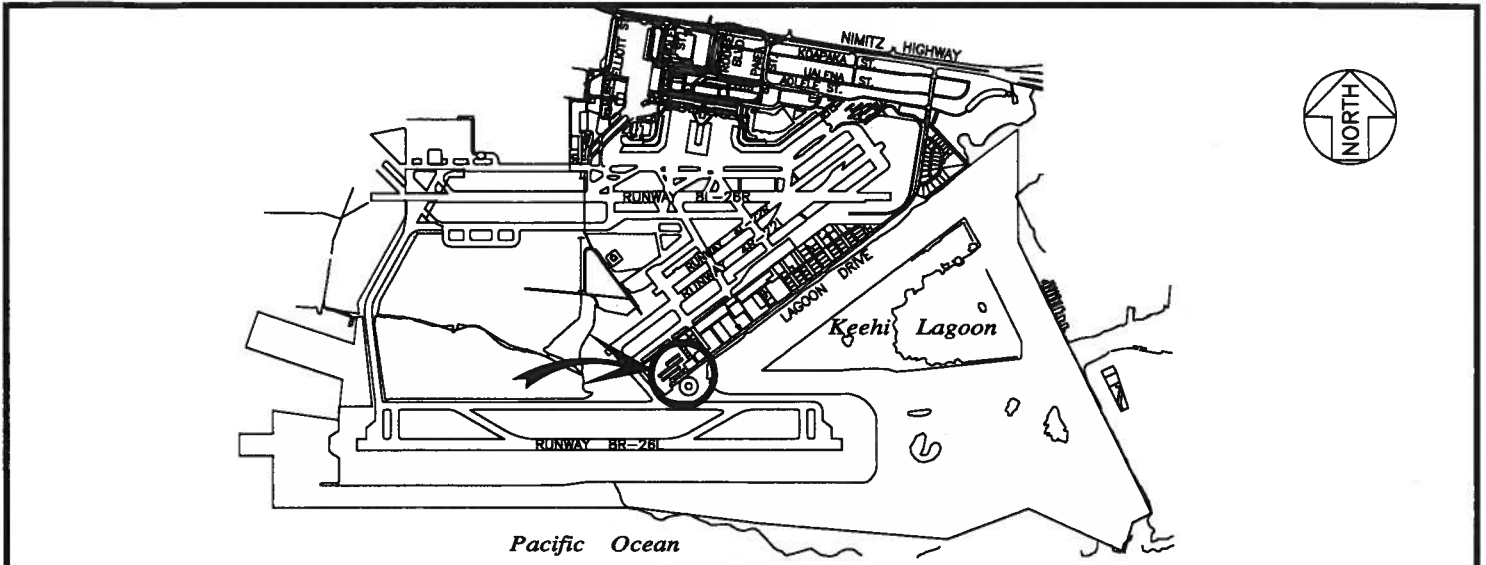

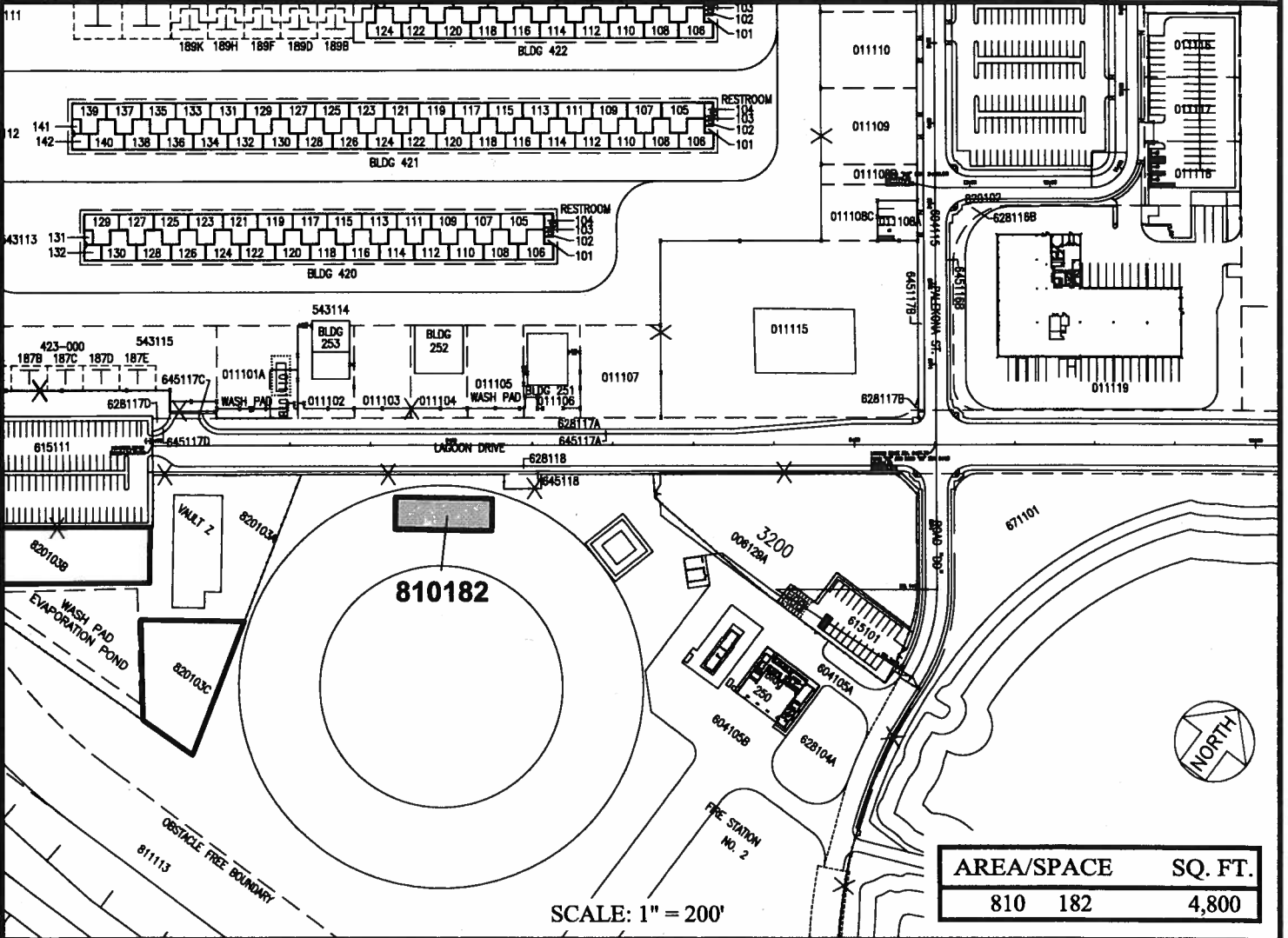

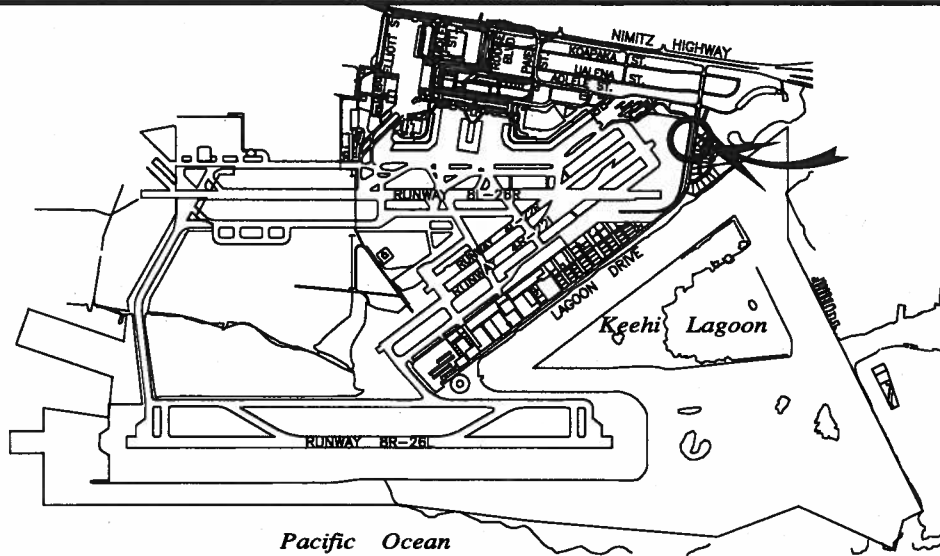

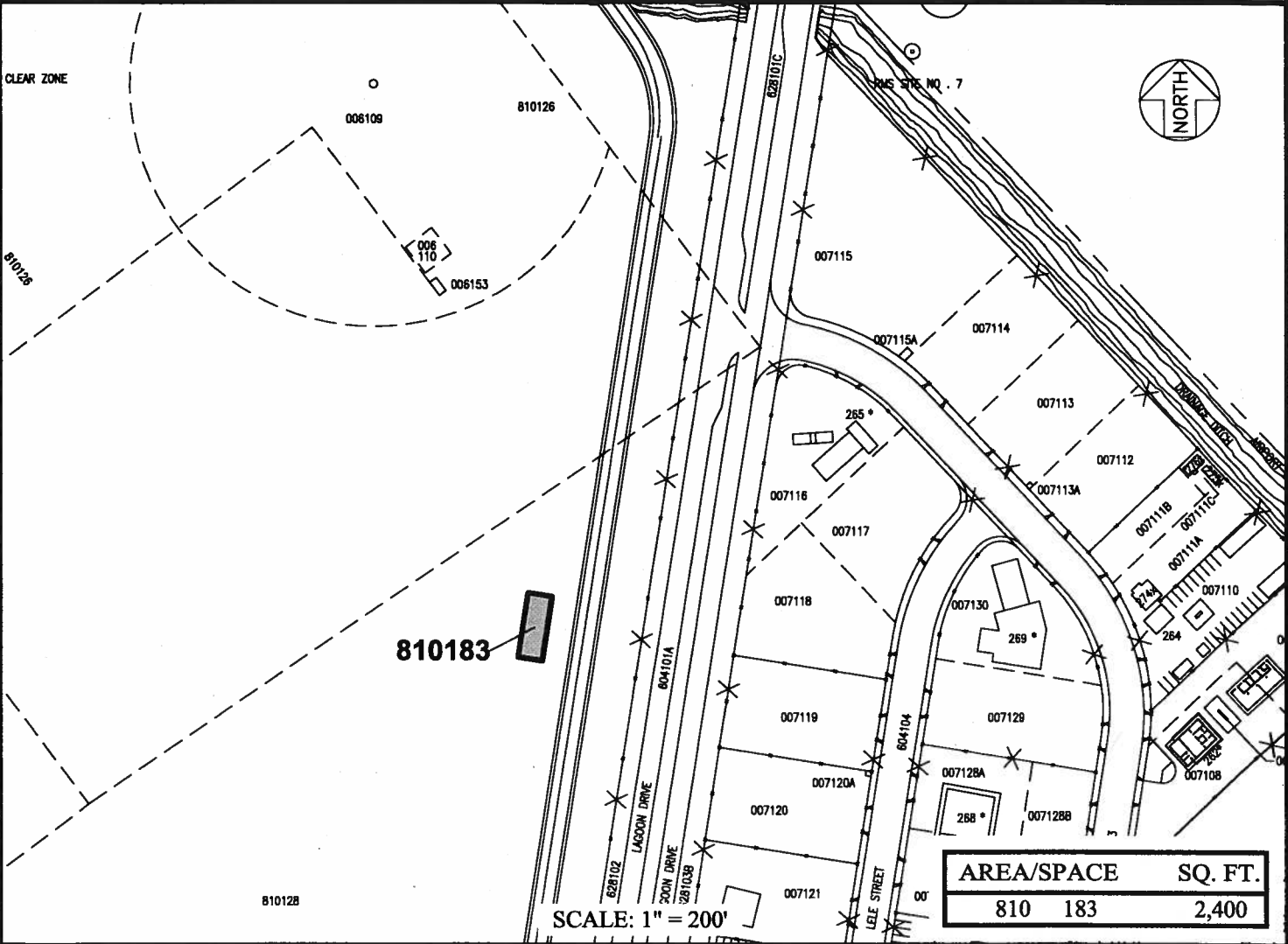
STAGING AREA 1

The Notice to Proceed date for the project was March 23, 2014 and the use of the space is requested until October 31, 2014.

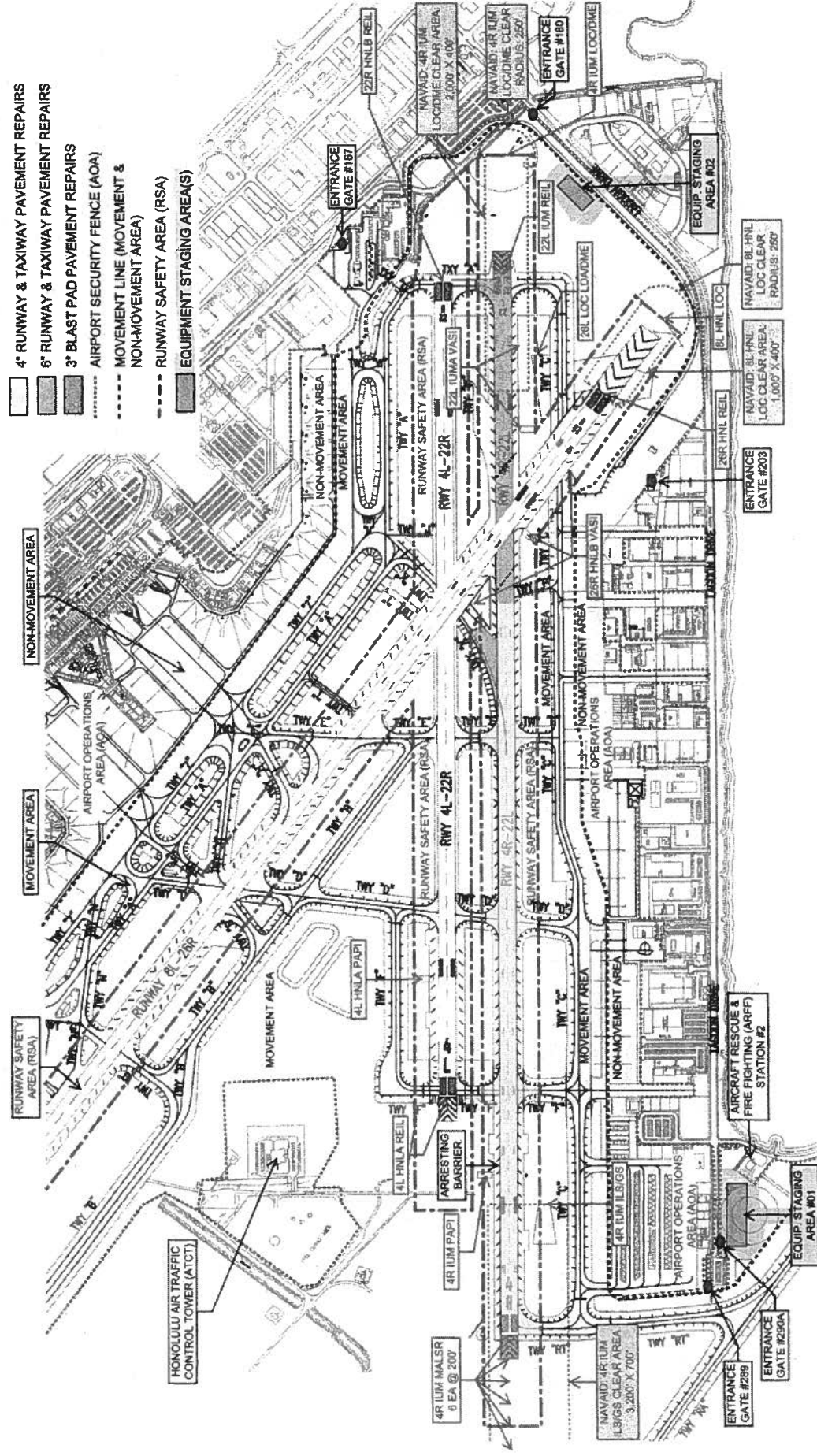
