Chrysalis Inc. dba Chrysalis Events Hawaii, a Domestic Profit Corporation.

Portion of Government lands at the beach area fronting the Kea Lani Resort at Honuaula, Wailea, Maui, identified as seaward of Tax Map Key: (2) 2-1-023: seaward of 003, as shown on the attached Exhibit A and overview photo attached as Exhibit B.

AREA:

4,800 square feet, more or less.

REMARKS:

Staff is requesting the approval for a right-of-entry permit to Chrysalis, Inc. dba Chrysalis Events Hawaii for a team building event (Beach Volleyball) scheduled for February 9, 2015, from 10:30am to 5:30pm. Set-up will be at 10:00am and break down / final clean up by 6:00pm. Staff brings this request to the Board pursuant to the policy adopted at its meeting of June 14, 2013, Item D-11, as amended.

The proposed activity is of a similar type and scope of beach activities that periodically occurred and continues to occur on this and other beach areas across the State. Such activities have resulted in no known significant impacts, whether immediate or cumulative, to the natural, environmental and/or cultural resources in the area. As such staff believes that

the proposed event/use would involve negligible or no expansion or change in use of the subject area beyond that previously existing.


Applicant has not had a lease, permit, easement or other disposition of State lands terminated within the past five years due to non-compliance with such terms and conditions.

RECOMMENDATION: That the Board



 - B. Such other terms and conditions as may be prescribed by the Chairperson to best serve the interests of the State.

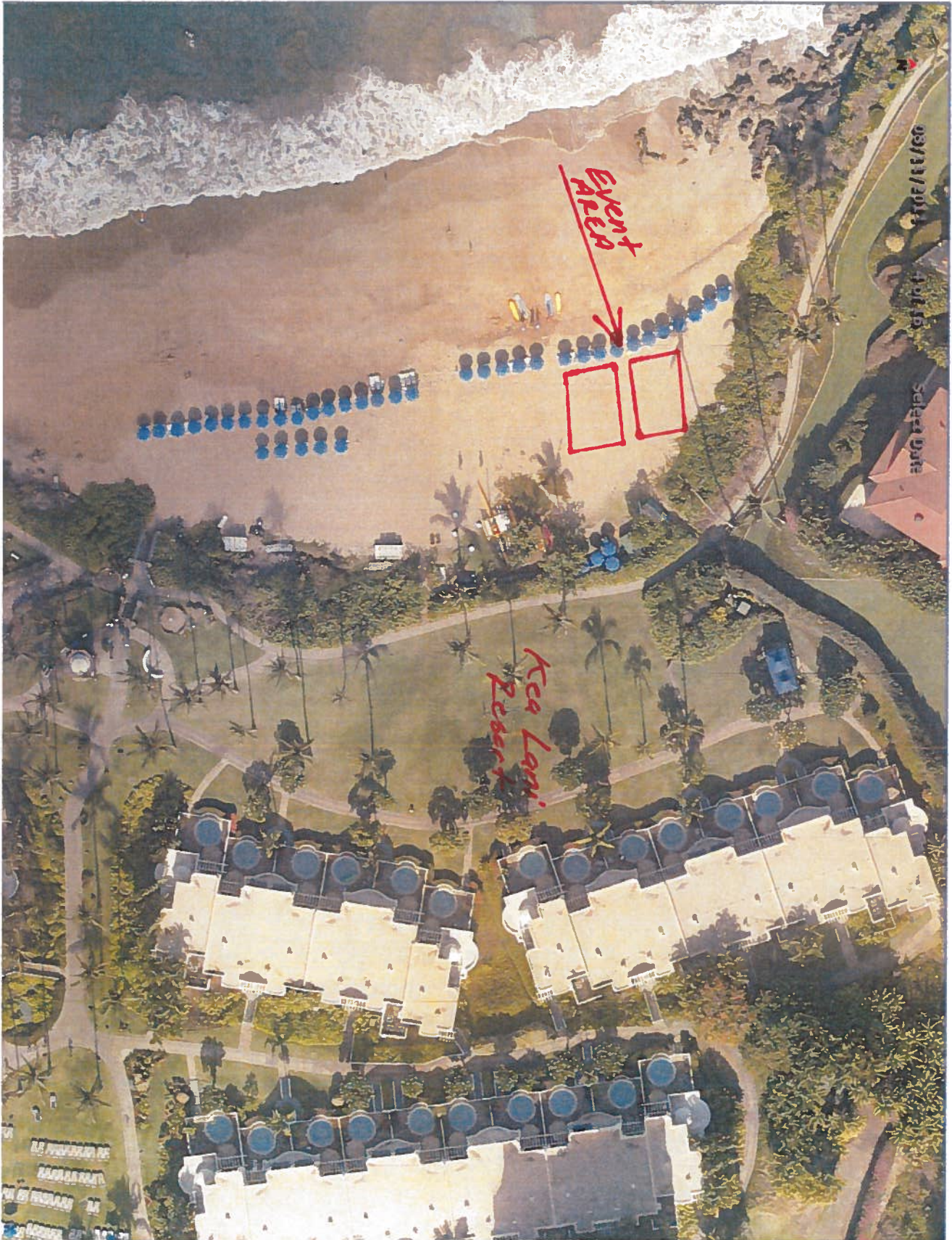
