## **REMARKS**:

Waikiki Beach Activities, Ltd is requesting a right-of-entry permit over a portion of the Duke Kahanamoku Lagoon as depicted on Exhibit A for beach activities purposes in connection with the team building activities for a group of about 250 guests staying at the adjoining hotel.

The request was originally scheduled to be considered by the Board on November 14, 2014. Due to lack of quorum, the item was deferred to today's agenda, which is after the event date on December 4, 2014. Pursuant to the authority delegated by the Board on June 14, 2013, Item D-11, as amended, Chairperson declared the request exempt from the preparation of an environmental assessment and issued a right-of-entry for the requested event. Staff brings the request to today's agenda asking for an after-the-fact

approval of the request. Staff does not recommend any late fee pursuant to the June 14, 2013 Board policy since the deferral is beyond the control of the applicant.

Applicant has not had a lease, permit, easement or other disposition of State lands terminated within the past five years due to non-compliance with such terms and conditions. No comments were solicited from government or community agencies.

There are no other pertinent issues or concerns, and staff does not have any objection to the request.


