The Board of Land and Natural Resources approved the award of the construction contract for the subject project on July 25, 2014. Pursuant to Chapter 343, Hawaii Revised Statutes (HRS), and Chapter 11-200, Hawaii Administrative Rules (HAR), the attached Exemption Notification labeled Exhibit A was prepared.


The project consists of the installation of rockfall impact fences, removal of boulders, stabilization of outcrops and miscellaneous related work.
