REMARKS:

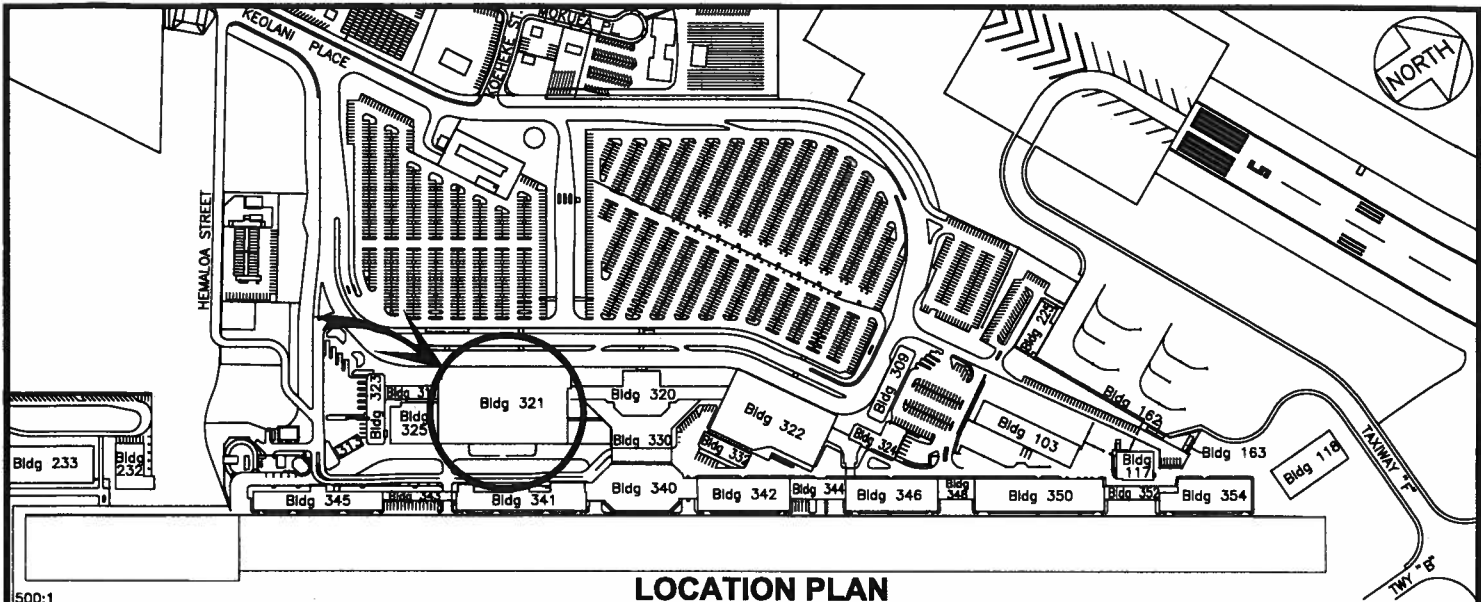

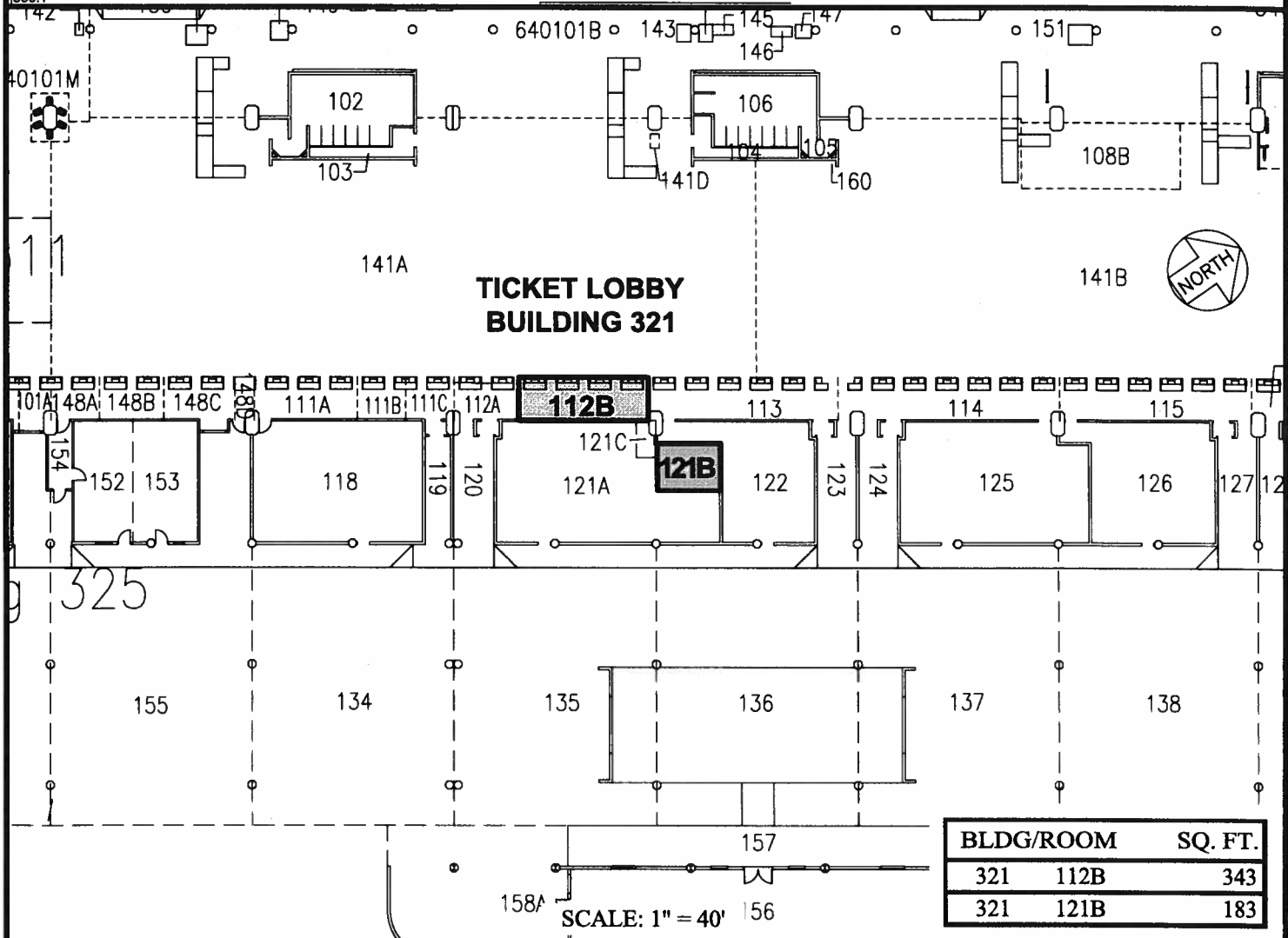
