CHAPTER 343, HRS – ENVIRONMENTAL ASSESSMENT:

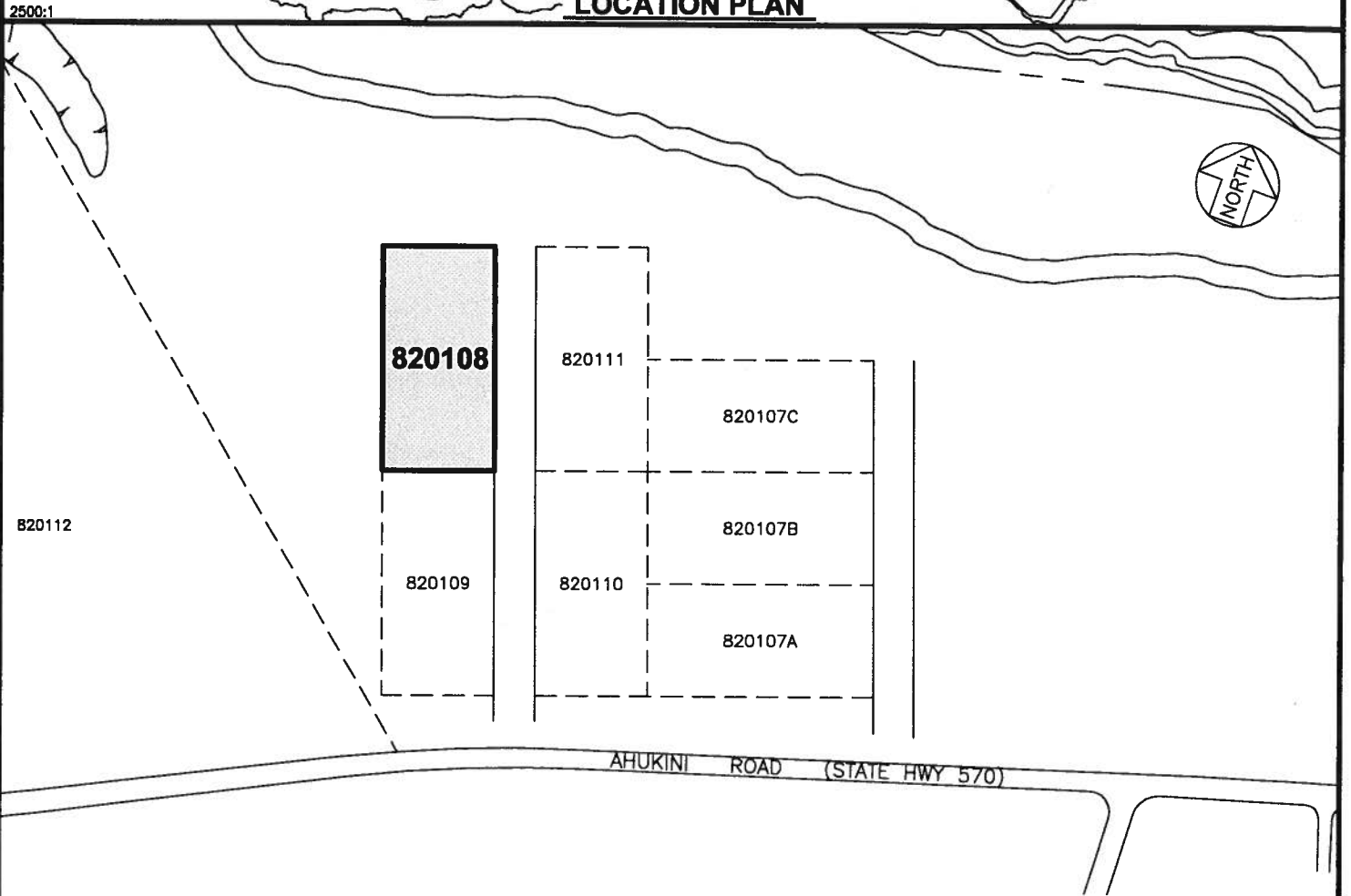
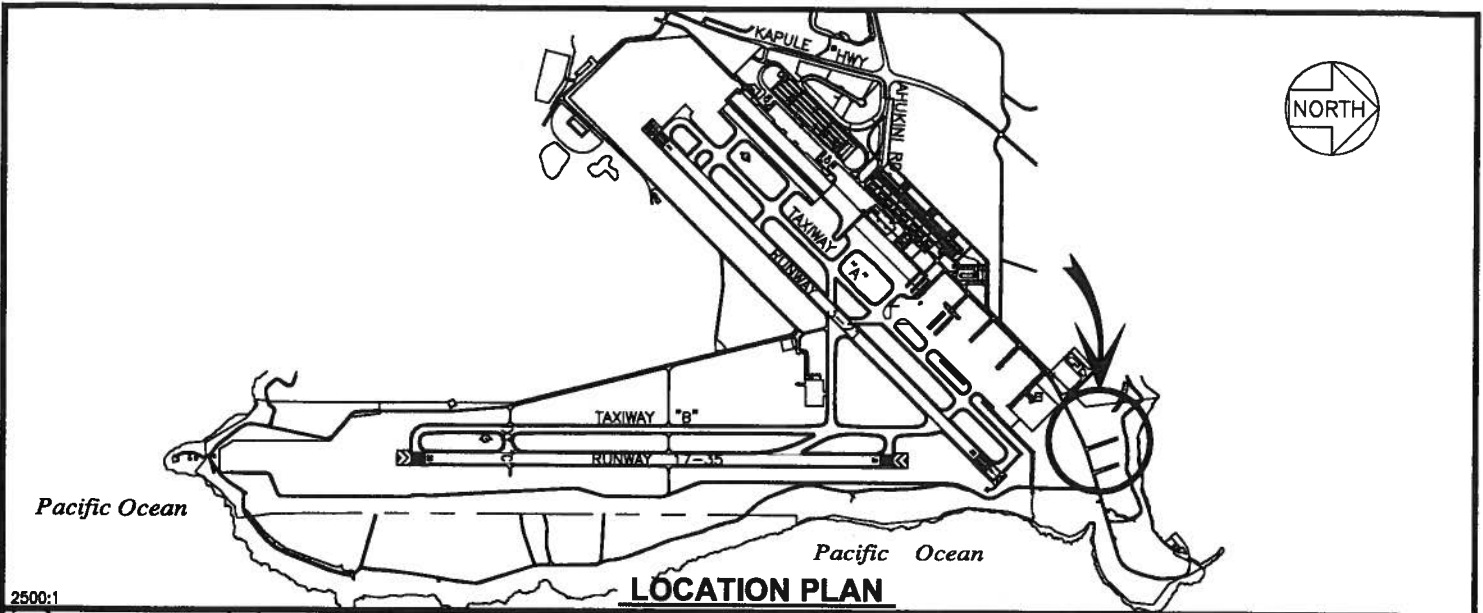
