Exemption Class #1 covers operations, repairs, or maintenance of existing structures, facilities, equipment, or topographical features involving negligible or no expansion or change of use beyond that previously existing.

REMARKS:

The DOT has no objections to HCM's request and therefore, in accordance with Sections 171-11 and 171-55, HRS, relating to <u>Public Purposes</u> and <u>Permits</u>, respectively and therefore, the DOT proposes to issue a month-to-month revocable permit to HCM, Area/Space No. 414-110 for a T-Hangar.

RECOMMENDATION:

That the Board authorize the Department of Transportation to issue a month-to-month parking permit to HCM, subject to: (1) terms and conditions herein outlined, which are by reference incorporated herein; and (2) such additional terms and conditions as may be prescribed by the Director of Transportation to best serve the interests of the State.
