RECOMMENDATION:



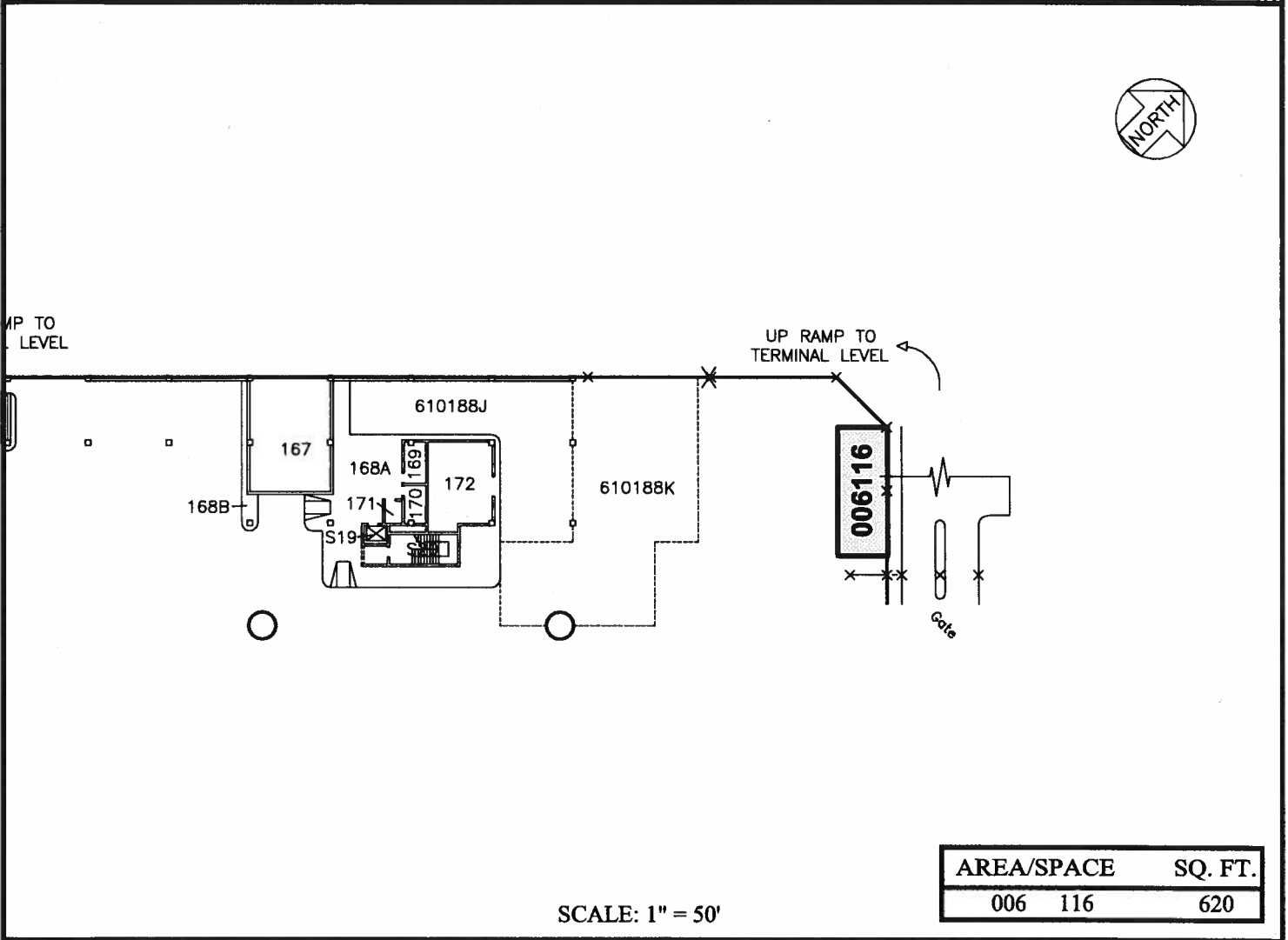
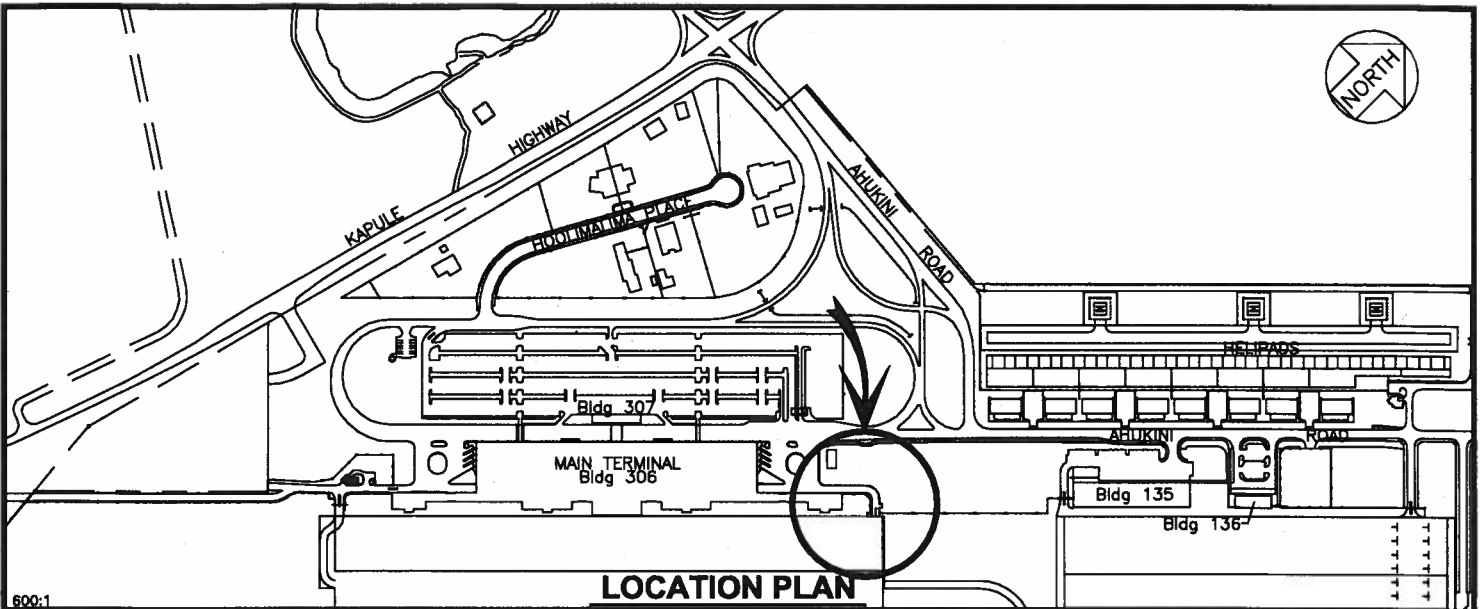
