CHAPTER 343, HRS - ENVIRONMENTAL ASSESSMENT:

The Department of Transportation (DOT) has no objections to MFS's request and therefore, in accordance with Sections 171-11 and 171-55, HRS, relating to <u>Public Purposes</u> and <u>Permits</u>, respectively and therefore, the DOT proposes to issue a month-to-month revocable permit to MFS for Bldg/Room Nos. 225-107D, -108D & -108G for ticket counters and baggage make up.
