REMARKS:

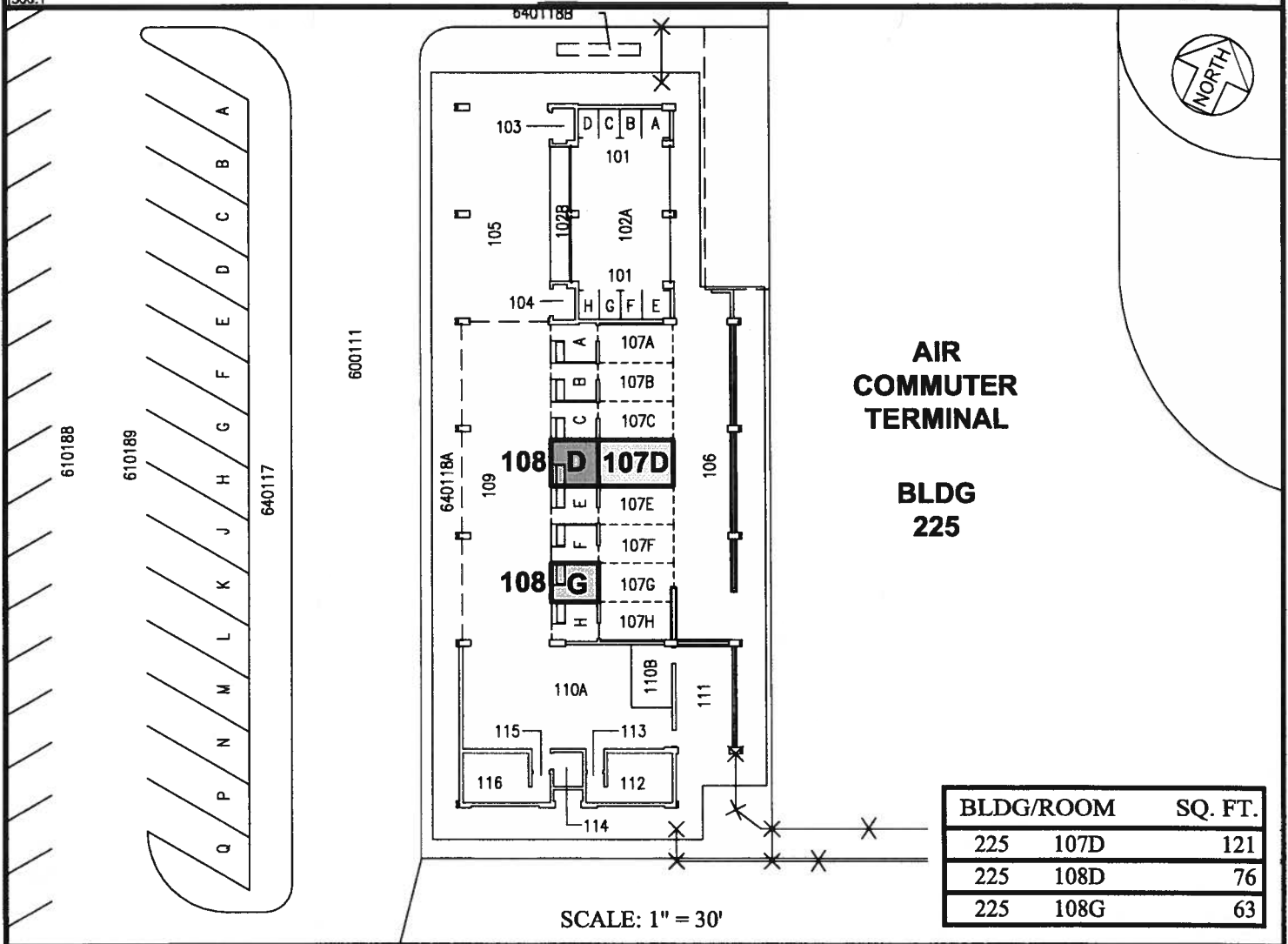
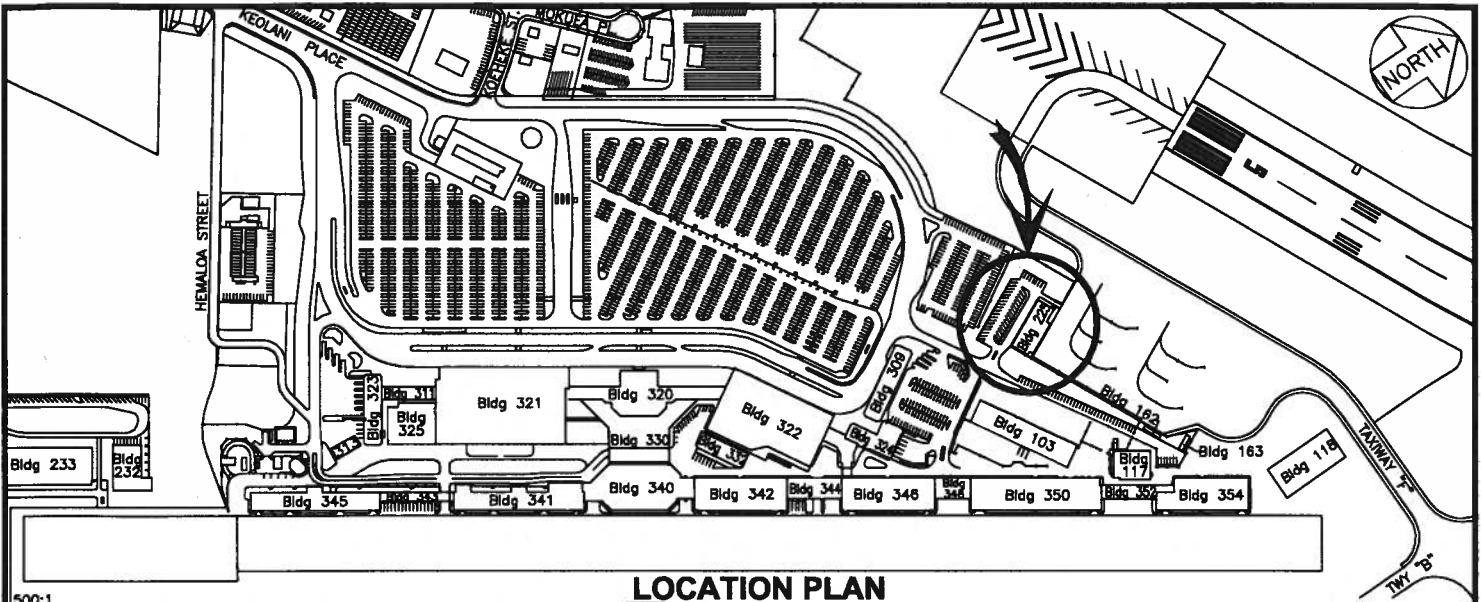
