HRS CHAPTER 343 – ENVIRONMENTAL ASSESSMENT:

In accordance with the Exemption List for the Department of Transportation (DOT), approved by the Environmental Quality Council on November 15, 2000, the subject action is exempt from the preparation of an environmental assessment pursuant to Exemption Class 1, "Operations, repairs, or maintenance of existing structures, facilities, equipment or topographical features, involving negligible or no expansion or change of use beyond that previously existing."

BACKGROUND:

This is the first request for renewal of revocable permits made by the DOT to the Board of Land and Natural Resources (Land Board) since the Board, at its August 27, 1993 meeting, delegated to the Director of Transportation, "the authority to issue revocable permits for uses that are consistent with the purpose and intent of the public lands set aside through Executive Orders pursuant to Chapter 171-11, HRS, as amended." A recent Attorney General opinion received by the DOT indicates the granting of such authority "was improper."

The Department of Transportation, Airports Division (DOTA), has reviewed its current list of revocable permits issued statewide and has determined which ones to recommend to the Board of Land and Natural Resources for renewal. Generally, those revocable permits in good standing will be recommended for renewal for the upcoming year.

REMARKS:

The list of revocable permits that the DOTA recommends be renewed for is attached as Exhibit 1. Included in the exhibit are the permittee names, tax map keys for each of the airports at which the permits are located, original commencement date of the permit, character of use, land area and annual rent.

RECOMMENDATION:


That the Board approves the continuation of the revocable permits listed in Exhibit 1 on a month-to-month basis through December 31, 2016.
