REMARKS:

Hawaii Explosives & Pyrotechnics, Inc. (HE), is requesting the issuance of a right-of-entry permit for the set-up and firing of fireworks display along the coastline fronting Lanikuhonua Beach for the Special Event Fireworks Display on June 2, 2016.

The set-up and firing of the aerial fireworks display for this event will include the staging area and the firing of the aerial fireworks display from a platform along the coastline fronting Lanikuhonua Beach consisting of 500 square feet from 12:00 p.m. to 10:00 p.m. on June 2, 2016 as shown on the attached map labeled Exhibit A-1 and A-2.

At its meeting on March 24, 2016, under agenda item D-4, HE provided testimony regarding the 30 day turn-around time for the \$2,500 clean-up deposit. HE raised the issue that multiple fireworks shows that may occur in close timeline to one another would have a detrimental effect on their cashflow, therefore, HE requested that a shorter turn-around period be granted. The Board agreed to the request and set the turn-around period to 7

calendar days, and that HE must turn in the proof of clean-up evidence (photos and certificates) to DLNR within 3 calendar days.

In addition, staff is recommending that a charge of \$500 be imposed to cover the exclusive use of the safety zone as shown on Exhibit A-2. The total cost for this right-of-entry, which includes the staging area of \$50 will be \$550.

Office of Conservation and Coastal Lands has no comments to the request.

Applicant has not had a lease, permit, easement or other disposition of State lands terminated within the past five years due to non-compliance with such terms and conditions. There are no pertinent issues or concerns. Staff does not have any objection to this request.

<u>**RECOMMENDATION**</u>: That the Board:

- 1. Declare that, after considering the potential effects of the proposed disposition as provided by Chapter 343, HRS, and Chapter 11-200, HAR, this project will probably have minimal or no significant effect on the environment and is therefore exempt from the preparation of an environmental assessment.
- 2. Authorize the issuance of a right-of-entry permit to Hawaii Explosives & Pyrotechnics, Inc. covering the subject area for aerial fireworks display purposes under the terms and conditions cited above, which are by this reference incorporated herein and further subject to the following:
 - A. The standard terms and conditions of the most current right-of-entry permit form, as may be amended from time to time;
 - B. Such other terms and conditions as may be prescribed by the Chairperson to best serve the interests of the State.
