## **REQUEST:**

Issuance of a revocable permit for ramp space to park ground service equipment for use in air cargo operations at Hilo International Airport.

#### **LEGAL REFERENCE:**

The FEA was prepared in support of: (1) Federal actions consisting of approval of the Airport Layout Plan in July, 2013, and (2) the State of Hawai'i actions consisting of environmental approval and construction of proposed

Hilo International Airport improvements. The FEA was prepared pursuant to Chapter 343, Hawai'i Revised Statutes and the Administrative Rules, Title 11, Chapter 200 of the State of Hawai'i, Department of Health.

## **REMARKS**:

The DOT has no objections to HA's request and therefore, in accordance with Sections 171-11 and 171-55, HRS, relating to <u>Public Purposes</u> and <u>Permits</u>, respectively, the DOT proposes to issue a revocable permit to HA.
