## **DLNR Kailua Bay Advisory Working Group Quarterly Report**

**HCR 191 HD1**

***December 1, 2025***

The Legislature of the State of Hawai'i, during its Regular Session of 2025, passed House Concurrent Resolution (HCR) 191 HD1 which specifically requested the Department of Land and Natural Resources (DLNR), Division of Boating and Ocean Recreation (DOBOR) to convene the Kailua Bay Advisory Working Group.

HCR 191 HD1 requested that the collaborative working group include a specific list of members. Letters were sent to the named working group members as listed in HCR 191 HD 1 in August of 2025, inviting them to participate in the working group and/or name a designee. By the mid-September 2025, all members/their designees were confirmed and their contact information received by DLNR's Outreach Coordinator.

Progress for the period of September 19, 2025 – November 05, 2025 is as follows with notes from Advisory Group meetings attached, which shows actual meeting attendance.

*(1) Provide a structured forum for state, county, and community stakeholders to collaborate on interjurisdictional issues affecting Kailua Pier*

Coordinated and conducted two meetings. The first meeting took place on October 21, 2025, via Zoom from 12:00-1:15p as a kickoff. The primary aim of the first meeting was to provide a high-level overview of HCR 191 HD1; an opportunity for Kailua Bay Advisory Working Group (KBAWG) members to introduce themselves to one another; and to schedule standing monthly meetings.

The second meeting took place in-person at the King Kamehameha Kona Beach Hotel on November 5, 2025, from 10:30a-12:30p. At the second meeting, the KBAWG members co-developed a draft twenty-five-year vision for Kailua-Kona Bay; a set of cultural values to guide discussions and decision-making; and to begin prioritizing key issue areas to tackle between November through March 2026.

*(2) Identify and implement solutions to enhance safety for pier users, including swimmers, boaters, and visitors*

KBAWG members completed a survey to prioritize and sequence the issues that are described in HCR 191 HD1. The survey question asked the following: *What priority areas do you aim to address within this Working Group?* Respondents had the option to select all issue areas including: tourism, slips, health of the bay; water-based events; events on the pier; trailer boats; cruise ships; homelessness, vandalism of public facilities; damage to restroom infrastructure; unauthorized encampments; ongoing safety and sanitation concerns for residents and visitors; fishing operations on the pier; and other.

Upon review of the survey results and further discussion, the KBAWG members determined to address homelessness first by focusing on recommendations to upgrade and renovate the restroom facilities and to improve sanitation for residents and visitors.

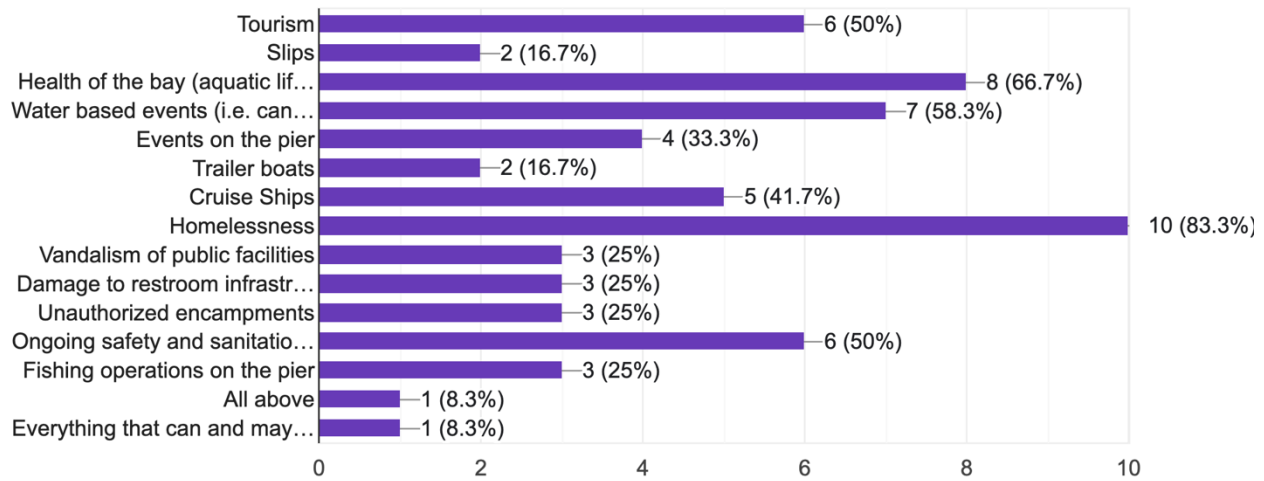

**1. Meeting Etiquette**

  - A Thriving and Protected Hub
    1. add “continued” to read: featuring continued restored, clean...
    2. add shade facilities, benches, educational signage (fish, rules, etc.)

      - a. with everyone following the rules / law

    - Mental Health Kōkua — outreach workers
- Health of the Bay
  - Ensure appropriate sunscreen use
  - Support more community clean ups — in and out of water
  - More events on the pier — so that the community can reclaim the space
    - The people in the space can then provide the education needed
    - Kupuna, community will safeguard and educate everyone
    - Importance of strong community presence
- What are we missing? OTHER POSSIBLE ISSUES:
  - Rampant fishing without proper regulation or education
