This constitutes the second monthly status report requested in your May 13, 2004, letter. With the exceptions noted below, our June 22, 2004, responses (copy attached for reference) to specific items remain the same.

 Receive public input and comment according to the work plan specified by the City Council and/or its Public Works Committee:

Our consultant is proceeding with supplemental studies necessary for the environmental impact statement for the next landfill site. A socio-economic sub-consultant will interview and relate the concems of 50 or more people representing a wide range of community interests. The attached Oahu Landfill EIS Socio-Economic Study document lists study questions.

 Understand and/or operationalize alternative technologies and methodologies for processing municipal solid waste;

On July 29, 2004, the City received no qualified proposals in response to our second Request for Proposals for a Municipal Solid Waste Recycling Facility to divert materials presently being landfilled. There were no qualified proposals to our first request for the same project in October 2003.

The City Council was invited to tour Waimanalo Gulch Sanitary Landfill on July 21, 2004, to augment their understanding of community concerns and landfill operations in order to provide them further basis for an informed decision on the next landfill site. In response to your letter dated May 13, 2004, we submit the following status report for June 2004.

Review and accept or reject all or portions of the Mayor's Advisory Committee Report MACR);

For City Council action.

Solicit and review for accuracy and acceptability financial cost estimates for securing, outfitting and operationalizing alternative MSW landfill sites based upon the receipt of letters from landowners and/or occupants of the alternative landfill sites and other research:

The City Council has asked for financial information of the current landowners of the four proposed sites. The Department has not received any information or any request to confirm any cost estimates from the City Council.

Receive public input and comment according to the work plan specified by the City Council and/or its Public Works Committee;

For City Council action.

Identify and include any additional MSW landfill sites (per City Council action) into the site review and selection process:

For City Council action.

Assemble any final report documenting the criteria and factors utilized by the City Council
in making its selection of an alternative MSW landfill site and specifying a project
development schedule (outlining the necessary steps to be taken to acquire, develop and
operate the proposed landfill site on or about June 2008 as per the LUC special permit);

Awaiting City Council action. The Department is willing to assist in preparation of any final report.

 Specify appropriate and necessary City and County of Honolulu FY 2005 (and beyond) budget items to fund the selection and/or establishment of a new MSW landfill site;

The FY05 Capital Budget provides \$301,000 for Planning (\$1,000) and Design (\$300,000) for a new MSW landfill site.

 Finalize the closure plan for the existing MSW landfill at Waimanalo Gulch (as per the LUC Special Permit;

The landfill operator has written a final closure plan for Waimanalo Gulch Sanitary Landfill, which meets the requirements of EPA Subtitle D. The specifics of the final closure plan will be submitted to the State Department of Health (DOH) one year before ceasing to accept refuse because the anticipated final grades will be better known and the year allows sufficient time for DOH review and approval.

 Understand and/or operationalize alternative technologies and methodologies for processing municipal solid waste;

The City has issued an amendment to its operating contract with the H-POWER facility operator to begin preliminary design of the third boiler.

The City has issued a Request for Proposals for a Municipal Solid Waste Recycling Facility to divert materials presently being landfilled. The date for submittal of proposals is July 29, 2004. Representatives of eight companies attended the mandatory presubmittal conference, held on April 26, 2004.

In the fall of 2004 the City plans to issue a Request for Proposals for a Municipal Solid Waste Mass Burn or Plasma Arc Waste Recovery System to address remaining combustible waste and future waste growth due to increase in population.

• Establish waste reduction and recycling programs designed to reduce (if not eliminate) the volume of municipal solid waste which is landfilled; and

In addition to the H-POWER third boiler and the MSW Recycling Facility, the City will process wastewater sludge into organic fertilizer pellets in its contract with Synagro, Inc., and initiate an island-wide residential curbside recycling collection and processing program.

 Secure if appropriate, any necessary amendment to the LUC Special Permit in effect for LUC Docket No. SP87-362 Department of Environmental Services, City and County of Honolulu (Fka Department of Public Works, City and County of Honolulu).

The Land Use Commission set a deadline for Waimanalo Gulch Sanitary Landfill to close on May 1, 2008. It also allowed the City Council to postpone its decision to select a landfill site by six months to December 1, 2004. The original schedule to have a new landfill site permitted and operational within five years was ambitious. Postponing the site selection by six months requires extending the deadline by six months since site selection was one of the first milestones in the original schedule. The requested and permitted landfill expansion area was based on a five-year capacity requirement. By postponing site selection, additional landfill capacity is needed to accommodate the waste generated during that additional period of time. The City has determined that in order to expand the landfill footprint, an environmental impact statement is necessary. Funds will be available on July 1, 2004, the start of the fiscal year, to begin selection of a consulting firm to provide the environmental impact statement and obtain the necessary permits for the expanded landfill footprint at Waimanalo Gulch.

We have instructed our consultant, contracted to provide support of the Mayor's Landfill Selection Advisory Committee and to provide the environmental documents for the new landfill site, to initiate site investigations for the four candidate landfill sites and to investigate filing a generic environmental impact statement to hasten the process.

OAHU LANDFILL EIS - SOCIO-ECONOMIC STUDY

An Environmental Impact Statement is being prepared for the City and County of Honolulu, to assess the four potential sites for a sanitary landfill selected by a Blue Ribbon Committee last year. The current Waimanalo Gulch landfill is scheduled to close in 2008. All four sites under consideration are privately owned. The EIS will also consider a "No Action" alternative. If no action is taken to replace Waimanalo Gulch as a site for municipal solid waste, the City and County may need to consider exporting solid waste elsewhere.

The State Land Use Commission has directed the City Council to identify a site by December 2004. Information gathered from this and other studies for the EIS will be available to the City Council and administration. Neither the City Council nor the administration has picked a preferred site as yet.

The four potential sites are:

Maili. The site is owned by Sphere LLC. The owner is pursuing plans to dedicate the site to use as a Construction and Demolition landfill. It can be reached via Paakea Road. Its landfill life has been estimated as 15.3 years.

Nanakuli "B" The site is owned by Shige International Inc. It can be reached by Lualualei Naval Road. Its landfill life has been estimated as 15.6 years.

Makaiwa Gulch. The site is owned by the Estate of James Campbell. It can be reached by Farrington Highway. Its landfill life has been estimated as 25 years.

Ameron Quarry at Kapaa. The site is owned largely by Kaneohe Ranch. It is currently used as a bluestone quarry. It can be reached via H-3 or Kapaa Quarry Road. Its landfill life has been estimated as 15 years.

The City considers that it needs a continuing sanitary landfill site for municipal waste - (a) to deal with wastes not appropriate for recycling, at H-POWER plant, or by alternative technologies that are now being explored; and (b) to be ready to respond to natural disasters. In any event, the current City administration supports recycling and other approaches to reduce the amount of municipal waste to be landfilled.


SMS Research is conducting a socio-economic impact assessment of a new landfill. As part of that work, we are talking to many different stakeholders to make sure we learn about community views, concerns, and ideas about ways to reach a solution to municipal waste disposal issues. Questions of particular interest to SMS include:

- How does the current municipal waste disposal system affect the community?
- What would be the impact of a sanitary landfill at any of these sites?
- > What communities are potentially affected if a sanitary landfill were located at any of these sites?

- > Can a landfill for municipal solid waste be operated in a way that would minimize problems for the community?
- > A sanitary landfill serves the whole island. What steps are appropriate and fair to address the concerns of communities near a landfill site?
- > What would be the impact of shipping municipal waste off-island?

Our interview results will be reported in a public document. We list the people who contribute their views, and we describe community concerns, but individual respondents' opinions are kept confidential.
