

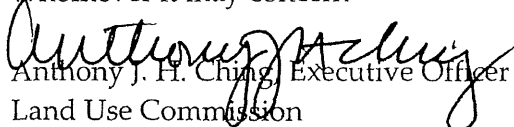

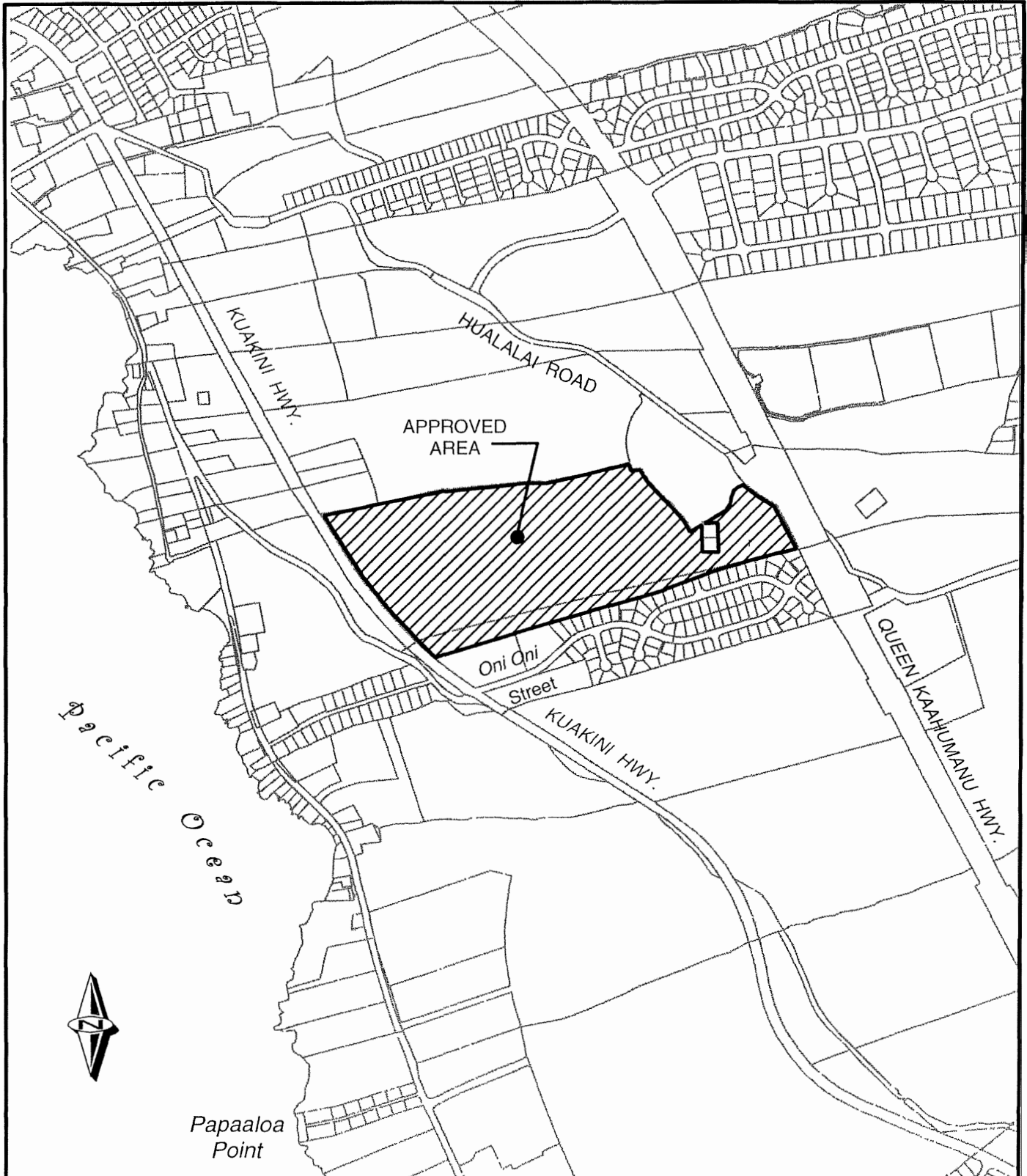

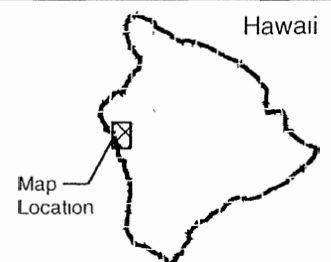


A02-737 UNIVERSITY OF NATIONS BENCORP

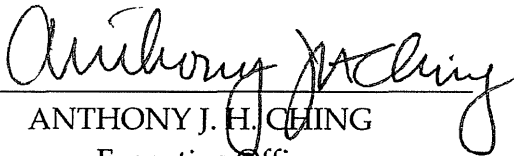
