### ORDER TO SHOW CAUSE

TO: U OF N BENCORP ("Petitioner"),

YOU ARE HEREBY COMMANDED, under the authority of section 205-4, Hawai'i Revised Statutes ("HRS"), and section 15-15-93, Hawai'i Administrative Rules ("HAR"), to appear before the Land Use Commission, State of Hawai'i ("Commission"), at the Natural Energy Laboratory of Hawai'i (NELHA) – Hale Iako Training Room #119, on May 22, 2019, at 9:30 a.m., to show cause as to why that certain land at Wai'aha 1st, North Kona, County and State of Hawai'i, Tax Map Key No. (3) 7-5-010:85 and 7-5-017:006 covering approximately 62 acres of land referred to as the Subject Area, and approximately identified on Exhibit "A", attached hereto and incorporated herein, should not revert to its former land use classification or be changed to a more appropriate classification.

The Commission has reason to believe that you have failed to perform according to the conditions imposed and to the representations and commitments made to the Commission in obtaining reclassification of the Subject Area. The conditions of the Decision and Order which may have been violated or not been met include, but may not be limited to the following:

- 1. Condition 1 Affordable Housing;
- 2. Condition 2 Drainage Improvements;
- 3. Condition 3 Public School Facilities.;
- 4. Condition 4 Water Resources:
- 5. Condition 5 Wastewater Facilities;
- 6. Condition 6 Archaeology
- 7. Condition 7 Cultural, Historical, Customary and traditional Rights and Resources;
- 8. Condition 8 Soil Erosion and Dust Control
- 9. Condition 9 Transportation
- 10. Condition 10 Traffic
- 11. Condition 11 Cultural Center
- 12. Condition 12 Ka Haka 'Ula O Ke'elikolani College of Hawaiian Language at University of Hawaii-Hilo
- 13. Condition 13 Civil Defense
- 14. Condition 14 Solid Waste;
- 15 Condition 15 Compliance with Representation to the Commission;
- 16 Condition 16 Notice of Change in Ownership;
- 17. Condition 17 Annual Reports;
- 18 Condition 18 Release of the Conditions Imposed by the Commission

Section 205-4, HRS, authorizes the Commission to impose conditions necessary to "assure substantial compliance with representations made by the petitioner in seeking a boundary change" and that "absent substantial commencement of use of the land in accordance with such representations, the [C]omission shall issue and serve upon the party bound by the condition an order to show cause why the property should not be revert to its former land use classification or be changed to a more appropriate classification."

Accordingly, the Commission will conduct a hearing on this matter in accordance with the requirements of Chapter 91, HRS, and subchapters 7 and 9 of chapter 15-15, HAR. All parties in this docket shall present testimony and exhibits to the Commission as to whether Petitioner has failed to perform according to representations made in seeking the land use reclassification.

Any party may retain counsel if the party so desires.
