Dear Director Evans and Executive Officer Orodenker:

On behalf of the Applicant, the University of the Nations, Kona, Inc., G70 is submitting the Second Final Environmental Impact Statement (EIS) for the University of the Nations, Kona, Inc. Master Plan Update (the project) located in Kailua-Kona to the State Office of Planning and Sustainable Development, Environmental Review Program for publication in the November 23, 2025, edition of The Environmental Notice (TEN). In accordance with Hawai'i Administrative Rules (HAR) §11-200.1-5(e)(6)(C), the Second Final EIS has been simultaneously filed with the Land Use Commission, the accepting authority, for acceptance pursuant to HAR §11-200.1-28.

A Final EIS for the project was published in the June 23, 2025, edition of TEN, but was withdrawn on July 23, 2025, due to an inadvertent omission of a comment letter received during the public scoping comment period. The omitted comment letter is reproduced in Vol I. Section 8.2, and Volume II. Appendix N of the Second Final EIS. Additionally, the Commission of Water Resource Management approved the preparation of a First-Generation Keauhou Aquifer System Area Groundwater Adaptive Management Plan in July 2025. Relevant information for the Groundwater Adaptive Management Plan has been integrated throughout the Second Final EIS. Minor revisions were made to address flora and fauna resources in Vol I, Section 4.16 and 4.17. No substantive changes to the project and Final EIS analysis were made.
