King Kalakaua was of this land, Governor Kuakini built the

Great Wall what is now considered to be a monument. Site 6302.

It was destroyed during the last 5 yrs or so witnessed by the locals.

This should be restored and put back to original not left destroyed.

The trails should be preserved; this is the cultural of the Hawaiian people.

Site 23681 (ceremonial - ag heiau) sugar plantation workers came to this area.

Site 23683, 23684/ 23685 Burials.

There should be many more, tradition is they hid the IWI buried secretly. This is concerning of a well-established site. Petitioner committed to Preserve with Papamu or rough square game board identified as site 23682.

On May 7, 2003, DLNR-SHPD AIS recommended 5 sites for preservation and 10 sites for Data Recovery. Meaning these 10 sites will likely be destroyed.



Preserving a rough board game vs. ancient Hawaii known trails Mauka Makai not recommended should be taken up and brough to the attention of the Hawaiian Natives as well as the Cultural Resources Commissioners.
