

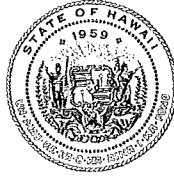

ORDER GRANTING MOTION TO CONSOLIDATE HEARING

On June 19, 2013, Maui R&T Partners, LLC ("Maui R&T"), successor-in-interest to original Petitioner Maui Economic Development Board, Inc., filed a Motion to Consolidate Hearing, pursuant to sections 15-15-54 and 15-15-70, Hawai'i Administrative Rules ("HAR").

Maui R&T seeks to consolidate the hearings before the State of Hawai'i Land Use Commission ("Commission") on its Motion for Order Amending the Amended Findings of Fact, Conclusions of Law, and Decision and Order filed February 25, 1986, in the above-entitled docket and its Petition for District Boundary Amendment filed June 23, 2010, in Docket No. A10-787 to promote efficiency and judicial economy

as it relates to the evidentiary record for the Maui Research & Technology Park Master Plan Update.

On June 28, 2013, the County of Maui Department of Planning ("DP") filed a Statement of No Opposition to Motion to Consolidate Hearing filed June 19, 2013.

On July 1, 2013, OP filed a Statement of No Objections to (1) Petitioner's Motion for Order Amending the Amended Findings of Fact, Conclusions of Law and Decision and Order filed February 25, 1986, and (2) Petitioner's Motion to Consolidate Hearing.

The Commission considered Maui R&T's Motion to Consolidate Hearing at its meeting on July 25, 2013, at Kīhei, Maui, Hawai'i. Curtis T. Tabata, Esq., and Steve Perkins appeared on behalf of Maui R&T. James Giroux, Esq., and William Spence appeared on behalf of the DP. Bryan C. Yee, Esq., and Rodney Funakoshi appeared on behalf of the State of Hawai'i Office of Planning ("OP").¹

At the meeting, Maui R&T provided a background of the docket and the basis for the Motion to Consolidate Hearing. The DP and OP stated that they had no objections to the Maui R&T's Motion to Consolidate Hearing.

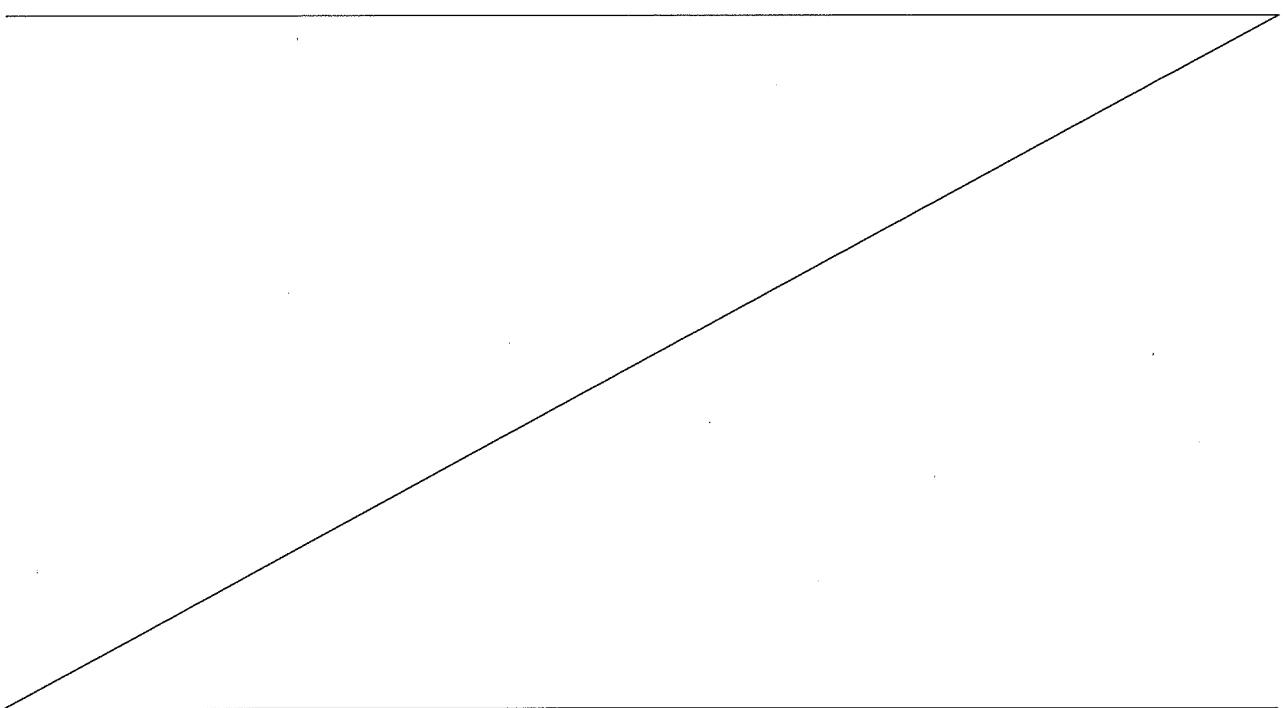
¹ At the beginning of the meeting, Chair Ronald Heller disclosed that he represented several clients on Maui in which the County of Maui was an adverse party. There were no objections by the parties to Chair Heller's continued participation in this proceeding.

Thereafter, a motion was made and seconded to grant Maui R&T's Motion to Consolidate Hearing. Following discussion by the commissioners, a vote was taken on this motion. There being a vote tally of 7 ayes, 0 nays, and 2 excused, the motion carried.

ORDER

Having duly considered Maui R&T's Motion to Consolidate Hearing and the oral and written arguments of the parties in the proceeding at this Commission's meeting on July 25, 2013, in Kīhei, Maui, Hawai'i, and the motion having received the affirmative votes required by section 15-15-13, HAR, and there being good cause,

IT IS HEREBY ORDERED that Maui R&T's Motion to Consolidate Hearing be GRANTED.


