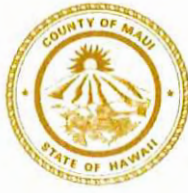

The Department would like to see in future compliance reports a list of construction activities done to date, a list of potential projects for the Park, and updates on the general activity and strategic plan for the Park. The Department looks forward to updates made between the Petitioner and the Hawaii Department of Transportation on a Memorandum of Agreement and notes coordination with HDOT regarding the update to the TIAR.
