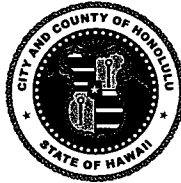

**SUBJECT:** Request for Extension of Time to Respond to Haseko Royal Kunia, LLC's 2025 Motion for Order Amending the Memorandum of Understanding's Offsite Infrastructure Date in Condition A.1 filed on December 26, 2025 with the State of Hawai'i Land Use Commission

Pursuant to Hawai'i Administrative Rules (HAR), § 15-15-42(a)(1), the Department of Planning and Permitting, City and County of Honolulu ("DPP"), respectfully requests an extension for the DPP to file its response to Haseko Royal Kunia, LLC's ("Petitioner") Motion for Order filed on December 26, 2025 ("Motion") with the State Land Use Commission ("LUC"), for Docket No. A92-683. The Petitioner is seeking an order amending the Memorandum of Understanding's Offsite Infrastructure date in Condition A.1 found in the LUC's October 7, 2024 Findings of Fact, Conclusions of Law, and Decision and Order granting the Motion to Amend the Memorandum of Understanding's offsite infrastructure date to be consistent with the Sixth Amendment to Amendment and Restatement of Memorandum of Understanding dated December 17, 2025.

Pursuant to HAR, § 15-15-70(f), the DPP is required to notify the LUC and Petitioner of its position within seven days after being served. The DPP respectfully requests that the deadline to respond to Petitioner's Motion be extended to February 27, 2026.

The request for extension is to allow time for the DPP to consult with appropriate agencies on areas of concern that may be affected by the proposed Petition.
